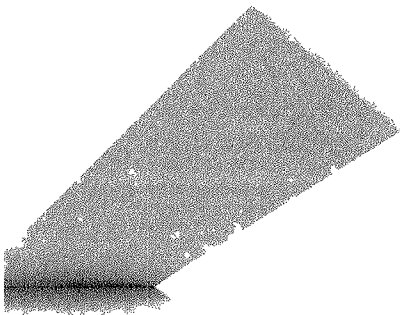

Notes to Financial Statements

Note 1: Description of Plan

The following description of the SCIO Health Analytics 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of SCIO Health Analytics who have one month of service and are age 18 or older. Leased employees, employees covered by a collective bargaining agreement, and nonresident aliens who receive no compensation from the Company or related employers are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

Eligible employees include all regular full-time employees of the Plan, who are not covered under a collective bargaining agreement. Employees are eligible to participate in the Plan after one month of service. In order to receive Company discretionary matching and non-elective contributions, employees must be employed as of the last day of the plan year.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, on a pretax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, in accordance with Internal Revenue Code Regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. The Participants are responsible for directing the allocation of their contributions among the established funds.

For the year ended December 31, 2024, the Company made a discretionary matching contribution of 50% on the first 6% of the participants' elective deferrals, totaling \$416,506. In addition, the Company may make a discretionary non-elective contribution as determined by the Board of Directors each plan year, which is allocated to participant's based on each participant's annual eligible compensation as a percentage of total annual eligible compensation. No discretionary non-elective contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching and non-elective contributions (if any), and an allocation of investment earnings/losses and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary employer contributions plus actual earnings thereon is based on years of continuous service. Participants vest on a three-year cliff schedule and are fully vested after three years of service.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a variety of mutual funds and common collective trusts as investment options for participants. Investment options can be changed daily.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms may not exceed five years, unless the note is for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at prime rate, with rates ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various installment methods. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$60,985 and \$68,483, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, forfeited funds of \$14,020 were used to pay administrative expenses. No amounts were used to reduce Company contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net realized gains and losses and unrealized appreciation or depreciation in fair value of investments is reported in the statement of changes in net assets available for benefits as net appreciation/depreciation in the fair value of investments. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the borrowing participant's account, as incurred, and are included in administrative expenses. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees incurred by the Plan for investment-related services are allocated proportionately to plan participants based on their respective account balances and are included in net investment income, as they are paid through revenue sharing rather than direct payment. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Notes to Financial Statements

Note 3: Fair Value Measurements (Continued)

Collective investment trust fund and Common collective trust funds: Valued at the NAV of units of the collective trust. The NAVs, as provided by the trustee, are used as a practical expedient to estimate fair value. The NAVs are based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no restrictions as to the redemption of these funds or unfunded commitments at December 31, 2024 and 2023. Were the Plan to initiate full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the Trustee of the Plan.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Plan contributions.

Note 6: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020 which states the non-standardized pre-approved plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity, the Plan's Trustee, and therefore these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Direct fees incurred and paid by the Plan for administrative expenses amounted to \$7,973 during the plan year ended December 31, 2024.

The Plan also participates in a revenue credit program with the Trustee, whereby participants may receive credit for excess recordkeeping revenue that the Trustee receives in connection with plan services when that revenue exceeds the agreed-upon compensation the Trustee is to receive. These revenue credits are allocated to eligible participants based on their respective account balances and are reflected in net investment income. Revenue credits received from Fidelity amounted to \$21,607 for the year ended December 31, 2024.

Wipfli, LLP ("Wipfli") provides audit services to the Plan, which qualify as party-in-interest transactions. Fees paid directly to Wipfli for audit services amounted to \$13,950 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
