## Report of Independent Auditors

### **1. Description of Plan**

The following description of Protective Industries Savings & Retirement Plan (the Plan) provides only general information. The Plan sponsor is Protective Industries, Inc. (the Company). Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Company.

#### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors. Empower Trust Company, LLC and Empower Retirement, LLC are the trustee and recordkeeper, respectively, for the Plan.

#### **Eligibility**

Eligible employees can become participants in the Plan after they have attained age 18 and completed 60 days of service.

The Plan includes an auto-enrollment provision whereby all new employees, upon meeting the eligibility criteria, are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation unless they affirmatively elect not to participate in the Plan. Eligible employees are given a 30-day period to indicate their election to defer a different percentage or to waive participation in the Plan. In addition, there is an auto increase of the deferral rate on the first day of the Plan year by 1% up to a maximum of 6% of compensation.

#### **Contributions**

Participants may contribute a combination of pretax and after-tax (Roth) contributions up to 100% of annual compensation, as defined by the Plan and subject to Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

## Notes to the Financial Statements (continued)

### **1. Description of Plan (continued)**

The Company makes a safe harbor matching contribution for each Plan year equal to 100% of each participant's elective deferrals for the first 3% of the participant's compensation, plus 50% of each participant's elective deferrals from 4% up to 5% of the participant's compensation.

Additional Company nonelective (profit-sharing) amounts may be contributed at the discretion of the Company's Board of Directors. Employees who are employed on the last day of the Plan year and have 1,000 hours of service are eligible for the profit-sharing contribution. In addition, employees who incurred a severance of employment or due to death, disability, normal retirement age or early retirement age during the year are also eligible for the profit-sharing contribution. For the year ended December 31, 2024, the Company did not make any profit-sharing contribution.

All contributions are subject to certain Internal Revenue Code (the Code) limitations.

Participants direct their elective and Company contributions into various investment options offered by the Plan and can change their investment options on a daily basis. If participants are automatically enrolled, their contributions are invested in the Putnam Stable Value Fund until they change their fund election.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company contributions and allocations of Plan earnings and are charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Description of Plan (continued)

#### Vesting

All participants are immediately 100% vested in employee contributions and employer matching contributions, plus actual earnings thereon. Profit sharing contributions are subject to the following vesting schedule:

#### Notes Receivable from Participants

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the participant's highest outstanding note receivable amount during the prior 12 months or 50% of their vested account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear interest at prevailing commercial rates as determined by the plan Administrator. Principal and interest are paid ratably through payroll deductions.

#### Withdrawals and Distributions

Participants may withdraw all or a portion of their vested account balance at any time upon or after the attainment of age 59½. In general, unless the participant elects otherwise, distribution of benefit will commence within 60 days after the latest of the close of the Plan year in which (a) the participant attains the retirement age of 65, (b) the participant terminates employment with the Company, or (c) the participant attains early retirement at age 55 and has 5 years of service. Upon termination, if a participant's vested account balance is \$1,000 or less, the participant will automatically receive a lump sum distribution as soon as administratively feasible.

### **1. Description of Plan (continued)**

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan.

#### **Forfeitures and Revenue Credit Program**

Upon termination of employment, participants forfeit their non-vested balances. Forfeitures are used to pay Plan expenses or reduce Company matching contributions or profit-sharing amounts. The Plan provides for a revenue credit program in connection with revenue sharing with certain investment managers. The revenue amounts may be used to pay Plan expenses. Forfeitures including revenue amounts amounted to approximately \$72,000 and \$109,000 as of December 31, 2024 and 2023, respectively, and forfeitures used to reduce Company matching contributions for 2024, were approximately \$90,000.

#### **Administrative Expenses**

All expenses of maintaining the Plan are paid by the Company or by the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States (U.S. GAAP) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### **3. Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC.

#### 4. Fair Value Measurements

Fair value is defined under Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
  - quoted prices for similar assets or liabilities in active markets
  - quoted prices for identical or similar assets or liabilities in markets that are not active
  - observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals);
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – Unobservable inputs for the asset or liability i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

##### *Registered Investment Companies*

Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end.

Valued at the published NAV of shares held by the Plan at year-end. Participant transactions (purchases and sales) may occur daily without restrictions.

#### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

### **6. Tax Status**

The underlying pre-approved plan has received an opinion letter from the IRS dated November 14, 2022, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Party-in-Interest Transactions**

The Plan invests in shares of a registered investment company managed by Putnam Investments (Putnam) an affiliate of Empower Trust Company (LLC) (Trustee). Putnam is a majority owned subsidiary of the Trustee. The Plan also holds units of common collective trusts managed by Putnam. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

### **8. Subsequent Events**

Management evaluated subsequent events for the Plan through September 3, 2025, the date the financial statements were available to be issued. Based on this evaluation, no additional disclosures or adjustments were required to be made to the financial statements as of December 31, 2024.
