We have performed audits of the accompanying financial statements of Wheeler Clinic, Inc. 403(b) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Wheeler Clinic, Inc. 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan which provides for the payment of benefits upon retirement, death, or total disability to certain eligible employees of Wheeler Clinic, Inc. (the “Company” or “Employer”) or their beneficiaries. All employees are eligible to make elective deferrals into the Plan. Eligible employees who have completed 12 months of service and have attained age 21 are eligible for Company contributions. Employees are eligible to receive Company contributions at the beginning of the following month after they have satisfied the eligibility requirements. Payments to the Plan are made by a salary reduction arrangement under Internal Revenue Code (“IRC”) Section 403(b). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Participant Contributions

Participants may make pretax contributions of their earnings as elective contributions up to the limit prescribed by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants that are age 50 or older may elect to defer additional amounts (age-50 catch-up contributions) to the Plan. However, a participant’s total deferral in any taxable year may not exceed a dollar limit which is set by law. Participants can change their contribution percentage or amount at any time and those changes will be effective as soon as administratively feasible. Eligible employees are automatically enrolled to contribute 2% of compensation unless the employee affirmatively directs that no contributions be made or elects a contribution amount other than 2%.

Employer Contributions

For each Plan year, the Company may contribute to the Plan, on behalf of each eligible participant, a contribution equal to a percentage of the eligible participants’ plan compensation, as follows:

<u>Number of vesting years on first day of the Plan year that contains the applicable month</u>	<u>Contribution for the month</u>
Less than 5 vesting years	4% of compensation for the month
At least 5 vesting years but less than 10	5% of compensation for the month
At least 10 vesting years but less than 15	6% of compensation for the month
At least 15 vesting years	7% of compensation for the month

At the discretion of the President and Chief Executive Officer of the Company, an additional contribution may be made for a Plan year, on behalf of each participant who as described above, has at least fifteen vesting years as of the first day of the Plan year and also has employment status with the Company on the last day of the Plan year.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The net earnings or loss of each fund within the Plan, including capital gains or losses whether or not realized, are allocated to individual participant accounts in that fund based on the ratio that the value of each participant's account bears to the value of all accounts in that fund as of the valuation date.

Vesting

Participants are immediately one hundred percent vested in their employee contributions. A vesting year means a plan year in which an individual has been credited with 1,000 hours for which an individual is compensated.

A participant who incurs a severance from employment with the Company prior to normal retirement shall be vested in their Employer contribution account according to this schedule:

Less than two vesting years	0% vesting
At least 2 vesting years	25% vesting
At least 3 vesting years	50% vesting
At least 4 vesting years	75% vesting
At least 5 vesting years	100% vesting

Payment of Benefits

Upon a participant's termination, retirement, death or disability, the participant or beneficiary is entitled to receive the value of their vested account balance. Payment of the amount is made in a lump sum, annuity or rollover distribution paid directly to an eligible retirement plan. Withdrawals prior to the age of 59½ are allowed only at termination of employment; on a hardship basis subject to IRS regulations provided that the amount withdrawn upon hardship may not exceed amounts contributed (unadjusted for investment gains/losses); for the purpose of childbirth or adoption; or for the purpose of a participant loan.

Loans to Participants

The Plan allows for loans to participants whose investments are with Mutual of America Life Insurance Company ("Mutual of America") and Mid Atlantic Trust Company ("MATC") which are secured by the participant's vested account balance that is segregated in the participant's interest accumulation and money market accounts. Participants may borrow against their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The interest rates on the loans range from 3.50% to 9.50%. Principal and interest are paid directly to Mutual of America and MATC in equal periodic payments through salary reduction. If a participant ceases to make loan repayments and the loan is deemed to be in default, the participant loan balance is reduced and a benefit payment is recorded. The amount of Plan assets collateralized by the loans was \$793,201 and \$612,425 as of December 31, 2024 and 2023, respectively.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$49,677 and \$150,753, respectively. These accounts are expected to be used to reduce future Employer contributions. For the year ended December 31, 2024, \$341,553 of forfeitures were used to reduce Employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Registered investment companies (mutual funds) and the money market fund are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, which has been measured by quoted market prices in an active market. See Note 3 for discussion of fair value measurements.

The Interest Accumulation Account is included in the financial statements at contract value, which is deemed to be fair value. The Interest Accumulation Account is credited with a contractual rate of return. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value within certain limitations. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The effective annual yield was 2.90% and 3.00% at December 31, 2024 and 2023, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and, changes therein as well as disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Subsequent Events

The Plan monitored and evaluated subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended December 31, 2024 through October 10, 2025, the date on which financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of the money market fund is reported at the carrying amount which approximates fair value because the instrument is liquid in nature.

Level 3 Fair Value Measurements

The fair value of Mutual of America's Interest Accumulation Account is represented by its current effective annual yield and the guaranteed minimum interest rate, which are determined by Mutual of America's financial strength and are subject to change but are always backed by Mutual of America's guarantee of principal and previously credited interest. The investment is presented at contract value, which approximates fair value and is not available for sale or transfer on any securities exchange, accordingly, transactions in similar investment instruments are not observable. The principal valuation technique is the discounted cash flow with risk-adjusted discount rate inputs applied.

The Company has various processes and controls in place to ensure that fair value is reasonably estimated. The Company sets the valuation policies for assets and is responsible for the determination of fair value. The Company (1) compares price changes between periods to current market conditions, (2) compares trade prices of securities to fair value estimates, (3) compares prices from multiple pricing sources, and (4) performs ongoing due diligence to confirm that independent pricing services use market based parameters for valuation. Valuation approaches are reviewed on an ongoing basis and revised as necessary based on changing market conditions to ensure values represent a reasonable exit price.

The Company assesses the fair value measurements applied by Mutual of America, including those for level 3 measurements, on a continuing basis. Periodically, the Company, together with Mutual of America, determines if the current valuation techniques used in the fair value measurements are still appropriate.

NOTE 4 – RELATED PARTIES AND PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are held by Mutual of America and MATC. Mutual of America and MATC are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan’s operations.

The Plan provides for loans to participants through Mutual of America and MATC utilizing the participants’ account balances as collateral. These transactions qualify as party-in-interest transactions as defined by ERISA.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

NOTE 6 – TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with sample language provided by the IRS in Revenue Procedures 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 8 – CERTIFIED INVESTMENTS

Information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America and MATC, the trustees of the Plan.
