Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Their report dated October 11, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). 1. DESCRIPTION OF PLAN

The following description of Future Pipe Industries, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the plan’s provisions.

General

The Plan is a qualified retirement plan that was originally effective on January 1, 2007, and has been amended and restated effective January 25, 2021. The purpose of the Plan is to enable eligible employees to save for retirement. Employees of Future Pipe Industries, Inc. (“Company”) that are not residents of Puerto Rico, union employees, or nonresident aliens may participate in the Plan after completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

Fidelity Management Trust Company serves as the trustee of the Plan. The duties of the trustee are to receive contributions and to invest and reinvest the trust asset of the Plan. Fidelity Investments is the recordkeeper for the Plan.

Contributions

Participants may elect to defer a percentage of their eligible compensation to the Plan as pre-tax contributions or Roth contributions. The Plan also contains an automatic enrollment feature in which the Company will automatically withhold 2% of a participant’s compensation unless the participant stops or changes this automatic contribution. Total deferrals in any taxable year may not exceed a federal tax law limit. The Plan further provides that participants who are projected to be age 50 or older by the end of the taxable year may make additional contributions as catch-up contributions. Participants may increase, decrease, suspend, or resume their deferral contributions during the plan year.

The Company has elected to make a safe harbor matching contribution equal to 100% of the first 3% of a participant’s eligible compensation, and 50% of the next 2% of the participant’s eligible compensation, contributed to the Plan. The Company may also make a discretionary nonelective contribution to the Plan. For 2024, the Company elected not to make a discretionary nonelective contribution.

Participants can roll over part or all of an eligible rollover distribution they have received from an eligible retirement plan into the Plan as rollover contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, rollovers, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their entire interest in the Plan into any or all of the investment securities available under the Plan. Participants can change their investment allocation among the various investment securities either through direct transfer from one security to another or by changing the percentage allocation of future contributions.

Vesting

Participants are always 100% vested in their contributions, safe harbor matching contributions, rollovers, and actual plan earnings thereon. The Company's discretionary nonelective contribution shall be vested in accordance with the following schedule:

Notes Receivable from Participants

Loans will be allowed for any purpose. Participants may borrow from their vested accounts a minimum of \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. All loans bear a reasonable rate of interest. Loan terms range up to five years or up to ten years for the purchase of a principal residence. Repayments are made through after-tax payroll deductions. Participants may only have one loan outstanding at any given time.

Benefits Paid to Participants

A distribution can be made to a participant due to disability, retirement, or termination of employment from the Company. A beneficiary may request a distribution in the event of death. In service withdrawals are permitted when a participant reaches age 59½ or in the event of financial hardship.

A participant's entire vested account balance will be paid in a single distribution or other distribution that the participant elects. Lump sum distributions include non-rollover distributions paid directly to the participant, direct rollover distributions rolled directly to an IRA or new employer's qualified plan, or a combination of non-rollover distributions and direct rollover distributions.

Forfeitures

If a participant terminates employment with the Company and is less than 100% vested in their employer account, the participant will forfeit the non-vested portion of their employer account. Forfeitures are retained in the Plan and may be used to pay administrative expenses or to reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,074 and \$25,358, respectively. In 2024, employer contributions were reduced by \$28,156 from forfeited non-vested accounts, and \$1,194 of forfeited non-vested accounts were used to pay administrative expenses.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expenses when they are incurred.

Payment Of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedules related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money Market Fund – Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily net asset value and to transact at that price. The money market fund is deemed to be actively traded.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. INCOME TAX STATUS

The pre-approved plan adopted by the Company received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the pre-approved plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Investments. Fidelity Investments is the recordkeeper for the Plan, therefore, these transactions qualify as party in interest transactions. In addition, the Plan provides for notes receivable from participants, which are party in interest transactions that are exempt from the prohibited transaction rules.

7. PROHIBITED TRANSACTIONS

During 2023 and 2022, the Company did not remit certain participant contributions to the Plan in a timely manner, as defined by ERISA. These contributions are considered prohibited transactions. The Company is actively working with Fidelity Investments to compensate the affected participants for lost investment earnings relating to these transactions. The Company believes these prohibited transactions do not affect the tax status of the Plan. There were no prohibited transactions in 2024.

8. PLAN TERMINATION

The Company has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time by taking appropriate action as circumstances may dictate. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

There were three investments as of December 31, 2024 and 2023, that represent a concentration of greater than 10% of the Plan's net assets available for benefits.
