## Independent Auditor's Report

Plan Administrator and Participants  
Service Lighting and Electrical Supplies, Inc. Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Service Lighting and Electrical Supplies, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained a certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) and Schedule of Delinquent Participant Contributions as of and for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Service Lighting and Electrical Supplies, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on June 1, 2018, by Service Lighting and Electrical Supplies, Inc. (the “Company”) under the provision of Section 401(a) of the United States Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company.

Substantially all employees of the Company are eligible to participate in the Plan, provided they have completed three months of service with the Company and are at least 21 years of age. After satisfying the eligibility requirements, an employee’s entry date into the Plan is the first day of the month coinciding with or next following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Administration

The Plan is administered by the Company (the “Plan Administrator”). The duties of the Plan Administrator are to oversee the operations of the Plan and to provide for prudent investment of Plan assets. Accordingly, the Plan Administrator has been granted discretionary authority concerning investment and management activities.

The daily operations, recordkeeping, and third-party administration of the Plan are monitored and performed by T. Rowe Price Retirement Services, Inc. and its sub-contractor, DST Retirement Solutions, LLC (collectively referred to as “T. Rowe Price”). The Plan’s investment assets are under the custody and management of Reliance Trust Company (the “Trustee”).

Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined by the Plan, subject to the dollar limitation of the IRC. The Plan permits both pre-tax and after-tax (Roth) deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are not to exceed the limits imposed by Section 402(g) of the IRC. Participants may also contribute amounts representing distributions from other eligible retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For newly eligible employees who were hired on or after June 1, 2018 and do not make an affirmative election otherwise, the Plan has an automatic enrollment feature whereby qualifying employees will be automatically enrolled into the Plan with a pre-tax compensation deferral rate of 4.00%. Participants can elect to stop or change the automatic contribution at any time.

The Company may contribute a discretionary matching contribution to the Plan. The Company will determine the amount of the matching contribution, if any, to be made each Plan year, to be applied on a uniform basis to all participants. For the years ended December 31, 2024 and 2023, the Company approved a dollar for dollar match of 50% of the first 4% of the employee’s salary. Additional profit sharing amounts (non-elective contributions) are not permitted by the Plan.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related employer matching, as well as the participant’s share of investment income, appreciation (depreciation), administrative expenses, and any related distributions. Allocations are based on participant earnings or account balances as defined. The participant determines both the amount to be invested and the allocation of the investment to one or more of the investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their elective contributions, rollover contributions, and the earnings received on those contributions. Vesting in the Company's contribution portion of their accounts, and the earnings thereon, is based on years of vesting service. A year of service is considered to be each twelve consecutive month period in which the participant is credited with 1,000 hours of service. A participant is 100% vested after six years of credited service. Full and immediate vesting will also occur upon attainment of normal retirement age, death, or total and permanent disability. Participants who leave the Company before they are fully vested in the Company's contributions forfeit the non-vested portion of their accounts.

Notes Receivable from Participants

The Plan allows for participants to borrow from their accounts under the Plan. These borrowings must be for an amount not less than \$1,000 and not more than the lesser of (a) \$50,000, reduced by the excess of the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan, or (b) 50% of the fair market value of the participant's vested account balance. Participants may have only two loans outstanding at a time. Each loan, by its terms, must be repaid in five years or less, except for loans for the purchase of a primary residence, which must be repaid in ten years or less. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator which is commensurate with prevailing interest rates. Principal and interest is paid ratably through payroll deductions.

Investment Options

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan to any one or more of the investment alternatives maintained by the Plan, determined at the discretion of the participant and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and the IRC. In the event of Plan termination, Participants will become 100% vested in their accounts to the extent not otherwise vested.

Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may receive a lump-sum distribution equal to the participant's vested account balance. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive required minimum distributions under IRC Section 401(a)(9). If the total vested balance of the terminating participant's account is \$5,000 or less and the participant does not elect otherwise, the Plan Administrator will cause an involuntary cash-out to occur in the form of a lump-sum distribution to the participant. In the event the vested account balance is less than \$1,000, the amount will be automatically rolled over into an individual retirement account in the participant's name. In addition, in-service and hardship distributions are permitted if certain criteria are met. Benefits are recorded when paid.

Forfeited Accounts

Forfeitures represent unvested portions of terminated participants' accounts and may be used to reduce future employer contributions or pay administrative expenses. At December 31, 2024 and 2023, the Plan had unallocated forfeitures of \$32,423 and \$42,156, respectively, and \$56,467 and \$18,727 of forfeitures were used to reduce employer contributions or pay administrative expenses during the years ended December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) are as follows:

Method of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan. The remaining administrative expenses are paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. The Plan is under no obligation to reimburse the Company for expenses paid on its behalf. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses in the accompanying statements of changes in net assets available for benefits. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair values of investments.

Use of Estimates

In preparing financial statements in conformity with GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Notes receivable from participants have interest rates ranging from 4.25% to 9.50% and are due at various dates through December 2029. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in fair value are reflected in operations. Interest-bearing cash (money market account), mutual funds, the self-directed brokerage account, and the common / collective trust represent investments with various investment managers. The respective fair values are based on the market value of the underlying investments, which are principally marketable equity and fixed income securities. Shares held in mutual funds and investments making up the self-directed brokerage account are traded on national securities exchanges and are valued at the net asset value (“NAV”) at year-end. Units held in the common / collective trust are valued at the unit value as reported by the investment managers at year end. Purchases and sales of investments are recorded on the trade-date basis. Interest and other income are recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The net appreciation (depreciation) of investments includes realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the fair value of investments held at year-end. Brokerage fees, if any, are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

The self-directed brokerage account consists of the Charles Schwab Brokerage Account and is intended for sophisticated investors who are willing to take on additional risk and are prepared to assume the responsibility of more closely monitoring their portfolio. This balance consists of investments in a money market fund or an exchange-traded fund, which are valued using the methodologies described in Note 3.

Investment Valuation and Income Recognition (Continued)

For the years ended December 31, 2024 and 2023, the Plan was invested in the T. Rowe Price Stable Value Common Trust Fund - Class E (“Stable Value Fund”), which is a common / collective trust established and maintained by T. Rowe Price Trust Company. The Stable Value Fund invests in synthetic investment contracts and short-term investments. An investment contract is a contract issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A synthetic investment contract has similar characteristics to a traditional investment contract and is comprised of two parts: the first part is units of a collective investment trust and/or a portfolio of underlying assets owned by the trust; the second part is a wrap contract (“Wrapper”) issued by a financially responsible third party. Wrappers provide contract payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity. Further information concerning the Stable Value Fund may be obtained from its audited financial statements.

The investment objectives of the Stable Value Fund are to maximize current income consistent with the maintenance of principal and to provide for benefit-responsive participant withdrawals at contract value for certain events without penalty or adjustment. The yield earned by the Stable Value Fund at December 31, 2024 and 2023 was 4.29% and 4.03%, respectively, while the yield earned by the Stable Value Fund with an adjustment to reflect the actual interest rate credited to participants in the Stable Value Fund at December 31, 2024 and 2023 was 3.29% and 3.04%, respectively.

Risks and Uncertainties

The Plan provides for investments in various investment securities with different investment strategies, which, in general, are exposed to various risks, such as interest rate, credit, foreign investment, active management, and overall market volatility risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. The Plan attempts to limit these risks by authorizing and offering participants a broad range of investment options that are invested in high quality securities or are offered and administered by reputable and known investment companies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits. The Plan’s exposure to a concentration of risk is limited by the diversification of investments across multiple investment fund options. Additionally, the investments within each investment fund option are further diversified into varied financial instruments.

Market conditions have resulted in an unusually high degree of volatility and increased the risks and may affect the short-term liquidity associated with certain investments held by the Plan which could impact the value of investments after the date of these financial statements. Because the values of individual investments fluctuate with market conditions, the amount of gains or losses that will be recognized in subsequent periods, if any, cannot be determined.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels, 1, 2, or 3.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Interest bearing cash:* Valued at the NAV of units held by the Plan at year-end, as provided by the Trustee.

*Mutual funds:* Valued at the NAV of shares held by the Plan at year-end, as provided by the Trustee. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage account:* The self-directed brokerage account consists of an investment in a money market fund and an exchange traded fund, which are registered with the Securities and Exchange Commission. These funds are required to publish the daily net asset value and to transact at that price. The money market fund and exchange traded fund are deemed to be actively traded.

*Common / collective trust:* Valued, as a practical expedient, at the NAV of units held by the Plan at year-end, as provided by the Trustee.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. TAX STATUS

The Company adopted the amended and restated DST Retirement Solutions, LLC Defined Contribution Pre-Approved Plan. The United States Internal Revenue Service ("IRS") has issued an opinion letter dated June 30, 2020, stating that the pre-approved plan is acceptable under Section 401(a) of the IRC for use by employers for the benefit of their employees. The Company is relying on the opinion letter (in accordance with Announcement 2017-41) that the Plan meets the qualification requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are interest-bearing cash accounts, mutual funds, and a common / collective trust managed by T. Rowe Price Associates, Inc., which is an affiliate of T. Rowe Price. Therefore, these transactions qualify as party-in-interest transactions. Purchase and sales of these accounts and the underlying investments comprising these accounts are performed on the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

7. REPORTABLE TRANSACTIONS

During the years ended December 31, 2024 and 2023, there were no loans in default or uncollectible which were not secured by the participant’s account balance, investment assets acquired and disposed of within the Plan, or non-exempt transactions with parties-in-interest, which would require supplemental presentation under DOL regulations.

8. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the Plan inadvertently failed to deposit \$293 of participant deferrals within the required time frame as stated by the DOL. The DOL considers late remittances to be prohibited transactions reportable on the schedule of delinquent participant contributions, which are reportable each year until fully corrected. As such, this amount is presented in the supplemental schedule of delinquent participant contributions included in these financial statements.

9. RECENT LEGISLATION

In December 2022, the Securing a Strong Retirement Act (“SECURE 2.0”) was passed into law. This package of laws builds on the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act of 2019. SECURE 2.0 covers numerous changes to retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers’ cost of offering and funding retirement savings plans. The provisions include both required and optional elements, and the Plan Administrator will determine the optional provisions to elect. The United States Department of the Treasury and the Internal Revenue Service continue to issue guidance and regulations implementing provisions of SECURE 2.0. Many of the provisions in SECURE 2.0 were effective in 2023 and 2024, but it will not be completely implemented until 2028. The deadline for amending plan documents has been extended to December 31, 2026.

NOTES TO FINANCIAL STATEMENTS

10. RECENT ACCOUNTING PRONOUNCEMENTS

In July 2025, the Financial Accounting Standards Board (“FASB”) issued Accounting Standards Update (“ASU”) 2025-05, *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets*. The ASU simplifies the estimation of expected credit losses for current receivables arising from revenue transactions under Accounting Standards Codification (“ASC”) Topic 606 – *Revenue from Contracts with Customers*, such as participant and employer contributions receivable. This ASU provides (1) all entities with a practical expedient to assume that current conditions as of the statement of net assets available for benefits date do not change for the remaining life of the assets and (2) entities other than public business entities with an accounting policy election to consider collection activity after the statement of net assets available for benefits date, but before financial statement issuance, when estimating expected credit losses. ASU 2025-05 is effective for the fiscal years beginning after December 15, 2025, with early adoption permitted, and requires prospective application.

The Plan is currently assessing the impact of this recent accounting pronouncement will have on its financial statements.

11. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Effective September 1, 2025, the Plan adopted the Higginbotham Pooled Employer Plan (“PEP”) administered by Finway Group. As part of the adoption, the plan merged and transferred its plan assets, including notes receivable to participants, in the amount of \$8,775,477 to Empower Trust Company. Effective September 1, 2025, the Plan’s participants became eligible to participate in the PEP.
