## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Colwell Industries, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). **1. Description of the Plan**

The following description of the Colwell Industries, Inc. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan is a defined contribution plan covering eligible employees of Colwell Industries, Inc., Colwell, Inc., and Technical Finishing Services, Inc. (collectively, the "Company" or "Employer").

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan was established in January 1985 and most recently amended in August 2022. The updated Plan documents did not significantly change the Plan's operations. During the year ended December 31, 2024, the plan sponsor terminated over 20% of their workforce, resulting in a partial plan termination. As a result, all affected participants became 100% vested in all employer contributions.

***Eligibility***

Employees of the Company must be at least 18 years of age, have completed one year of service, and be working in covered employment to be eligible to participate in the plan. Non-resident aliens, leased employees, members of collective bargaining agreements, and temporary employees are not eligible to participate in the Plan.

***Automatic Enrollment***

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Deferral rates are automatically set at 3 percent of eligible compensation unless a different rate is elected by the participant. There is no automatic escalation of the participant's deferral percentage.

***Contributions***

Participants may defer pre-tax or Roth contributions up to the limits set by the Internal Revenue Code. Participants satisfying certain criteria are permitted to make catch-up contributions, as stated in the Plan document. The Company matches 100% of the first 3% of an employee's eligible compensation contributed to the Plan and 50% of the next 2% of compensation. The Company may make a discretionary profit sharing contribution. There were no profit sharing contributions made during the years ended December 31, 2024 and 2023.

***Participant Accounts***

Each Participant's account is credited with the participant's contribution, employer matching contributions, employer discretionary profit sharing contributions, and allocations of Plan earnings and losses and, in certain cases, with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investment Options***

All investments of the Plan are participant directed. Participants may direct their accounts to be invested in one or more of the investment options available in the Plan and may transfer assets in their accounts between funds on a daily basis. The Plan currently offers mutual funds and a guaranteed investment contract as investment options for participants.

***Vesting***

Participants are immediately vested in their salary deferral, catch-up, and rollover contributions plus actual earnings thereon. Employer safe-harbor matching contributions are 100% vested at the time of contribution. Employer discretionary profit sharing contributions vest on a graduated scale to 100% after six years of service with a provision for 100% vesting at the normal retirement date, upon death, or at retirement due to disability, as defined in the Plan document. During the year ended December 31, 2024, the plan sponsor terminated over 20% of their workforce, resulting in a partial plan termination. As a result, all affected participants became 100% vested in all employer contributions.

***Forfeitures***

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their employer discretionary profit sharing contributions. Forfeitures may be used to pay Plan expenses or reduce Employer discretionary profit sharing contributions. The forfeited nonvested account totaled \$3,584 and \$3,482 at December 31, 2024 and 2023. The Plan expects to use this balance to reduce either employer contributions or administrative expenses by December 31, 2025.

***Payment of Benefits***

Upon termination of service due to death or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his or her account's vested interest, or substantially equal installments. Participants are also allowed to take in-service withdrawals upon reaching age 59½ and hardship withdrawals as defined by the Plan and Internal Revenue Service regulations. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan allows two loans to be outstanding at any given time. The loans must be repaid within five years, unless the loan is for a primary residence. Loans are secured by the balance in the participant's account and bear interest at a fixed rate set at the prime rate plus 1% at the time of issuance. Current loan interest rates range from 4.25% to 9.5%. Loans outstanding at December 31, 2024 mature through 2029.

***Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, all assets will be distributed to participants based on the balances in their respective accounts. During the year ended December 31, 2024, the plan sponsor terminated over 20% of their workforce, resulting in a partial plan termination. As a result, all affected participants became 100% vested in all employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying Plan financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Estimates***

The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require the plan administrator to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any unpaid accrued interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

***Payment of Benefits***

Benefits payments to participants are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation (depreciation) in fair value of investments.

### **3. Information Prepared and Certified by the Trustee**

The Plan's trustee, Empower Trust Company (the "Trustee"), is responsible for the custody and management of the Plan's assets. Investments held with the Trustee are invested in mutual fund accounts, and a guaranteed investment contract.

The Trustee has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants reported on the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment activity and interest on notes receivable from participants reported on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and,
- Schedule of Assets (Held at End of Year) as of December 31, 2024.

### **4. Fair Value Measurements**

The accounting framework for measuring fair value provides a fair value hierarchy prioritizing the inputs to valuation techniques used to measure fair value. The levels of this hierarchy are as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The hierarchy gives the highest priority to Level 1 inputs and the lowest priority to Level 3 inputs. The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

Mutual funds are valued at the daily closing price as reported by the fund and those held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fully Benefit Responsive Investment Contract**

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. Guaranteed investment contracts are valued at contract value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due to accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
2. Premature termination of the contract;
3. Plan termination or merger;
4. Changes to the Plan's prohibition of competing investment options; and
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or signoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact a contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract.

Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and
4. A material amendment to the agreements without the consent of the issuer.

**6. Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds and a fully benefit responsive investment contract managed by the Trustee as defined by the Plan. These transactions qualify as exempt party-in-interest transactions which are exempt from the prohibited transactions rules of ERISA. Additionally, notes receivable from participants qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**7. Income Tax Status**

The prototype adopted by the Plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, no uncertain positions were taken or are expected.

**8. Reconciliation of Financial Statements to Schedule H of Form 5500**

Both of the years ended December 31, 2024 and 2023 and the related Plan's Form 5500 reported the same net assets available for benefit and operating results. Net assets available for benefits per the Plan's Form 5500 are \$10,405,182 and \$10,826,492 as of December 31, 2024 and 2023. The net decrease in net assets available for benefits per the Plan's Form 5500 is \$421,310 for the year ended December 31, 2024. Such amounts agree to these audited financial statements.

**9. Contingencies, Risks and Uncertainties**

*Investment Options*

The Plan invests in various investment securities, some of which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in investment security values will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**10. Subsequent Events**

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available for issue.
