INDEPENDENT AUDITORS' REPORT

To the Plan Advisory Committee
Krones, Inc. 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Krones, Inc. 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Krones, Inc. 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Plan mergers - The plan sponsor acquired R&D Custom Automation, LLC ("R&D") effective January 1, 2024. In January 2024, all net assets of the former plan, which totaled \$3,310,076, were transferred to the plan. Additionally, the plan sponsor acquired AMPCO Pumps Company Inc. effective September 9, 2024. In September 2024, all net assets of the former plan, which totaled \$16,388,324, were transferred to the plan. These transfers are reflected in the accompanying statements of changes in net assets available for benefits.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events - The preparation of these financial statements includes the plan administrator's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 14, 2025, which is the date the financial statements were available to be issued.

Key parties of the plan - Krones, Inc. ("Krones") is the plan sponsor, employer and plan administrator. Javlyn Process Systems, LLC ("Javlyn"), Process and Data Automation, LLC, ("Process and Data Automation"), Krones Process Group North America ("Krones Process Group"), MHT USA, LLC., R&D and AMPCO are participating employers. Fidelity Management Trust Company is the trustee of the plan that holds custody of the plan's investment assets. Fidelity Workplace Services LLC is the record-keeper that maintains plan and participant records, tax counsel that performs various compliance tests and investment advisor. The two related entities are collectively referred to as "Fidelity".

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Interest-bearing cash and mutual funds - Valued at the daily quoted market prices as reported by the funds. The investments held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trusts - Valued at the NAV based on the units of the common/collective trusts. The common/collective trust investments are direct filing entities. The NAV, as certified by Fidelity, is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by the common/collective trusts less their liabilities. This practical expedient would not be used if it is determined to be probable that the common/collective trusts will sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as summarized below.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General - The plan was adopted effective September 1, 1985 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to make elective deferral contributions and receive employer discretionary matching contributions immediately upon hire.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their wages subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions and after-tax contributions. New employees are automatically enrolled in the plan and have 7% of compensation withheld as deferral contributions. Participant deferral percentages automatically increase by 1% each year until they reach a maximum of 10%. Such participants have the option to increase, decrease or stop the deferral at any time by completing the necessary documentation.
- b. Participant rollover contributions are accepted by the plan from other qualified plans.
- c. The individual employers may make matching contributions equal to a discretionary percentage of the elective deferral contributions, subject to certain limitations (matching contributions). The employer matching contribution percentage for all individual employers is 100% of the first 3% and 50% of the next 4% of the employee compensation contributed to the plan as elective deferral contributions in 2024 and 2023. These contributions are funded coinciding with each payroll with an annual true-up contribution.
- d. Employer nonelective contributions may be made at the employer's discretion. No such contributions were made in 2024 or 2023.

Vesting - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Most participants begin vesting in their employer contributions and related earnings after their first year of service, at which time they are 25% vested. These participants then vest at a rate of 25% for each year thereafter. Trans-Market participants who were hired on or before June 30, 2017, participants of Krones who were hired before January 1, 2016, Javlyn participants with accounts in the former plan prior to March 12, 2018, Process and Data Automation participants with accounts prior to the plan merging in on January 2, 2019 and R&D participants with accounts prior to the plan merging on September 9, 2024 are immediately vested in employer matching contributions. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

Forfeitures - Forfeitures may be used to pay administrative expenses or reduce employer contributions. Forfeitures used to reduce employer contributions totaled \$287,000 and \$32,000 in 2024 and 2023. Forfeitures used to plan administrative expenses were \$26,000 and \$38,000 in 2024 and 2023. Unapplied forfeitures were \$192,000 and \$215,000 as of December 31, 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions and an allocation of the employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

Benefits to participants - Benefits are recorded when paid. Benefit payments may commence upon death, disability, retirement or termination of employment. Participants generally receive distributions of their accrued benefits in the form of lump sum payments, installment payments or partial withdrawals. In-service distributions are permitted upon obtaining age 59½ and hardship withdrawals are also permitted under certain circumstances.

Notes receivable from participants - Participants may obtain loans from their accounts with the approval of the plan administrator. The required minimum loan amount is \$1,000 and the maximum loan amount is the lesser of \$50,000 or 50% of the vested account balance. Participants may only have one loan outstanding at any given time. The maximum loan term for a general purpose loan is five years. The loan term may be extended if the loan proceeds are used to purchase a primary residence. As of December 31, 2024, the interest rates charged on the loans ranged from 3.00% to 9.50%. The loans mature at various dates through November 2034. The notes receivable from participants are valued at their unpaid principal balances plus accrued but unpaid interest, which approximates fair value.

Administrative fees - Certain administrative fees of the plan are paid by the plan sponsor. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loans, overnight mailing, participant maintenance and portfolio advisory services and non-participant directed charges for investment advisory and contract administrator fees. The non-participant directed fees are paid using forfeitures or indirect compensation (see Note 3).

3. PARTY-IN-INTEREST TRANSACTIONS

Fidelity is the trustee of the plan that holds custody of the plan's investment assets. Fidelity also manages certain of the plan's investment offerings and, as such, these investment transactions qualify as party-in-interest transactions. Fidelity also receives indirect compensation from mutual fund service providers for services Fidelity provides to the funds. The compensation received by Fidelity is used to offset amounts that would otherwise be owed by the plan to Fidelity for administrative services provided.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although they have not expressed any intent to do so, the employers have the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted an FMR LLC pre-approved profit sharing plan. The pre-approved profit sharing plan received a favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
