## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Takahata Precision Tennessee, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

## **Basis for Opinion**

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Description of Plan

The following description of the Takahata Precision Tennessee, Inc. 401(k) Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 2012, is a defined contribution plan covering substantially all employees of Takahata Precision Tennessee, Inc. ("Company") who have completed at least three months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (*ERISA*).

Plan Operations

The Company is the sponsor of the Plan and has appointed the Company's president to serve as plan administrator. Nationwide Trust Company is the trustee of the Plan and is responsible for holding the assets of the Plan, executing investment transactions and making disbursements.

Contributions

Each year, participants may elect to contribute up to 100% of annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers one insurance company general account and numerous pooled separate accounts (with underlying mutual funds) as investment options to participants. The Company may make discretionary matching contributions or additional contributions allocated based on compensation. Company contributions are invested using the same allocation as the participant contributions. Contributions are subject to certain limitations. During the plan year, the Company provided a matching contribution equal to 100% of the first 5% of employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's contribution and allocations of (a) Plan earnings, and (b) charged with an allocation of administrative expenses. Allocations are based on account balances as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in employer matching and discretionary profit sharing contributions after a three-year cliff.

1. Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than their assumed life expectancy, or partial withdrawals. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

Forfeitures of non-vested Company contributions are used to reduce future Company contributions. During 2024, \$3,379 of forfeited amounts were used to pay plan expenses. At December 31, 2024 and 2023, there were \$2,502 and \$3,048 in forfeited accounts that had not yet been used to reduce the Company's contributions or pay plan expenses.

2. Summary of Significant Accounting Policies

Date of Management's Review

Subsequent events were evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The presentation of financial statements in conformity with the modified cash basis of accounting and where investments are reported at fair value requires management to make estimates and assumptions that affect the reported amounts of assets, net assets, changes in net assets and disclosures. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under this method, transactions are recorded on the cash method of accounting except for investments (which are reported at fair value).

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as reported by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Net investment gain (loss) from pooled separate accounts and mutual funds included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net realized gains or losses from the sale of investments represent the difference between the sales proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in fair value of investments held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets. Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets and liabilities and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of the underlying mutual funds that comprise the accounts at year-end.

Fixed Contract Account: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Nationwide Life Insurance Company (Nationwide). Nationwide maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value and then adjusted to contract value as reported to the Plan by Nationwide. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract has certain restrictions that impact the ability to collect the full contract value. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor, (c) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable. There are no reserves against contract value for credit risk on the contract issuer or otherwise.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

6. Tax Status

The Internal Revenue Service has provided an opinion to the trustee by a letter dated June 30, 2020, that the non-standardized defined contribution pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Party in Interest Transactions

Certain Plan investments are pooled separate accounts, managed by Nationwide Life Insurance Company. Nationwide Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the recordkeeping services was \$4,895 for the year ended December 31, 2024. Additional investment fees paid to the custodian are netted against investment returns.

9. Information Prepared and Certified by Trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and interest and dividends and net investment gain (loss) for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Life Insurance Company (the trustee of the Plan).
