**NOTE 1 DESCRIPTION OF PLAN**

The following description of Ascendum Machinery, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering all employees of Ascendum Machinery, Inc. (the "Company") who have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** – Each year, participants may contribute up to 90 percent of annual compensation as defined in the Plan. The Plan also allows participants to designate a portion or all of their deferral contribution at the time the deferral election is made as a Roth deferral contribution. Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation with an annual increase of 1 percent until a max of 6 percent is reached. Automatically enrolled participants have their contributions invested in a designated age based target date fund until changed by the participant. The Company may make discretionary matching contributions equal to a percentage of the participant's elective deferrals, 100 percent of the first 2 percent and 50 percent of the next 4 percent of eligible compensation that a participant contributed to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Contributions for Plan participants and matching contributions from the employer are recorded in the year in which the contributions are withheld from the participants' compensation.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or losses or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in matching and discretionary matching contributions after four years of credited service.

**Investment Options** – Upon enrollment in the Plan, a participant may direct employer and employee contributions in any of several investment options approved by Ascendum Machinery, Inc. 401(k) Plan's Retirement Plan Committee. Participants may change their investment options daily.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits** – On termination of service, a participant, or their beneficiary, may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of a financial hardship.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts from a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan transactions are treated as a transfer from the investment fund to the Notes Receivable from Participants account. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest, at a reasonable rate per year, is paid ratably through payroll deductions.

**Forfeited Accounts** – Forfeited nonvested accounts may be used to pay administrative expenses or applied to employer contributions. In the current year, there were no forfeited non-vested funds used to reduce employer match corrective contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts available to fund employer contributions and plan expenses totaled \$194,599 and \$131,809, respectively.

**Risks and Uncertainties** – The Plan’s invested assets ultimately consist of investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment advisors and the trustee. See Note 4 for discussion of fair value measurements.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains and losses on investments are included in the net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

**Benefits Paid** – Benefits are recorded when paid. As of both December 31, 2024 and 2023, no benefits were due to participants who have withdrawn from participation from the Plan and requested a benefit distribution.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded monthly. No allowance for credit losses has been recorded at December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**Administrative Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The following is a summary of the Plan’s asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedules, that was prepared by or derived from information provided by Equitable Life Insurance Company (“Equitable”), the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the trustee that the information provided to the Plan Administrator by the trustees related to the following assets is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

*Level 2* – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the securities and exchange commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed investment contract:* Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

*Pooled separate funds:* Valued at contract value which approximates fair value. The assets are marked to market on a daily basis.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Equitable provides certain administrative services to the Plan pursuant to a Master Plan Service Agreement (“MSA”) between the Company and Equitable. Equitable receives revenue from mutual fund service providers for services Equitable provides to the funds. This revenue is used to offset certain amounts owed to Equitable for its administrative services to the Plan.

If the revenue received by Equitable from such mutual fund service providers exceeds the amount owed under the MSA, Equitable remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 there were no excess amounts. The Plan or Plan Sponsor may make a payment to Equitable for administrative expenses not covered by revenue sharing.

Certain Plan investments are shares of mutual funds managed by Equitable who is also the investment trustee, as defined by the Plan, and, therefore, these transactions qualify as party in interest transactions. Administrator fees paid by the Plan for the 2024 investment services totaled \$103,142.

**NOTE 6 TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and all amounts of a participant's account will become 100% vested.

**NOTE 8 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

There are no reconciling differences between net assets available for benefits on the financial statements and the Form 5500 at December 31, 2024 and 2023.

There are no reconciling differences in benefits paid between the financial statement and the Form 5500. Amounts allocated to withdrawing participants are recorded in the Form 5500 for benefits claims that have been processed and approved for payment prior to the December 31, but not yet paid as of that date. No approved benefit claims existed at December 31, 2024, which were not paid.

**NOTE 9 DELINQUENT EMPLOYEE DEFERRALS AND LOAN REPAYMENTS**

During 2022 the Company erroneously failed to timely remit certain employee deferrals and loan repayments to the plan aggregating \$93,295. These deferrals and loan repayments as well as lost earnings associated have since been corrected.

**NOTE 10 OPERATIONAL DEFECT**

During the year ended December 31, 2024, it was discovered that certain plan provisions were not followed when considering plan compensation limits for the true-up employer contribution which was funded in December of 2024. As a result of this error, certain participant accounts were overfunded in match true-up. As of October 13, 2025, the Plan administrator is still in the process of reclassifying the impacted participants' excess match true-up into the Plan's forfeiture account.
