Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i – schedule of assets (held at end of year), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of the FirstFruits Holdco (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all eligible full-time employees of the Company and its affiliates that have adopted the Plan who have one year of service, 1,000 hours per year, and are aged 21 or older. The Plan administrator intends the Plan to be a safe harbor plan. In a safe harbor plan, if certain requirements are met, the Plan will be deemed to automatically pass certain Internal Revenue Service (IRS) required nondiscrimination testing. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions – Each year participants may contribute up to 100% of pre-tax annual compensation and/or after-tax elective Roth deferrals, not to exceed the annual regulated limits determined by the IRS as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. The employer makes a Safe Harbor matching contribution of 100% of participant contributions up to 4% of eligible wages. The Company may make additional discretionary matching, profit-sharing, and other qualified non-elective contributions. The employer made a Safe Harbor matching contribution of \$413,327 and \$408,740 for the years ended December 31, 2024, and 2023, respectively. No additional discretionary employer contribution was made for 2024 or 2023.

Participant accounts – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions and employer contributions upon entering the Plan plus actual earnings thereon.

NOTE 1 – DESCRIPTION OF THE PLAN (continued):

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance subject to approval of the Administrative Committee. The loans are secured by the balance in the participant's account and bear interest at prime plus one percent. Repayments are generally made over a period not to exceed five years; however, loans used to acquire a principal residence may be repaid over a reasonable period up to 15 years. The principal and interest are paid ratably through payroll deductions.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or in annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. For a hardship distribution, a participant may elect to receive a lump sum distribution from the vested interest in his or her account, excluding earnings and amounts attributed to employer's Safe Harbor contributions and participant's Roth contributions.

Forfeited accounts – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,186 and \$10,783, respectively. These accounts can be used to reduce employer contributions or pay Plan expenses. In 2024 and 2023, \$1,456 and \$717, respectively, was used to reduce employer contributions. No forfeited funds were used to pay Plan expenses in 2024 or 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued):

Contributions – Contributions from plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Notes receivable from participants - defaulted – Defaulted loans are loans resulting from the failure of a participant to make the required loan repayments on an outstanding loan and are considered deemed distributed loans. These loans are considered as a distribution to the participant for which a federal Form 1099 is issued. If the loan was issued after January 1, 2002, and the participant is still active and the loan has been defaulted on, it is categorized as a deemed distributed loan. The fund remains intact and remains as an outstanding loan for purposes of determining the number of loans allowed and is used in the loan availability calculation. There were \$7,185 and \$15,357 deemed distributed loans during the years ending December 31, 2024 and 2023, respectively.

Payments of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE:

Information contained in the financial statements and supplemental schedule that was certified to be complete and accurate by Matrix Trust Company, the trustee, is as follows:

- Investment amounts included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024.
- Net appreciation in fair value of investments, interest, and dividend amounts included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE 4 – FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"> • quoted prices for similar assets or liabilities in active markets; • quoted prices for identical or similar assets or liabilities in inactive markets; • inputs other than quoted prices that are observable for the asset or liability; • inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (Level 1): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Cash and cash equivalents (Level 1): Interest bearing accounts valued at fair market cash value.

Stable value collective investment funds (net asset value): A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value.

Certain Plan investments are shares of mutual funds managed by investment management companies, such as Matrix Trust Company. Matrix Trust Company is the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan’s direct payments to investment advisors and the third-party administrator also qualify as party-in-interest transactions. As stated in Note 2, certain Plan expenses are paid by the Plan, unless they are otherwise paid by the Company and thus are excluded from these financial statements.

NOTE 6 – PLAN TERMINATION:

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 – PLAN TAX STATUS:

The Plan was developed through a volume submitter template. The Internal Revenue Service (IRS) has determined and informed the submitter by a letter dated March 31, 2014, that the Plan's template and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500:

There are no reconciling items between the financial statements and Form 5500 for the years ended December 31, 2024 and 2023.

NOTE 10 – SUBSEQUENT EVENTS:

In a previous year, the Company purchased another orchard that had its own 401(k) plan. Subsequent to year end, the 401(k) net assets of the orchard acquired were transferred into the Plan.

Subsequent events have been evaluated by the Plan's management through October 9, 2025, the date the financial statements were available to be issued.
