Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Waukesha State Bank Employees' 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Waukesha State Bank Employees' 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Waukesha State Bank (the Sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Fidelity Management Trust Company is the Plan Trustee and recordkeeper. Substantially all employees who have completed at least 2 months of service with the Sponsor, as defined in the Plan document, and are age 18 or older effective May 6, 2024 (age 21 or older prior to that date), are eligible to participate in the Plan.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements.

Contributions

Participants may contribute up to 90% of pretax annual compensation, as defined in the Plan document, subject to the limits of the Internal Revenue Service (IRS). Participants may also designate some or all of the participant's contributions as a Roth deferral contribution. In addition, participants age 50 and older may make catch-up contributions, subject to the annual dollar limit. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Sponsor matching and profit-sharing contributions can be made at the discretion of the Sponsor. The participant groups that receive the profit-sharing contributions are at the discretion of the Sponsor. For the year ended December 31, 2024, the discretionary profit-sharing contributions were \$2,133,668 and the discretionary matching contributions were \$750,108. These contributions were offset by \$203,728 of forfeitures for total net Sponsor discretionary contributions of \$2,680,048 for the year ended December 31, 2024.

To be eligible for Sponsor contributions, participants must have completed at least one year of service with the Sponsor, be employed the last day of the year, and have completed 1,000 hours of service during the year.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor discretionary matching contributions, and allocations of the Sponsor's discretionary profit sharing contribution and the Plan's earnings and losses. Allocations of Sponsor discretionary contributions are based on the participant's eligible compensation as defined in the Plan document. Allocations of plan earnings and losses are based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus any earnings (losses) thereon. Participants who leave the Plan because of death, early or normal retirement, or disability, as defined in the Plan document, are considered 100% vested. Sponsor discretionary profit-sharing and discretionary matching contributions and earnings vest as follows:

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$200,239 and \$137,546, respectively. Forfeitures are used to pay administrative expenses or reduce Sponsor contributions. Forfeitures of \$203,728 were used to offset 2024 Sponsor contributions. There were no forfeitures used to offset administrative expenses during 2024.

Notes Receivable From Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the balance in the participant's account and bear interest between 3.25% and 8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid through payroll deductions. Note terms may not exceed five years, unless for the purchase of a primary residence, which is a maximum of ten years.

Note 1: Description of Plan (Continued)

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan document. The Plan also allows for in-service distributions upon attaining age 59 1/2. The Plan provides for normal retirement at age 65 and early retirement if the participant attains age 55 and completes 10 years of vesting service. The vested portion of a participant's account balance is distributed as a partial payment or in the form of a lump-sum.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates and are subject to change in the near future.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as benefit payments based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Expenses

The Sponsor pays substantially all of the Plan's administrative expenses which are excluded from the Plan's financial statements. Transaction fees related to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated to Plan participants based on their respective investment elections and are included in total investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 11, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Fidelity Management Trust Company, Trustee of the Plan.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets in active markets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

Note 4: Fair Value Measurements (Continued)

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

Note 6: Tax Status

The Sponsor adopted a non-standard pre-approved plan document with an IRS opinion letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company, the Trustee of the Plan. These transactions, as well as administrative expenses and notes receivable from participants, qualify as party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA regulations.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
