Opinion

We have audited the financial statements of The Savings and Profit Sharing Plan for Employees of Shelter Insurance Companies (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of The Savings and Profit Sharing Plan for Employees of Shelter Insurance Companies (“Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Shelter Mutual Insurance Company (“Plan Sponsor”) for the benefit of its employees who are not covered by a collective bargaining agreement, leased employees, salaried agents, or employees who are compensated solely by commissions or bonuses. Related employers who also participate in the Plan include Shelter General Insurance Company; Shelter Reinsurance Company; Shelter Life Insurance Company; Shelter Financial Services, including its subsidiary, Shelter Benefits Management Inc.; Shelter Enterprises, LLC; Shelter Investments, LLC; AmShield Insurance Company; Daniel Boone Agency, LLC and Haulers Insurance Company (collectively, the “Companies”). Employees who are age 18 or older are eligible to contribute to the Plan and participate in the Companies’ match upon the first of the month following employment. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). John Hancock Trust Company, LLC serves as Plan custodian.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Companies make annual contributions of 3% up to 100% of eligible compensation. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Companies may match a portion of the contributions of the participants. Depending on the amount of annual profit of the Companies, the first 3% of salary deferral contributions could be matched as many as five times. If there are sufficient earnings, an additional matching contribution shall be made equal to the portion of participants’ salary deferral contributions in excess of 3% but not in excess of 6%. Contributions are subject to certain limitations. Matching contributions of \$17,030,913 were made for the year ended December 31, 2024. There was no matching contribution for the year ended December 31, 2023.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant makes an affirmative election otherwise. Participants that defer less than 6% will be automatically enrolled in the Plan’s auto-escalation feature to get their rate to 6%, unless they opt-out.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Companies’ contribution and Plan earnings and is charged an annual operating expense based upon the participants’ investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions as well as all matching contributions made by the Companies.

Payment of Benefits

Upon retirement, total and permanent disability, death, or any other termination, the participant's account balance will be paid in a lump sum after the end of the year in which the participant terminates, provided the participant's account does not exceed \$1,000. If the value of the account is more than \$1,000 but less than \$5,000, unless the participant makes a timely election to roll over the vested account to an eligible IRA or another eligible retirement plan, or elects to have their vested account distributed in a lump sum, the vested account will be rolled over to an IRA selected by the Plan Administrator. All other participants can request an immediate lump-sum withdrawal, a lump sum after year-end matching, or a periodic payment not to exceed the joint life expectancy of the participant and the spouse or, if the beneficiary is not the spouse, the lesser of 60 months or the beneficiary's life expectancy. Participants may withdraw their account balance at any time, subject to certain restrictions. Benefit payments are recorded upon distribution.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1.5% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The pooled separate account is valued at estimated fair value as provided by New York Life Insurance. The pooled separate account is a group annuity contract that seeks to provide a low-risk, stable investment option.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Employer matching contributions are recorded when they are approved by the board for the year in which they are earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Plan Sponsor or the Plan, at the Plan Sponsor's discretion.

Note 3. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying Statements of Net Assets Available for Benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no assets measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan had no Level 3 securities.

Note 4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with New York Life Insurance Company (NYL). NYL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

Note 4. Investment Contract with Insurance Company (Continued)

The guaranteed investment contract is fully benefit responsive. The investment is presented at fair value, which approximates contract value. Contract value, as reported to the Plan by NYL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan also incurs expenses related to general administration and record keeping. The Plan Sponsor pays certain of these expenses and accounting and auditing fees relating to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7. Tax Status

The Plan obtained its latest determination letter on April 19, 2016, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the with applicable sections of the Internal Revenue Code (IRC) and therefore not subjected to tax. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
