## Independent Auditors' Report

To the Participants and Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Duquesne Light Company Medical Benefits Plan for IBEW-Represented Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Description of Plan

The following description of the Duquesne Light Company Medical Benefits Plan for IBEW-Represented Employees (the Plan) provides only general information. Participants should refer to the summary plan description, as amended, which is the plan document for a more complete description of the Plan's provisions.

### General

The Plan was established on April 1, 1959, to provide health and other benefits to all eligible participants of Duquesne Light Company (the Company) covered under the collective bargaining agreement between the Company and the International Brotherhood of Electrical Workers (IBEW). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is partially funded through a voluntary employees' beneficiary association trust (the VEBA Trust) that was established by the Company on February 1, 2008, to transact contributions and disbursements related to retiree benefits.

The Company is the plan administrator and the named fiduciary for the Plan. The plan administrator has all powers necessary to carry out the provisions of the Plan and to satisfy the requirements of any applicable law. The plan administrator establishes, among other things, the funding policy of the Plan, the form and nature of the Plan and the claims administration of the Plan.

The Bank of New York Mellon (BNYM) is the sole trustee for the VEBA Trust. As the trustee, BNYM administers and provides safe keeping of the VEBA Trust. BNYM is responsible for accepting contributions into the VEBA Trust from the plan administrator and making distributions or transfers out of the VEBA Trust pursuant to authorized instructions from the plan administrator.

### Benefits

Participation in the Plan is voluntary. The Plan provides preventive care and medical benefits, mental health and substance abuse treatment, prescription drug benefits and vision care benefits to eligible employees that are represented by the IBEW and to their covered dependents. Coverage generally begins 31 days following either the employee's initial employment date or the eligibility date, as defined by the plan document. Eligible retired employees and covered dependents are entitled to health benefits provided that the retiree has attained at least age 55 and has five years of service with the Company before retirement. Retiree health benefits end when age 65 is attained by the eligible participant. Health benefits are provided only for those medical conditions that are medically necessary and appropriate (unless for certain preventive care), not employment-related, and are treated or prescribed by a licensed provider. The Plan also provides postemployment health benefits to participants during periods of unemployment, as long as salary continuation is received, the participant is not employed elsewhere and under other limited circumstances as defined by the Plan.

IBEW-represented employees hired on or after October 1, 2010, are not eligible for retiree medical benefits. Highmark Blue Cross Blue Shield (Highmark) and Express Scripts process health and prescription drug claims, respectively, and perform provider network management under third party administrative agreements with the Company; however, the responsibility for payments to providers and participants is retained by the Plan.

## Contributions

The costs of the Plan are shared by the Company and the Plan's participants. Participating employees contribute a portion of their wages into the Plan through pre-tax payroll deductions. Employee contributions are calculated and set by the plan administrator, subject to the aforementioned collective bargaining agreement, for each of the various plan benefit coverage options. Participants make annual elections of the Plan's options during the open enrollment period offered by the Company. Participant elections must remain in effect for the next full calendar year, with exceptions for certain qualified life events, in order to meet restrictions set by the Internal Revenue Service (IRS) that allow for certain federal income tax advantages of the employee deductions. Employees may also contribute specified amounts to extend coverage to eligible dependents. Retiree participants contribute specified amounts to the Plan based on the various benefit coverage options, as well as the number of dependents elected for coverage. All participants are required to pay certain deductibles, coinsurance and copayments.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Employer contributions are credited to the Plan when benefit claim payments, net of refunds received and other plan expenses are paid by the Company and charged to the Plan.

## Stop-Loss Insurance

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured medical benefits (individual claims over a specified dollar amount, as well as its aggregate exposure for all claims). Premiums for stop loss insurance are included in insurance premiums paid in the accompanying Statements of Changes in Net Assets Available for Benefits. Stop loss reimbursements totaling \$38,474 for 2024 and \$66,177 for 2023 have been netted against benefits paid in the accompanying Statements of Changes in Net Assets Available for Benefits.

## Reclassifications

Certain amounts in the 2023 financial statements have been reclassified to conform with the 2024 financial statements. Such reclassifications had no impact on the reported results of operations or net assets.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, amounts incurred but not reported (IBNR), claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Payment of Benefits

Health claim payments are recorded when paid by the third-party claims processor, and are included in benefits paid, net in the accompanying Statements of Changes in Net Assets Available for Benefits.

## Expenses

Substantially all administrative expenses of the Plan, including, but not limited to, costs related to claims processing, legal, accounting and certain recordkeeping services are paid from plan assets. These expenses are recorded in the Statements of Changes in Net Assets Available for Benefits as administrative expenses. All other administrative expenses are paid by the Company on behalf of the Plan and are excluded from these financial statements.

## Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between willing market participants on the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividends, if any, are recorded on the ex-dividend date. Net appreciation, if any, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Claims Incurred but not Reported

Plan obligations at December 31, 2024 and 2023, for IBNR health claims by active participants at that date are estimated by the Company. Health claims incurred by retired participants but not reported at year-end are included in the postretirement benefit obligation.

## Subsequent Events

Subsequent events were evaluated through October 10, 2025, the date the financial statements were available to be issued.

## 3. Postretirement Benefit Obligations

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. The postretirement benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company, retired participants and from existing plan assets. Postretirement benefits include future benefits expected to be paid (net of refunds received), to or for (1) currently retired or terminated employees and their covered dependents and (2) active employees and their covered dependents after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

There were no plan amendments for the years ended December 31, 2024 or 2023.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The assumed weighted-average discount rate used to value the present value of plan benefit obligations changed from 5.26% to 5.74% in 2024, causing the actuarial present value of plan benefit obligations to decrease by approximately \$0.7 million in 2024. During 2023, due to various changes in actuarial assumptions, including a change in mortality tables, the actuarial present value of plan benefit obligations decreased by approximately \$0.7 million.

## 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual fund:* Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open-ended mutual fund that is registered with the U.S. Securities and Exchange Commission. This fund is required to publish its daily net asset value and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

## 5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, BNYM, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023. Such information was obtained by management and agreed to or derived from information certified as completed and accurate by a qualified institution.

## 6. Related-Party and Party in Interest Transactions

The VEBA Trust invests in a mutual fund that is registered by an affiliate of BNYM, the trustee of the Plan, and therefore, these transactions qualify as party in interest transactions. Other related party transactions include certain administrative costs and expenses which are paid by the Company. The Company does not consider contributions made to the Plan or benefit payments made on behalf of participants to be nonexempt party in interest transactions.

## 7. Plan Termination

Although it has not expressed any intention to do so, the Company may terminate, amend, modify or suspend the Plan in whole or in part at any time, subject to the terms of any collective bargaining agreement that limits the Company's right to do so, as well as to the provisions set forth in ERISA. In the event of plan termination, assets remaining will be applied in a uniform and nondiscriminatory manner towards the provision of benefits for or on account of the participants. No assets of the Plan may revert back to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

## 8. Tax Status

The VEBA Trust obtained its tax determination letter dated July 7, 2009, in which the IRS stated that the VEBA Trust is qualified pursuant to Section 501(c)9 of the Internal Revenue Code (IRC) and, accordingly, the VEBA Trust's net investment income is exempt from federal income taxes. The Company believes that the VEBA Trust continues to qualify and operate in accordance with applicable provisions of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes is included in the Plan's financial statements.

In addition, the Plan and the VEBA Trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the VEBA Trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the related VEBA Trust is tax-exempt.

The accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits. The Plan's investments are concentrated in one mutual fund. Refer to Note 4.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
