Notes to Financial Statements

Note 1: Description of Plan

The following description of the K-W Electric 401(k)/Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible classes of employees of K-W Electric, Inc. (the "Company"). Employees are immediately eligible to enter the Plan and receive discretionary matching and non-elective contributions. The Plan covers employees rendering services for the Company on contracts subject to the Davis-Bacon Act, Service Contract Act, or other Federal, state, or municipal prevailing wage laws.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for oversight of the Plan, including the determining the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Contributions

Each year, participants may elect to contribute to the Plan up to 100% of their eligible compensation, as defined in the Plan, on a pre-tax basis, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions and discretionary non-elective contributions. For the year ended December 31, 2024, the discretionary matching contributions were equal to 25% of participant contributions to the Plan, up to 10% of eligible compensation. Rollover contributions are not matched. The Company did not make any discretionary non-elective contributions for the year ended December 31, 2024. The Company contributions to the Plan for employees subject to prevailing wage laws are determined by the Company based on rates that satisfy the wage determination issued by the government agency responsible for the contract. During the year ended December 31, 2024, the Company made prevailing wage contributions of \$10 and discretionary matching contributions of \$138,991.

The Plan has recorded a Company contribution receivable of \$71,815 at December 31, 2024, that relates to an error found in the Plan's calculation of eligible compensation and Company discretionary matching contribution true up. This correction is considered a qualified non-elective contribution ("QNEC") that will be funded by the Company in 2025. Participants will be 100% vested in the QNEC once funded.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, Company prevailing wage contributions, and allocations of (a) the Company's discretionary non-elective contributions and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and charged with an allocation of administrative and investment management expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and the Company's discretionary matching and non-elective contributions, plus actual earnings (losses) thereon. Participants are also vested immediately in contributions made subject to prevailing wage laws.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to five years or may extend beyond five years if the note is for the purchase of a primary residence. A participant can only have one loan outstanding at one time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.00% at December 31, 2024, which were equal to the prime rate plus 2.00% as of the date of note issuance. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability retirement, death, or termination of employment with vested interests. Participants may elect to receive benefit payments in the form of a lump-sum distribution or in installments. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59.5. Participant account balances are also distributable to the participant upon termination of employment if the balance is less than \$7,000. Participants may withdraw their rollover contributions at any time.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0") signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately, through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023. The Plan also adopted provisions to allow penalty-free distributions in cases of domestic abuse, as well as increased the dollar limit for mandatory distributions effective January 1, 2024. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contracts ("FBRICs"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the plan document.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Management Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income. Fees related to administrative expenses are allocated proportionately to plan participants based on their respective account balances and included in administrative expenses. Fees related to the administration of notes receivable from participants and certain types of distributions are charged directly to the participant's account and included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 1 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds held in pooled separate accounts: Valued based on quoted net asset values ("NAVs") of the underlying investments held by pooled separate accounts. The underlying mutual funds held in pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price.

Note 4: Guaranteed Investment Contracts

The Plan invests in FBICs with Lincoln National Life Insurance Company ("Lincoln") in the form of guaranteed investment contracts ("GICs") that invest in traditional investment contracts. Lincoln maintains the contributions in general accounts. The accounts are credit with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GICs are carried at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based the best interest rate that is consistent with the performance of Lincoln's general account assets and is reviewed quarterly.

Certain events limit the Plan's ability to transact at contract value with Lincoln, including plan termination and other events as specified in the GICs. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GICs do not permit Lincoln to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and fully benefit responsive investment contracts at contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln, the Custodian of the Plan.

Note 6: Party-In-Interest Transactions

Certain plan investments are managed by Lincoln. Lincoln is the Custodian, as defined by the plan document and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administration services amounted to \$120 for the year ended December 31, 2024.

The Retirement Advantage, Inc. ("TRA"), is the third-party service provider, as defined by the plan document and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to TRA for administrative services amounted to \$4,420 for the year ended December 31, 2024.

Stadion Money Management ("Stadion") is the investment advisor to the Plan and, therefore, fees paid to Stadion qualify as party-in-interest transactions. Fees paid by the Plan for investment management fees amounted to \$47,188 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receiving the letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
