## Independent Auditors' Report

### To Plan Administrator of Birlasoft 401(k) Retirement Savings Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Birlasoft 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **1. Description of Plan**

The following brief description of the Birlasoft 401(k) Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### ***General***

The Plan is a defined contribution plan available to all full time non-union employees of Birlasoft Solutions, Inc., Birlasoft Computer Corporation, Birlasoft, Inc., Birlasoft Consulting, Inc. and Enable Path, LLC (collectively the “Adopting Employers”). The Plan is a defined contribution profit sharing plan under the provisions of the Internal Revenue Code (“IRC”) sections 401(a) and 401(k). The Plan is subject to the applicable regulations of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the IRC.

The Adopting Employers have contracted with Principal Trust Company (“Principal”) to assist with the administration of the Plan, including the processing and maintenance of certain participant records. Expenses incurred for administering the Plan may be paid by either the Plan or the Adopting Employers at its discretion. Effective March 24, 2021, the Birlasoft, Inc. 401(k) Plan and the Birlasoft Computer Corporation 401(k) Plan were merged into the Plan (the “Merger”).

#### ***Eligibility***

All full-time employees of the Adopting Employers are eligible for Plan participation and may enter the Plan upon fulfillment of 90 days of service.

An employee who has satisfied the eligibility requirements may enter the Plan on the first day of the month coinciding with or following the date which he or she satisfies such eligibility requirements.

#### ***Assets Held for Investment***

All Plan assets are held with Principal, the trustee, and record-keeper over all of the Plan’s assets. Among other duties, Principal is responsible for the custody of the Plan assets and for the payment of benefits to eligible participants.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered by the Plan. There is no limit to how often a participant may change their investment options. Participants should refer to each fund's prospectus for a more complete description of the risks associated with each fund.

### 1. Description of Plan (*continued*)

#### **Contributions**

Eligible employees may contribute up to 100% of their eligible compensation up to the annual limit determined by the IRC. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be contributed that is determined by the IRC.

Rollover contributions are comprised of distributions made to the participants from their account balances from their former employers' qualified retirement plans and transferred to the Plan.

The Adopting Employers may make a discretionary employer match each Plan year. The discretionary employer match contribution allocation formula is determined each year by the Adopting Employers and allocated to eligible employees accordingly.

#### **Vesting**

Upon entrance into the Plan, participants are 100 percent vested in their voluntary contributions. The matching and nonelective contributions vest as follows:

<u>Years of Service</u>	<u>Vested %</u>
At least 1 year, but less than 2	25%
At least 2 years, but less than 3	50%
At least 3 years, but less than 4	75%
4 years or more	100%

#### **Participant Accounts**

A separate account is maintained for each participant, which is credited with the participant's contribution and allocations of (a) the Adopting Employers' contributions and, (b) Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Forfeitures**

Forfeitures of terminated participants' non-vested accounts serve to reduce employer contributions or Plan expenses. During the year ended December 31, 2024, the Adopting Employers elected to use \$160,707 of the forfeited non-vested accounts to reduce their contributions, as allowed by the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled to \$190,845 and \$69,912, respectively.

### **1. Description of Plan (*continued*)**

#### ***Payment of Benefits***

A participant may elect to receive benefit payments at the normal retirement age of 65 or at an early retirement date. The Plan also provides for distribution of benefits upon death or disability. Upon retirement, death or disability, the participant becomes 100% vested and all amounts credited to the participant's account shall be distributed to the participant or his or her beneficiary in either a lump-sum payment of the fully vested account balance or a single-sum payment of a portion of the account balance.

In-service distributions may be made from a participant's account at any time upon or after the occurrence of the following events:

- Participant's attainment of age 59½
- Due to hardships, as defined in the Plan document
- Participant becoming disabled
- Attainment of normal retirement age

A participant may apply to the Plan administrator for a hardship withdrawal at any time. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include post-secondary educational expenses for the participant or their dependents, medical expenses to the extent not otherwise reimbursed under the Adopting Employers' medical programs, expenses for the purchase of a principal residence or material alterations thereto, payments to prevent eviction from or foreclosure on a principal residence and burial or funeral expenses for the participant's parent, spouse, children or dependents.

#### ***Notes Receivable from Participants***

Loans to participants are allowed in accordance with the provisions of the Plan document. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The amount available for borrowing will be reduced by the amount of his or her highest outstanding loan balance, if any, during the previous one-year period. These loans are secured by the balance in the participant's account and bear interest as determined at the time of the loan origination.

Principal and interest is paid ratably through bi-weekly payroll deductions over a period of time not to exceed five years. If the proceeds are used to construct or rehabilitate a participant's principal residence, the Plan administrator may permit a longer repayment term. Principal and interest repaid is reinvested based on the participant's present investment allocation selection.

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Adopting Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States of America (“US GAAP”), using the accrual basis of accounting, which recognizes revenue when it is earned and expenses as they are incurred.

#### ***Use of Estimates***

The preparation of financial statements in conformity with US GAAP requires the Plan’s management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions to net assets available for benefits during the period. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows US GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

### **2. Summary of Significant Accounting Policies (continued)**

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except for the investment in the group annuity contract. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value ("NAV") and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV of the common/collective trusts, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts.

Pursuant to US GAAP guidance, alternative investments where fair value is measured using NAV are not categorized within the fair value hierarchy.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold during the year as well as those held at the end of the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Excess Contributions Payable***

Amounts contributed by participants in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

With the exception of the Plan's recordkeeping fees and participant loan expenses (loan setup and loan maintenance fees) which are charged to the individual participant's account, all other administrative expenses incurred by the Plan are paid by the Adopting Employers and are excluded from these financial statements.

Expenses relating to investment management are paid directly by the respective investment vehicle and are included in net appreciation in fair value of investments.

### **3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividend income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

### **4. Tax Status**

The IRS issued an opinion letter to the prototype plan document preparer, Principal, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods pending.

#### ***Common/Collective Trusts - Principal Trust Target Date Funds***

The Plan offers common/collective trusts called the Principal Trust Target Date Funds ("Target Date Funds"). These Target Date Funds include: the Principal LifeTime Hybrid 2020 CIT; the Principal LifeTime Hybrid 2025 CIT; the Principal LifeTime Hybrid 2030 CIT; the Principal LifeTime Hybrid 2035 CIT; the Principal LifeTime Hybrid 2040 CIT; the Principal LifeTime Hybrid 2045 CIT; the Principal LifeTime Hybrid 2050 CIT; the Principal LifeTime Hybrid 2055 CIT; the Principal LifeTime Hybrid 2060 CIT; the Principal LifeTime Hybrid 2065 CIT; the Principal LifeTime Hybrid 2070 CIT; and the Principal LifeTime Hybrid Income CIT. The unit value of each of these Target Date Funds is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants, but are reflected in the unit value.

#### ***Fully Benefit-Responsive Investment Contract***

The Plan invests in one fully benefit-responsive investment contract called the Principal Fixed Income Guaranteed Option Account (the "Fund"). The Fund maintains its contributions in insurance company general accounts. The Fund consists of guaranteed investment contracts, which are valued, based on the net asset value of the Fund as reported by the investment advisor.

### **5. Investments (continued)**

#### ***Fully Benefit-Responsive Investment Contract (continued)***

The Fund is recorded at contract value. Contract value is the relevant measurement attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Fund represented approximately 8% and 9% of the Plan's total net assets available for benefits at December 31, 2024 and 2023, respectively. Participants may ordinarily withdraw or transfer all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The principal and previously credited interest is guaranteed by Principal. This guarantee is subject to Principal's financial strength and claims paying ability.

### **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **7. Party-In-Interest Transactions**

Certain Plan investments are managed by Principal. Principal is the custodian as defined by the Plan and, therefore, those transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Adopting Employers, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.
