Note 1. Description of the Plan

The following brief description of the Entech Sales and Service Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

General

The Entech Sales and Service, Inc. (the Company) established the Plan effective as of April 1, 2001. As of January 1, 2017, the Plan was amended and operated, as a leveraged employee stock ownership plan (ESOP) through the period ended March 31, 2021. The ESOP is designed to comply with section 401(a) of the Internal Revenue Code of 1986 (Code), as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by a Plan Committee comprising up to one person appointed by the Company's board of directors. The trust department of a third-party bank is the Plan's Trustee.

The Company amended the Plan's adoption agreement effective December 31, 2017, to reflect a change in the name of the Company and to change the name of the plan from Entech Sales & Service, Inc. Employees' Stock Ownership Plan to Entech Sales and Service Employee Stock Ownership Plan.

Employee Stock Ownership Plan

The Plan purchased common shares of the Company using the proceeds of borrowings from the Company and holds the stock in a trust established under the Plan. As the Plan makes each payment of principal, an appropriate percentage of stock is allocated to eligible employees' accounts in accordance with applicable regulations under IRC. All borrowings were repaid in 2021 and all shares were fully allocated during 2021.

Eligibility

Employees (age 21 or older) who have completed one year of service and have worked at least 1,000 hours of service are eligible to participate in the Plan. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation for Company contributions for such year.

Contributions

Employer contributions are granted at the discretion of the Entech Board of Directors (the Board) in an amount not to exceed the allowable deduction for federal income tax purposes but not less than the amount needed to satisfy current obligations of the Plan. A participant's share of the basic, non-elective contribution for a Plan year is calculated based on a percentage of the participant's compensation for the year. The payment may be in cash or in Company common stock. Contributions are invested primarily in the Company common stock. There was \$1,681,985 and \$3,556,853 contributed to the Plan for the years ended December 31, 2024 and 2023, respectively.

No participant shall be required or permitted to make contributions to the Plan.

Payment of Benefits

Distributions on account of death or disability are made in a lump sum in the Plan year following the event. Distributions on account of retirement are paid out between one and five years and begin in the Plan year following the event. Distributions are made in cash or, if a participant elects, in the form of Company common stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations. Distributions for other separations from service commence in the fifth Plan year following the separation from service and are made through (i) minimum distribution requirements, (ii) diversification requirements (iii) as the plan administrator otherwise determines. The amount to be distributed is based upon the immediately preceding valuation date.

Administrative Expenses

As provided by the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company common stock released by the Trustee from the unallocated account and forfeitures of terminated participant's nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Forfeitures

The non-vested portion of a terminated participant's account will become forfeitures as of the allocation date of the plan year in which the participant incurs a five-year break in service. Forfeitures will be allocated to the accounts of the remaining participants at the end of the plan year in which the forfeiture occurs (i.e., as of the December 31st of the year in which a participant incurs a five-year break in service), in the same manner as employer contributions are allocated. Forfeitures allocated to participants during December 31, 2024 and 2023 totaled \$49,489 and \$3,595, respectively.

Vesting

Benefits vest 100% for participants whose employment is terminated by reason of retirement, death or total disability. Participants will be 100% vested after three years of service.

Any portion of a terminated participant's account forfeited due to the vesting provisions described before is reallocated within the Plan to other participants based on the participant's eligible compensation as a percentage of the total compensation of all eligible participants. As of December 31, 2024 and 2023, the outstanding forfeitures balance was \$0.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution or a direct transfer to another Company qualified plan. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all highly liquid investments with a maturity of three months or less when purchased to be cash equivalents.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

The shares of Company stock are reported at fair value. See Note 4 for discussion of fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Management's Review of Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued using the NAV of the fund shares.

Company common stock: Valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years.

The valuation process involves the trustee's selection of an independent valuation specialist that has determined the methods and assumptions to determine fair value. Plan management accumulates the data for the valuation specialist from audited financial statements of the Company.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party in interest transactions. As described in Note 1, the Company pays all plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

Note 6. Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 7. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Company directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

Note 8. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated August 23, 2017, stating that the Plan qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
