1. Description of the Plan

The following brief description of the Employee Benefit Plan of Harry S. Truman Children's Neurological Center DBA TNC Community (the Plan) provides only general information. Participants should refer to the Plan document for more complete information, copies of which may be obtained from Harry S. Truman Children's Neurological Center DBA TNC Community (the Company or Plan sponsor or TNC Community).

General

The Plan is a defined contribution plan for all eligible employees who are employed by the Company that meet the Plan's eligibility criteria. Employees of TNC Community who have reached twenty-one years of age are eligible to make elective deferrals. Employees of TNC Community who have completed one year of service and reached twenty-one years of age are eligible for employer matching contributions and employer base (non-elective) contributions. Mutual of America Insurance Company (MoA) serves as the trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants in the Plan may contribute up to 100% of their pretax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions) and Roth contributions. The Plan includes an auto-enrollment provision whereby all eligible employees, who were newly hired or rehired after May 1, 2019, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. If automatically enrolled, a participant's deferral is set at 2% of eligible compensation until changed by the participant.

The employer match is 100% of an employee's contributions up to 2% of the employee's compensation. Employer non-elective (base) contributions are calculated based on the employee's compensation. TNC Community will contribute 3% of the employee's compensation received during the Plan year while the participant meets the eligibility requirements. Employer matching

and non-elective contributions begin in the month after the employee meets the service and eligibility requirements.

All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and non-elective contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants may direct the investment of their contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan currently offers a mix of pooled separate accounts and an interest accumulation account as investment options for participants.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after one year of service, and vests incrementally until 100% vested at five years of service. Full vesting also occurs if a participant becomes disabled, as defined; dies while actively employed; or reaches early or full retirement age, as defined.

Payment of Benefits

When a participant terminates employment for any reason, all vested amounts in the participant's account, upon request, shall be distributed to the participant or, in the case of death, to a designated

beneficiary. Terminated participants may defer receipt of their distribution, except if below a minimum amount. In-service withdrawals are available in certain limited circumstances, as defined by the Plan document. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available distributions prior to requesting a hardship withdrawal.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum level equal to the lesser of (a) 50% of the participant's vested account balance or (b) \$50,000 with an interest rate equal to the prime rate plus 1%. The loans are secured by the balance in the participants' accounts. Loan terms range to a maximum of 60 months, except for purchase of a primary residence. Principal and interest are repaid through payroll deduction or by check. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined, represents a forfeiture. During the year ended December 31, 2024, the Plan used forfeitures of \$14,009 to reduce employer contributions, in accordance with Plan provisions.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company. Certain transaction related fees are charged to the account of the participant.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Pooled separate accounts are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Amounts in the Interest Accumulation Account of the insurance company are credited with interest at a rate determined by the insurance company. The Interest Accumulation Account is carried at amortized cost, or contract value, and is deemed to be fair value for an insurance company general account. It is not considered to be benefit responsive. The Interest Accumulation Account is considered to be a cash equivalent and therefore exempt from classification in the ASC 820-10 fair value table in Note 4. There are no restrictions on participant directed transactions.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of the amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in March 2025.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Investments Certified by Insurance Company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company, the insurance company of the Plan.

4. Fair Value Measurement

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

Pooled Separate Accounts: Units of pooled separate accounts are valued based on the net asset value (NAV) provided by the administrator of the fund. The value is based on the value of the underlying mutual funds which comprise the pooled separate account.

Certain investment information in the prior year fair value table was reclassified to conform to the current year presentation based upon management evaluation. This had no impact on the Statement of Net Assets Available for Benefits or the Statement of Changes to Net Assets Available for Benefits.

5. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Exempt Party-in-Interest and Related Party Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain Plan investments are units of pooled separate accounts issued by Mutual of America, the insurance company. Mutual of America is the insurance company as defined by the Plan and these transactions, including issuances of loans to participants, qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on the fund.

8. Subsequent Events

Management evaluated subsequent events for the Plan through September 16, 2025, the date the accompanying financial statements were available to be issued.
