Opinion

We have audited the financial statements of Machinists' Money Purchase Pension Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Machinists' Money Purchase Pension Fund (the Plan) provides only general information. Participants should refer to the *Plan document* for a more complete description of the Plan's provisions.

General

The Plan is a multi-employer, defined contribution plan established under an Agreement and Declaration of Trust dated January 1, 1994, pursuant to collective bargaining agreements between Lodge 447 International Association of Machinists & Aerospace Workers, AFL-CIO (the Union) and various employers doing business in and around the New York and New Jersey area. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is currently administered by a third-party administrator.

Contributions

Contribution rates have been established under collective bargaining agreements entered into between the Union and the various employers. Each employer is required to make monthly contributions to the Plan at the rate(s) specified in its respective collective bargaining agreement.

Participant Accounts

Each participant's account is credited with employer contributions made on their behalf. A pro rata share of the Plan's net investment income and administrative expenses are allocated in accordance with the formula specified in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become fully vested in an individual account on the earliest of the following dates:

- (a) The date the employee became a participant in the Plan if:
 1. The employee became a participant before June 1, 1995; or
 2. At the time the employee became a participant, he/she was a participant in the Lodge 447 Severance Fund.
- (b) The date the participant earned three years of vesting service under the Plan (a participant earns a year of vesting service for each year, beginning from the date employment commenced, in which 1,000 hours of service is earned). For participants with one year of service on or after April 1, 1998, the participant will become vested with one year of vested service.
- (c) The date a participant attains normal retirement age.

Payment of Benefits

Upon termination of service due to death or retirement, or termination of employment with a contributing employer, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in the form of a lump sum amount or a lifetime annuity.

Forfeitures

When a participant's employment with a contributing employer terminates before interest in an individual participant account becomes vested, the participant will forfeit the individual account unless the participant returns to employment with a contributing employer, in a position for which the employer is obligated to contribute to the Plan and earns at least 501 hours of service in a calendar year before the participant has incurred five consecutive "Breaks in Employment". Amounts forfeited shall be credited, in the year of forfeiture, to the Plan contribution account, and such forfeitures shall be allocated to the individual accounts of eligible participants in the same manner as employer contributions. At December 31, 2024 and 2023, there were \$-0- forfeited non-vested accounts.

Third-Party Administrators

The Plan utilizes a third-party administrator for the administration of the Plan's participant account balances, for the collection of employers' contributions and for the payment of benefits to eligible participants.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

All expenses of maintaining the Plan are paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual fund: Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Money market fund: Valued using the NAV of the fund shares.

Note 4. Related Party Transactions and Party in Interest Transactions

Certain plan investments are shares of collective trust funds held by Amalgamated Bank of New York. Amalgamated Bank is the custodian and record keeper for the Plan, therefore, these transactions qualify as party-in-interest transactions.

The Plan is associated with the Lodge 447 Fringe Benefit Trust Fund and the International Association of Machinists District 15 Health Fund through common participants and certain trustees.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the trustees have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 6. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated August 5, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Contributions from one employer represent approximately 11% of the total contributions and approximately 10% of total contributions receivable as of December 31, 2024.


