We have performed audits of the financial statements of CVR Energy 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - PLAN DESCRIPTION

The following description of the CVR Energy 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by CVR Services, LLC, a subsidiary of CVR Energy, Inc. (“CVR”), for the benefit of its nonunion employees and the nonunion employees of the following participating employers: Coffeyville Resources Nitrogen Fertilizers, LLC; CVR Common Services, LLC; Coffeyville Resources Crude Transportation, LLC; and East Dubuque Nitrogen Fertilizers, LLC (collectively, the “Company”). Effective January 1, 2023, CVR Common Services, LLC was added as a participating employer in the Plan and Coffeyville Resources Refining & Marketing, LLC (“CRRM”) and Wynnewood Refining Company, LLC (“WRC”) were removed as participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). T. Rowe Price Trust Company (“T. Rowe Price” or “Trustee”) serves as both the trustee and the custodian.

Eligibility

Employees are eligible to participate in the Plan immediately upon hire. Eligible employees exclude those employees whose employment is governed by a collective bargaining agreement, non-resident aliens, leased employees, independent contractors, and part-time employees (those who are scheduled to work less than 1,000 hours per year).

Contributions

Participants may contribute up to 60% of eligible compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may elect to classify all, or a portion, of their elective deferral as a Roth elective deferral. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions. Contributions are subject to certain limits specified by the Internal Revenue Code (“IRC”). The Plan includes an automatic enrollment feature, which automatically enrolls employees in the Plan at a deferral rate of 6% of eligible compensation 30 days after their eligibility date unless they opt out.

The Company may make matching contributions to the Plan. For the year ended December 31, 2024, the Company contributed 100% of the first 6% of eligible compensation that a participant contributed to the Plan. While additional amounts may be contributed at the option of the Company, no such contributions were made for the year ended December 31, 2024.

Participant Accounts

A separate account is established for each participant. The account is credited or charged, as applicable, with the participant’s salary deferral contributions, an allocation of the Company’s contributions, the participant’s share of investment earnings and losses, the participant’s distributions, and certain administrative charges. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their account into the various investment options offered by the Plan. If a participant fails to direct investment of their contributions, the T. Rowe Price Retirement Fund available in the Plan with the target date closest to the year in which the participant turns age 65 will serve as their default investment. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant’s account.

Vesting

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the Company's contributions, plus earnings thereon, is based on years of continuous service according to the following schedule:

Forfeitures

Any forfeited, non-vested Company contributions may be used to reduce future Company contributions or pay Plan expenses. During 2024, there were \$427,049 of forfeitures used to offset Company contributions paid in 2024 for 2023 contributions. At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$37,630 and \$20,953, respectively.

Payment of Benefits

If participants terminate employment with account balances less than \$1,000, they will automatically receive a lump sum distribution upon termination of employment. For balances greater than \$1,000, on termination of service due to termination of employment, death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a specific period of time, not to exceed the life expectancy of the participant or the participant's beneficiary, whichever is longer. The Plan permits in-service withdrawals for those participants who have attained age 59½ or hardship withdrawals.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans are secured by the balance in the participant's account and bear interest at fixed rates which are based on the published prime rate plus one percent at the time the loan is initiated. Loans are repayable over a period not to exceed five years, unless the loan is for the purchase of a primary residence and are primarily repaid through payroll deductions. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024 and December 31, 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments represents realized gains and losses on investments sold during the year, as well as the change in unrealized appreciation (depreciation) of investments that are held by the Plan at year-end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced to zero and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are recognized as administrative expenses. Investment related expenses are included in the net appreciation (depreciation) in fair value of investments.

Other Income

T. Rowe Price Retirement Plan Services, Inc. receives pricing credits associated with certain investments in the Plan and allocates those pricing credits to participants in proportion to their account balances invested in those options.

Transfer of Assets

Certain employees participate in the Plan or the CVR Energy 401(k) Plan for Represented Employees (the "Represented Plan"). Participation is based on the employees' job classification. Consequently, transfers of assets between the Plan and the Represented Plan occur as participants change job classifications. Assets are transferred at fair value at the date of transfer.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

On May 27, 2025, the Retirement Plans Management Committee approved to add the after-tax contributions and in-plan Roth conversion provisions to the Plan effective January 1, 2026. This retirement plan savings strategy allows individuals such as high-income earners to contribute larger amounts to Roth accounts, by first contributing after-tax to the 401(k) plan and then electing to convert those after-tax contributions to Roth contributions.

The Plan Administrator is not aware of any other subsequent events which would require recognition or disclosure in the financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

In accordance with Financial Accounting Standards Board Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures* ("ASC 820"), the Company utilizes the market approach to measure fair value of the Plan's financial assets and liabilities. The market approach uses prices and other relevant information generated by market transactions involving identical or comparable assets, liabilities or a group of assets or liabilities.

ASC 820 utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels. The following is a brief description of these three levels:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Other significant observable inputs (including quoted prices in active markets for similar assets or liabilities).

Level 3 - Significant unobservable inputs (including the Plan's own assumptions in determining fair value).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds - Valued at the NAV of the units held by the Plan at year-end, as determined by fair value of the underlying assets. Underlying assets include commingled pools of exchange traded equity and fixed income securities.

Investments without a readily determinable fair value have been valued at NAV as a practical expedient to estimate fair value.

(a) Withdrawals for benefit payments and participant transfers to noncompeting investment options to be paid to Plan participants shall be made 30 days after written notification has been received. All other withdrawals may be made up to one year after notification is received. The Company submitted a 12 months' advance redemption notice to the T. Rowe Price Stable Value Common Trust Fund ("SVF") on April 13, 2023 seeking to withdraw 100% of its interest from the SVF. Participants were notified in May 2024 that the assets from the SVF would be transferred to the Vanguard Federal Money Market Investment Fund on June 18, 2024.

NOTE D - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator determined that the certification received from the Trustee meets the requirements of ERISA Section 103(a)(3)(C). NOTE E - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are held and managed by T. Rowe Price. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company contribution portion of their account.

NOTE G - TAX STATUS

The Internal Revenue Service (“IRS”) issued an opinion letter dated August 19, 2020, stating that the form of prototype plan used by the Plan is acceptable under Section 401 of the IRC. Although the Plan has been amended since the opinion letter was issued, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and the Plan is exempt from federal income taxes.

U.S. GAAP requires management to evaluate tax positions taken by the Plan to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

NOTE H - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks, and may be further exposed to impacts from political and economic changes caused by global market conditions and geopolitical events such as the conflicts and tensions in the Middle East and the ongoing Russia-Ukraine War. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
