## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the  
Institutional Shareholder Services Inc. 401(k) Retirement Savings Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Institutional Shareholder Services Inc. 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

## **NOTES TO FINANCIAL STATEMENTS**

December 31, 2024 and 2023

### **NOTE 1 – PLAN DESCRIPTION**

The following description of the Institutional Shareholder Services Inc. 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan that was established on April 22, 2014, by Institutional Shareholder Services, Inc. (the “Company” and “Plan Sponsor”) to provide benefits to eligible employees as defined in the Plan document. The Plan is referred to as a “qualified automatic contribution arrangement 401(k) plan”, also known as a “QACA”. In order to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met, the Company has committed to make certain contributions to the Plan as described below. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### Eligibility

Employees are eligible to participate in the Plan on their date of hire unless they are members of a class of employees excluded from participation in the Plan, as defined in the Plan document.

#### Administration

The Company has appointed a Plan administrator to manage the operation and administration of the Plan. T. Rowe Price Trust Company (“Trustee” or “T. Rowe Price”) acts as the trustee and third-party administrator to process and maintain the records of participant data.

#### Participant Contributions

Participants may elect to have the Company contribute their eligible pre-tax or Roth after-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in compensation. Contributions withheld are invested in accordance with the participant’s direction. The Plan includes an automatic enrollment provision whereby eligible participants are automatically enrolled at a pre-tax deferral rate of six percent of eligible compensation, unless they elect otherwise. A participant who is on automatic enrollment may opt in for automatic increases. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

#### **NOTE 1 – PLAN DESCRIPTION (Continued)**

##### Company Contributions

The Company provides matching contributions of 100% of each dollar a participant defers, up to 6% of participant's eligible compensation. Additionally, the Company makes a safe harbor nonelective contribution equal to 3% of employee eligible compensation for the period. All Company contributions are invested in the same manner that the participant directs their investments. For the year ended December 31, 2024, the Company's matching and safe harbor nonelective contribution was \$8,239,893, net of forfeitures of \$509,595.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings, and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in amounts they contribute to the Plan plus actual earnings thereon. Company contributions vest after two years of service.

##### Forfeitures

If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance is a forfeiture which may be used by the Plan for several purposes. Forfeitures may be used to pay Plan expenses, reduce safe harbor contributions, reduce matching contributions or allocated as discretionary matching contributions.

During the year ended December 31, 2024, forfeitures in the amount of \$509,595 were used to reduce Company contributions of which \$132,672 was used to reduce the 2023 Company safe harbor nonelective contribution deposited in 2024. As of December 31, 2024 and 2023, unallocated forfeitures amounted to \$668 and \$35,682, respectively.

##### Payment of Benefits

Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total benefits in a lump-sum amount equal to the value of the participant's interest in their account, or partial payments. The Plan allows for the automatic distribution of participant account balances that do not exceed \$5,000 and effective January 31, 2024, the Plan was amended to increase this amount to \$7,000.

#### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

##### Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

##### Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

##### Administrative Expenses

Certain administrative expenses incidental to the administration of the Plan may be paid by the Plan, unless otherwise paid by the Company. Administrative expenses paid by the Company are excluded from these financial statements.

Most investment options have fees which reduce the overall return on assets. The net appreciation of investments is reflected net of these fees.

##### Benefit Payments

Benefits are recorded when paid.

##### Subsequent Events

The Plan evaluated subsequent events through October 8, 2025, which is the date that the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements, except as noted below.

Effective January 1, 2025, the Plan Sponsor was changed to ISS STOXX and the Plan was amended to permit installment payments as a form of distribution.

#### **NOTE 3 – FAIR VALUE MEASUREMENT**

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following are a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and, therefore, classified as Level 1 within the valuation hierarchy.

*Self-directed brokerage accounts:* Contain investments in common and preferred stocks, exchange traded funds, money market funds and mutual funds. The common stocks and exchange traded funds are valued at the closing price reported on the active market on which the individual securities are traded. The money market funds and mutual funds are valued in the same manner as noted in the previous paragraph. As such, these investments are classified as Level 1 within the valuation hierarchy.

*Common/collective trust fund:* The fund is valued at the NAV of units of a bank collective trust. The NAV, as provided by the fund’s trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to withdraw from the fund, it is required to provide either 12 or 30 months’ advance written notice to the fund’s trustee prior to redemption of trust units; the notice period may be shortened or waived by the fund’s trustee in its sole discretion. There are no unfunded commitments as of December 31, 2024 or 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, the Trustee, and was not subjected to any auditing procedures performed by the independent public accountants:

- Cash, investments, at fair value and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Cash, investments and participant loans as listed in the accompanying Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the participant’s balance. Such notes bear interest at the prime rate plus one percent and must be repaid to the Plan within a five-year period, unless the note is used for the purchase of a principal residence, in which case the maximum repayment period is fifteen years. A participant may only have one (1) loan outstanding at any time. The specific terms and conditions of such notes are established by the Company. Principal and interest are paid ratably through payroll deductions.

#### **NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments and notes receivable from participants and the related interest income are managed and held by the Trustee. Such transactions, while considered party in interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

Administrative fees paid to the Trustee by the participants through the Plan amounted to \$8,336 for the year ended December 31, 2024. In addition, the Trustee received indirect compensation from the Plan.

The Plan has an agreement with T. Rowe Price Retirement Plan Services Inc. (“TRPRPS”), the Plan’s recordkeeper, whereby TRPRPS provides the Plan a reimbursement of certain expenses charged to the Plan by the Plan’s investments, as defined in the agreement, and the funds are placed in an Administrative Budget Account (“ABA”). The amounts received from TRPRPS may be utilized to pay Plan administrative expenses or be allocated to participants at the discretion of the Company. For the year ended December 31, 2024, no amounts were received from TRPRPS nor were any funds utilized from the ABA. There was no balance in the ABA as of December 31, 2024 and 2023.

#### **NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **NOTE 8 – PLAN TERMINATION OR MODIFICATION**

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its board of directors and is subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in the accounts.

#### **NOTE 9 – TAX STATUS**

The Company adopted a non-standardized pre-approved profit sharing plan that is the subject of a favorable tax opinion letter from the Internal Revenue Service (“IRS”) dated August 19, 2020. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or other taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.
