Scope and Nature of ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the Evergreen Retirement Community, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying 2024 financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTE 1 - Description of the Plan

General

The following description of Evergreen Retirement Community, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's

The Plan is a defined contribution plan under Internal Revenue Code (IRC) section 403(b) covering all eligible employees of Evergreen Retirement Community (the Organization) subject to universal availability. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Investment Committee is responsible for oversight of the Plan. Fiduciary Management Group and Envestnet determine the appropriateness of the Plan's investment offerings, and monitor investment performance as an ERISA 3(21) co-fiduciary and ERISA 3(38) discretionary investment advisor, respectively.

The plan's federal identification number is 39-1081800, and the plan's number is 001.

Eligibility

Employees are eligible to participate in the salary reduction arrangement in the Plan immediately. Employees are eligible for discretionary employer matching and non-elective contributions after completing 1,000 hours of service within their first year of employment or 1,000 hours of service in any succeeding Plan year. To receive an allocation of employer matching and non-elective employer contributions participants must have completed 1,000 hours of service in the Plan year and be employed as the of the last day of the Plan year.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 403(b) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 403(b) contributions to the Plan. Participants are also allowed to make after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a fixed income account as investment options for participants. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain IRS limitations.

The employer matching contribution is equal to 100% of a participant's elective contributions up to 2% of their eligible compensation. The employer non-elective contribution is equal to 4% of the participant's eligible wages. Employer matching contributions for 2024 and 2023 were \$248,527 and \$200,461. Employer non-elective contributions for 2024 and 2023 were \$160,506 and \$135,827.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer matching contribution, an allocation of the employer non-elective contribution, an allocation of Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based upon years of continuous service. A participant is 100% vested after five years of credited service.

A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to two outstanding loans at any given time. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.50% to 9.5%. Notes receivable from participants, net of deemed distributed loans amounted to \$63,507 and \$67,104 as of December 31, 2024 and 2023, respectively.

Plan Loans

Participants may make applications for loans directly with The Lincoln National Life Insurance Company or Empower Trust Company for a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance, less the outstanding principal balance of a previous loan, if applicable. Participants with such loans must maintain a balance in excess of the loan balance in the fixed account during the repayment period of the loan. A participant may only have two outstanding loans at a time.

The loans are not shown in the Plan's statements of net assets available for benefits as the loans are not made from Plan assets and are, therefore, not considered assets of the Plan. During the term of the loan, a portion of the participant's account, equal to the outstanding principal of the loan, plus any interest that has accumulated on that amount, is allocated within the participant's fixed account balance and is considered the loan reserve account. Participants do not have access to these funds during this time and the funds cannot be transferred to other funds. Lincoln National Life Insurance Company loan interest rates were fixed at 7.00%.

As payments are made on the loan, the loan reserve account is reduced by the amount of the payment applied to the principal and the interest is reduced on an annual basis. The loan reserve account is credited with interest at a rate equal to the interest rate on the loan minus 2.50% on the date the loan is issued. At December 31, 2024 and 2023, the loan reserve account was \$38,272 and \$48,794, respectively.

Forfeited Accounts

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$18,280 and \$8,358, respectively. These accounts will be used to reduce future employer contributions. There were approximately \$8,355 in forfeited nonvested accounts used to offset employer contributions in 2024.

Benefits

Amounts contributed may be withdrawn by, or distributed to, a participant only upon (a) termination of employment or (b) attaining age 59½. Withdrawals prior to attaining age 59½ are not permitted except in the event of death, disability, or as hardship distribution. Certain income tax by penalties may apply to withdrawals or distributions prior to age 59½. Upon proof, to the satisfaction of the Plan administrator, of an immediate and substantial financial need, amounts contributed may be withdrawn for a hardship purpose. A mandatory lump-sum distribution may be made if the participant's vested interest in his or her account is \$5,000 or less. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan opted into the hardship distribution provisions of the Bipartisan Budget Act of 2018 which included eliminating the requirement to take a loan before taking a hardship distribution and eliminating the requirement to suspend employee deferrals for six months following the hardship distribution.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value).

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and contract holders. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Payments of benefits are recorded when paid. There were no requested distributions unpaid as of December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. For 2024 and 2023, expenses paid by the plan include investment advisor fees, asset based fees, and fees related to the administration of notes receivable and benefit payments and are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of value of investments.

NOTE 3 -Subsequent Events

These financial statements have not been updated for subsequent events occurring after October 7, 2025, which is the date these financial statements were available to be issued. The plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets in active markets that the plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- > quoted prices for similar assets or liabilities in active markets;
- > quoted prices for identical or similar assets or liabilities in inactive markets;
- > inputs other than quoted prices that are observable for the asset or liability;
- > inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The plan sponsor is responsible for the determination of fair value and accordingly performs periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily closing price and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Guaranteed investment accounts: See Note 5.

NOTE 5 - Investment Contracts with Insurance Company

The Plan has entered into fully benefit-responsive investment contracts with Lincoln Life Insurance Company (Lincoln) and Empower Annuity Insurance Company (EAIC). Both Lincoln and EAIC maintain participant contributions in general accounts and mutual funds. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the general account is carried at amortized cost, or contract value, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract.

Contract value, as reported to the Plan by Lincoln and EAIC, represents contributions made under the contract, plus earnings, less participant withdrawal or transfer of all or a portion of their investment at contract value, which is also the contract's fair value prior to contract termination.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The interest rate is determined by Lincoln and EAIC who reserves the right to change the interest rate at their discretion.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The amount the Plan invested in the guaranteed investment contracts, at contract value was \$1,619,831 and \$1,772,345 as of December 31, 2024 and 2023.

NOTE 6 - Termination of Plan

Although it has not expressed any intent to do so, the Organization has the right under the plan to terminate the plan at any time subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

NOTE 7 - Party-in-Interest Transactions

Plan investments consist of mutual funds, and fixed interest accounts managed by Lincoln Life Insurance Company and Empower Trust Company, LLC. Lincoln Life Insurance Company and Empower Trust Company, LLC are contract holders of the Plan and, therefore, these transactions qualified as party-in-interest transactions. These transactions are not considered prohibited transactions under 29 CFR 401(b) of the ERISA regulation. The Plan paid administrative fees of \$49,529 for the year ended December 31, 2024.

NOTE 8 - Tax Status

In 2021, Empower Retirement acquired Massachusetts Mutual Life Insurance Company. The IRS has determined and informed Massachusetts Mutual Life Insurance Company by letter dated March 31, 2017, that their section 403(b) prototype plan is acceptable under section 403(b) of the Internal Revenue Code (IRC) for use by eligible employers for the benefit of their employees. Although the Plan has been amended since receiving the opinion letter, the prototype sponsor and Plan administrator believe that the Plan was designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and qualifies for exclusion of income for the Plan participants.

NOTE 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024, there were 3 investments which individually represented greater than 10% of investment assets held. There were 4 investments which individually represented greater than 10% of investments held at December 31, 2023.

NOTE 10 - Information Certified by the Plan's Trustee and Contract Holder

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, the trustee, and Lincoln National Life Insurance Company, the contract holders of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024 and 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
