Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Foothill Packing, Inc., 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF PLAN

The following description of the Foothill Packing, Inc., (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Summary Plan Description or Plan document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all full-time employees of the Company who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2009, the plan was amended to allow 401(k) safe harbor provisions.

CONTRIBUTIONS

Each year, participants may make contributions that cannot exceed the lesser of the annual specified maximum allowed by income tax regulations or 100% of pretax annual compensation, as defined in the Plan. Participants direct the investment of their contributions into various investments offered by the Plan. Effective January 1, 2009, the Company instituted a safe harbor contribution equal to 3% of each participant's eligible compensation, and 50% of the next 2% of employee contributions, if any, are matched by the employer.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and Plan earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are vested immediately in their contributions as well as the company's matching contributions in the Plan plus actual earnings thereon.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000. A participant must secure each loan with an irrevocable pledge and assignment of no more than 50% of the non-forfeitable amount of the borrowing participant's accrued benefits under the Plan, other security the trustee accepts and finds to be adequate, or both 50% of the participant's accrued benefits and other security.

The interest rate on the note receivable will be determined from time to time by the trustee and will be fixed throughout the life of the loan. The note principal and any accrued interest must generally be paid within five years from date of disbursement. However, a term greater than five years may be granted by the Administrator under certain circumstances.

PAYMENT OF BENEFITS

On termination of service, participant accounts with vested benefits less than \$5,000 will be distributed in a lump sum. For accounts with vested benefits greater than \$5,000, a participant may elect to receive a single sum distribution or annuity payments of all vested amounts.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

FORFEITURES

The Plan normally has no forfeitures as all accounts are 100% vested at all times.

ADMINISTRATIVE EXPENSES

Administrative expenses recorded in the Plan represent custodial fees and other third-party administration fees paid directly from the Plan to the respective service provider. The Company pays the administrative costs of the Plan associated with any professional services provided to the Plan, and the cost of communications to the participants. Administrative expenses recorded in the Plan represent fees and other recordkeeping fees paid directly from the Plan to the Plan's custodian and administrator. The Plan paid \$124,291 in administrative expenses in 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared using the accrual method of accounting.

NOTES RECEIVABLE FROM PARTICIPANTS

Loans to participants are reported at their unpaid principal balances plus accrued but unpaid interest.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated at fair value except for its guaranteed interest accounts which are valued at contract value with an insurance company. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at the year end.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

NOTE 3 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were accounts managed by Transamerica Retirement Solutions, LLC. Transamerica Trust Company was the custodian of the Plan, and, therefore, these transactions qualified as party-in-interest transactions. In addition, in as much as auditing and plan administration services are paid directly by the Plan, these services are also deemed to be party-in-interest transactions.

Also, certain administrative functions have been performed by the Plan sponsor, Foothill Packing, Inc. There has not been a value calculated for these costs, and therefore the Plan has not been charged for these costs.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants would receive benefits under the Plan based on their vested account balance accumulated to the date of the termination of the Plan. Termination of the Plan could occur before attaining normal retirement age.

NOTE 5 – RISKS AND UNCERTAINTIES

Investments include pooled separate accounts comprised mostly of underlying mutual funds of debt and equity securities (bonds and common stocks). Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Effective January 1, 2009, the Plan was amended to allow 401(k) safe harbor provisions. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 7 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than the quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurement: The fair value is based on quoted prices for identical assets in active markets that are held by the Plan at year end.

Level 2 Fair Value Measurements: The fair value is based on quoted prices of similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and inputs other than quoted prices that are observable for the asset.
