We have performed audits of the accompanying financial statements of the Carmeuse Lime, Inc. 401(k) Plan for Bargaining Unit Employees (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements. In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Carmeuse Lime, Inc. 401(k) Plan for Bargaining Unit Employees (Plan) provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

General - The Plan is a defined contribution plan for certain bargaining unit employees of Carmeuse Lime, Inc. and its subsidiaries (Company) as defined in the Plan Document and was established to encourage and assist employees in adopting a regular savings program to provide for their retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan on the first day of the first payroll period beginning on or after the 60<sup>th</sup> day of employment unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. Participants may create an auto-increase provision program to gradually increase their contribution each year.

Contributions - In general, participants may contribute up to 75% of their compensation to the Plan in any combination of pre-tax and Roth contributions. Combined pre-tax and Roth contributions are subject to a \$23,000 limitation for 2024 under the Internal Revenue Code (IRC). Additionally, Plan participants who are age 50 or older are permitted to make pre-tax and Roth catch-up contributions to the Plan in accordance with federal tax laws and limitations. For 2024, combined pre-tax and Roth catch-up contributions are limited to \$7,500 under the IRC. Catch-up contributions are eligible for employer matching contributions. Employer contributions may include matching contributions in a range of 3% to 6% of compensation, and/or contributions not dependent upon participant contributions in a range of 1% to 3% of compensation. The total employer matching contributions and contributions not dependent upon participant contributions were approximately \$1,755,000 and \$1,122,000, respectively. Employees of two Erie bargaining units and one Savage bargaining unit covered by the Plan do not receive employer contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment election for future contributions or the percentage(s) invested in each of these options, or transfer funds among these options on any business day.

Participants' Accounts - Each participant's account is credited with the participant's contribution, Company contributions, plus his or her pro rata share of earnings or losses based upon account balances. The funds charge investment fees, which are calculated as a percentage of the amount invested in the fund. A participant's account is also charged with expenses related to specific transactions, recordkeeping and/or optional investment advisory services elected by the participant. Each account is separated into participant contributions and employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - All amounts contributed by Plan participants are fully vested and nonforfeitable. Company contributions generally vest over a three-year graded vesting schedule. In addition, a participant will become fully vested upon the attainment of normal retirement age, at death while an employee, or upon total disability, permanent layoff or involuntary entry into military service.

Forfeitures - Forfeitures may be used to reinstate previously forfeited account balances, if any. Any remaining forfeitures may be used to pay the expenses of administering the Plan or to reduce Company contributions, at the discretion of the Company.

Payment of Benefits - Benefits provided by the Plan are paid from assets available for benefits at termination of employment, retirement, disability or other severance from service date as defined in the Plan document. Payment is in the form of a lump-sum payout of the participant's account balance, in installments or partial withdrawals in any amount at any time.

Withdrawals During Service - Unless the applicable collective bargaining agreement provides otherwise, hardship withdrawals are permitted. A participant may also withdraw all or any specified percentage of the current value of his or her after-tax contributions and up to 100% of his or her rollover contributions. In general, a participant who has attained age 59½ may withdraw all or a portion of the vested portion of his or her account at any time. Except for one group of participants, no early withdrawals of Company contributions or pre-tax contributions and earnings thereon are permitted.

Notes Receivable from Participants - Participants may borrow up to 50% of their vested account balance. The minimum loan amounts are \$1,000 and the maximum loan amounts are the lesser of \$50,000 or one-half of the participant's vested balance. A participant is permitted to have up to two loans outstanding. For any new loans beginning January 1, 2019, the Plan was amended to limit the number of loans a participant can have outstanding to one. Loans are required to be repaid, including interest, through payroll deductions, within five years, except those loans used in the purchase of a primary residence. Residential loans have a maximum 15-year repayment period. Loans are secured by the balance in the participant's account and bear interest at the prime lending rate (as reported in the Wall Street Journal, Eastern Edition), on the first day of the month in which the loan is processed plus 1%.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation - The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments consists of realized gains or losses and the unrealized appreciation or depreciation on those investments.

Administrative Expenses - Certain expenses incurred in administering the Plan are paid by the Company, at the discretion of The Retirement Plans Committee of Carmeuse Americas and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions, recordkeeping and optional investment advisory services elected by participants are charged directly to the Plan participant's account and are recorded in administrative expenses. All other investment-related expenses are included in the net appreciation in fair value of investments.

Payment of Benefits - Benefits are recorded when paid.

Net Asset Transfers To Other Company-Sponsored Plans - The Plan presents in the statement of changes in net assets available for benefits the net value of assets transferred into or out of the Plan. Net asset transfers are attributable to participants' accounts transferred between the Plan and two other Company-sponsored defined contribution plans.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN TRUSTEE (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, interest and dividends, interest income on notes receivable from participants and net appreciation in fair value of investments, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity).

NOTE 4 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds and a money market fund managed by Fidelity, the trustee of the Plan. Transactions in such investments qualify as a party-in-interest, which are exempt from the prohibited transaction rules under ERISA. Fees incurred by the Plan for the investment management services of certain Fidelity funds are included in net appreciation in fair value of the investment. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan in whole or in part at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

NOTE 6 - FEDERAL INCOME TAX

The Plan is a non-standardized, pre-approved defined contribution plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the prototype plan is qualified pursuant to the appropriate sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Should the Plan incur penalties and interest related to unrecognized tax benefits, such amounts would be recorded in administrative expenses. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date, giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of inputs that may be used to measure fair value are defined as:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund - Valued at cost, which approximates fair value based on quoted market prices available.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
