Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Ceramicorp, Inc. Employee Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

The following description of the Ceramicorp, Inc. Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was originally established by Falcon Building Products, Inc. effective January 1, 1995. The Plan was originally named the Falcon Building Products, Inc. Employee Savings Plan. Effective as of May 1, 2000, Falcon Building Products, Inc. transferred sponsorship of the Plan to Mansfield Plumbing Products, LLC (the "Company") and renamed the Plan the "Mansfield Plumbing Products, LLC Savings Plan." Effective as of November 30, 2000, the Plan was assumed by Mansfield Plumbing Products, LLC. Effective January 1, 2001, the Company amended and restated the Plan to incorporate recent amendments, legislative changes, and to change the name of the Plan to Mansfield Plumbing Products, LLC Employee Savings Plan. The Company merged the Orchid Ceramics, Inc. 401(k) Plan into the Mansfield Plumbing Products, LLC Employee Savings Plan effective January 2, 2008. Effective on this date, the name of the Plan changed to the Ceramicorp, Inc. Employee Savings Plan. Effective January 1, 2009, the Company restated the Plan to incorporate recent amendments and legislative changes. In 2011, the owners of Orchid Ceramics, Inc. made the decision to cease operations. Effective January 1, 2021, the Company restated the Plan to incorporate recent amendments and legislative changes. The Plan was amended effective December 1, 2024 to now include union employees, and at that time the Mansfield Plumbing Products, LLC Employee Savings Plan for Ohio Hourly Employees merged into the Plan. The Plan is a defined contribution plan covering certain employees of the Company or any subsidiary or affiliate which is a member of its "related group" as defined in the plan agreement. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Employees become eligible to participate in the Plan on the first day of the month coinciding with or next following date, following three months of eligible service.

Contributions

Participants may elect to defer from 2% up to 50% of their compensation as defined by the Plan on either a pre-tax, after-tax, or Roth basis. The Plan also provides for catch-up contributions for participants who reach the age of 50 by the end of the Plan year. Effective January 1, 2024, the Plan includes a traditional Automatic Contribution Arrangement in which employees hired or rehired after the effective date, are automatically enrolled the first day of the month following three months of employment. Unless otherwise directed by the participant, 4% of compensation is withheld and invested in qualified default investment alternatives. The deferral amount will escalate at the rate of 1% each year to a maximum deferral of 15%. The Plan provides for a discretionary employer matching contribution for each participant, which was 50% of the first 3% of annual compensation (as defined by the Plan) that a participant contributed to the Plan for the year ended December 31, 2024. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code ("IRC"). Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Note 1. Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's own contributions and an allocation of any Company contributions and Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their individual accounts between several different investment options offered by the Plan.

Vesting

Participants are 100% vested in their account upon entrance date.

Payment of Benefits

On termination of service or due to death, disability, retirement, or attainment of age 59½, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Active participants may make hardship withdrawals of the employee contribution portion of their account balances, subject to Plan provisions, in-service distributions upon attaining age 59½, and rollover contributions which can be distributed at any age and at any time, but the minimum withdrawal amount is \$500.

Inter-Plan Transfers

From time to time, changes in employee status require the transfer of participation between Ceramicorp, Inc. Employee Savings Plan and Mansfield Plumbing Products, LLC Employee Savings Plan for Ohio Hourly Employees. In connection with the Plan merger, transfers from the Mansfield Plumbing Products, LLC Employee Savings Plan for Ohio Hourly Employees were \$4,879,767 for the year ended December 31, 2024.

Termination Provisions

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Notes Receivable From Participants

A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance with the minimum loan amount of \$1,000. Loans are secured by the balance in the participant's account. Loans are repayable through payroll deductions over periods ranging up to 60 months or longer when the loan proceeds are used to purchase a primary residence. The interest rate is fixed and will be equal to the Prime Rate (as published in The Wall Street Journal on the day the loan is initiated), plus 1%.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at the fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor and John Hancock Trust Company, the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits

Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies (Continued)

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and loans are charged directly to the participant's account and are included in administrative expenses. Participant accounts are also charged a quarterly fee that is included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Administrative expenses may be offset with funds made available by the Plan Trustee from fees it received from investment fund managers. Service credit amounting to \$87,336 was received and used to offset administrative expenses for the year ended December 31, 2024.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and March 15, 2024, respectively.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

Note 3. Unaudited Information

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from John Hancock Trust Company, the Trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1: Quoted prices in active markets for identical assets and liabilities
- Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3: Unobservable inputs in which little or no market data exists

Note 4. Fair Value Measurements (Continued)

The following is a description of the valuation methodology used for assets of the Plan measured at fair value at December 31, 2024 and 2023:

- Mutual funds: Investments in mutual funds are valued based on their quoted closing market prices in active markets for identical investments and are classified as Level 1.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodology used from 2023 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Fully Benefit-Responsive Investment Contracts

The Plan holds a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to a contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan holds a direct interest in a fully benefit-responsive investment contract through its investment in the Anchor Account II, which is a group annuity contract (Stable Value Fund ("SVF")) managed by New York Life Insurance Company ("NYLIC"). Contributions to the contract are deposited into a guaranteed separate account of NYLIC, which is a participating stable value separate account that is not unitized, and the assets of the separate account are accounted for at amortized cost. There are no reserves against contract value of the issuer or otherwise.

Note 5. Fully Benefit-Responsive Investment Contracts (Continued)

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances may include a partial plan termination, mergers, spin-offs, layoffs, early retirement incentive programs, sales, or closings of all or a portion of the Plan sponsor's operations, bankruptcy, or receivership, if these events would lead to a request for payments of more than 10% of the Plan's value in the fund. The contract does not limit the circumstances under which the issuer may terminate the contract. At contract termination, the Plan may receive a book value distribution of the Plan's interest in the SVF, provided a twelve months' advance written notice is given to NYLIC. Distributions resulting from terminations initiated without providing twelve months' advance written notice will be subject to a market value adjustment pursuant to the provisions of the SVF contract, provided a minimum of thirty days' written notice is given. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

Note 6. Party-in-Interest Transactions

The Plan holds shares of a mutual fund, which is managed by John Hancock Investment Management, LLC. As John Hancock Investment Management, LLC is affiliated with the Trustee of the Plan, this investment and its transactions qualify as party-in-interest transactions. In addition, administrative expenses were paid to the Trustee during the year ended December 31, 2024.

Note 7. Income Tax Status

The IRS has previously ruled in an opinion letter, dated June 30, 2020, that the pre-approved document on which the Plan is based is designed in accordance with the applicable sections of the IRC. The Plan has been amended since adopting the pre-approved document. However, the plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 8. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
