## INDEPENDENT AUDITORS' REPORT

To the Trustee  
Furlani Foods, LLC Savings & Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Furlani Foods, LLC Savings & Retirement Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of February 14, 2025, December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the period / years then ended, and the related notes to the financial statements - modified cash basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the period / years ended February 14, 2025, December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 1.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 1, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 1.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

#### **Other Matter - Basis of Accounting**

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements were prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

#### **Other Matter - Plan Merger**

As described in Note 1 to the financial statements, effective January 28, 2025, the plan sponsor elected to merge the plan into the Successwise Pooled Employer Plan. As a result, all net assets of the plan were transferred to the Successwise Pooled Employer Plan by February 14, 2025.

#### **ERISA-Required Supplementary Information**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. ## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The accompanying financial statements have been prepared on the modified cash basis of accounting. Under that basis, certain additions and the related assets were recognized when received rather than when earned and certain deductions were recognized when paid rather than when the obligation was incurred. That basis differs from accounting principles generally accepted in the United States of America ("GAAP") primarily because the plan has not recognized contributions receivable and the related effect on changes in net assets in the accompanying financial statements.

**Accounting estimates** - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Plan merger** - Effective January 28, 2025, the plan sponsor elected to merge the plan into the Successwise Pooled Employer Plan. As a result, all net assets of the plan were transferred to the Successwise Pooled Employer Plan by February 14, 2025.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to February 14, 2025 through October 7, 2025, which is the date the financial statements were available to be issued.

**Key parties of the plan** - Furlani Foods, LLC was the plan sponsor, employer, and the plan administrator. One officer of Furlani Foods, LLC was the trustee. Minnesota Life Insurance Company ("Minnesota Life") was the investment agent and custodian of plan assets. StanCorp Financial Group, the parent of Minnesota Life, was the third-party administrator that maintained participant records and tax counsel that performed various compliance tests. MPC Advisors was the investment advisor.

**Investments** - The plan sponsor determined the investments available to plan participants. The participants allocated their contributions and transferred existing balances among the available investment options. Participants should refer to the investment account summaries and prospectuses for more information.

At the end of each business day, Minnesota Life determined the value of the investments and allocated the value to the participants. The net appreciation (depreciation) in the values of the investments, including investments bought, sold or held during the period / years, are reflected in the accompanying statements of changes in net assets available for benefits - modified cash basis.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

**Pooled separate accounts** - The pooled separate accounts were direct filing entities valued at the net asset value ("NAV") based on units of the pooled separate accounts. The NAV, as provided by Minnesota Life, was used as a practical expedient to estimate fair value. The NAV was generally based on the fair value of the underlying investments held by the pooled separate account less their liabilities. This practical expedient would not be used if it was determined to be probable that the pooled separate account would sell the investment for an amount different than the reported NAV.

**Investment at contract value** - The plan had a fully benefit-responsive investment contract through a group annuity contract issued by Minnesota Life. The Guaranteed Return Account invested directly in the general assets of Minnesota Life. These general assets were predominantly invested in high quality fixed income investments. The interest rate credited was agreed upon each quarter, but may not have been less than 1.5%.

The contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investments contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Minnesota Life, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of the investment at contract value.

The contract did not have a maturity date and there were no contract provisions that required a distribution at contract value at any specified time. There was no market value adjustment from contract value deducted from plan assets at the time of liquidation.

### 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

**General** - The plan was adopted effective August 1, 1999 as a defined contribution plan with a 401(k) salary deferral arrangement. It was subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees were eligible to contribute to the plan once they had completed twelve months of service and attained age 21. An employee was allowed to enter the plan on the January 1, April 1, July 1 or October 1 entry date immediately following the date the plan's eligibility requirements were met. Effective January 1, 2024, an employee was allowed to enter the plan on the first day of the month immediately following the employee meeting eligibility requirements.

**Contributions** - Contributions to the plan could be made as follows:

- a. Participants could contribute a percentage of their compensation subject to certain limitations (employee elective deferral contributions). Effective January 1, 2024, the plan also permitted Roth elective deferral contributions. Participants had the option to enroll in an auto-escalation feature under which their deferral percentages automatically increased by 1% each year until they reached a maximum of 10%. Such participants had the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions were accepted by the plan from other qualified plans.
- c. Employer discretionary matching contributions could be made, which were equal to 20% of an employee's elective deferral contribution up to 5% of compensation in 2025, 2024 and 2023.
- d. Employer safe harbor matching contributions were made equal to 100% of the first 3% of compensation that a participant contributed to the plan and 50% of the next 2% of compensation that a participant contributed to the plan. Contributions for 2024 were funded to the Successwise Pooled Employer Plan in 2025. Contributions for 2023 totaling \$228,000 were funded to the plan in 2024. Contributions for 2022 totaling \$209,000 were funded to the plan in 2023.
- e. Employer discretionary nonelective contributions can be made at the employer's discretion. There were no such contributions in 2025, 2024 or 2023.

**Participant accounts** - Each participant's account was credited with their elective deferral contributions and an allocation of the company's contributions. Earnings, including the fair value appreciation or depreciation, were allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Participants were allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

**Vesting** - Participant elective deferral contributions, employer safe harbor contributions and related earnings were immediately 100% vested. Employer discretionary matching and nonelective contributions vested 20% after one year of service and 20% each subsequent year until fully vested after five years of service, or became fully vested upon death or total and permanent disability or attainment of normal retirement age while employed.

**Payment of benefits** - Benefit payments were made in one lump sum cash payment or partial withdrawals after retirement, death, disability or termination of employment. Hardship withdrawals were permitted under certain circumstances. In service distributions of vested balances could have been made upon attainment of age 65, normal retirement age.

**Notes receivable from participants** - Participants could take out loans against their accounts with the approval of the plan administrator. The minimum loan amount was \$1,000 and the maximum amount was the lesser of one-half of the participant's vested account balance, or \$50,000. Participants could not have more than one loan outstanding at any given time. The repayment term generally could not exceed 5 years except when the loan was for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had repayment schedules through November 2028 with interest rates ranging from 4.04% to 10.50%. The notes receivable from participants were valued at their unpaid principal balances plus any accrued but unpaid interest, which approximated fair value. All loan balances were paid in full prior to the plan assets being transferred to the Successwise Pooled Employer Plan in 2025.

**Forfeitures** - Forfeited nonvested accounts were used to reduce employer contributions or pay administrative fees. Forfeitures used in 2025, 2024 and 2023 were insignificant. There were no unapplied forfeitures as of February 14, 2025. Unapplied forfeitures as of December 31, 2024 and 2023 were insignificant.

**Administrative fees** - Certain administrative fees of the plan were paid by the employer. Certain other administrative fees were paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses included participant directed charges for loan and distribution fees and charges for terminated participants with account balances.

### 3. PARTY-IN-INTEREST TRANSACTIONS

The plan investments were managed by Minnesota Life. Minnesota Life was the investment agent and as such, these transactions qualified as party-in-interest transactions. Direct fees paid by the plan to Minnesota Life were \$4,000, \$5,000 and \$6,000 in 2025, 2024 and 2023. Minnesota Life also provided certain administrative services to the plan pursuant to a service agreement between the plan sponsor and Minnesota Life. Minnesota Life received revenue from mutual fund service providers for services Minnesota Life provided to the funds. This revenue was used to offset certain amounts that would have otherwise been owed by the plan to Minnesota Life for its administrative services to the plan.

Notes receivable from participants also qualified as party-in-interest transactions.

All of the above party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

### 4. INCOME TAX STATUS

The plan adopted a Minnesota Life Insurance Company pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator had not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believed the plan was designed and was operating in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believed the plan was qualified, and the related trust was tax-exempt.

GAAP required plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of February 14, 2025, December 31, 2024 and 2023. The plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits in progress.


