Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Kaspar Companies & Affiliates 401(k) Savings Plan (formerly Kaspar Wire Works, Inc. 401(k) Profit Sharing Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

As discussed in Note B to the financial statements, effective November 1, 2024, the Plan changed its name from Kaspar Wire Works, Inc. 401(k) Profit Sharing Plan to Kaspar Companies & Affiliates 401(k) Savings Plan. The financial statements as of December 31, 2023, and for the year then ended, reflect the former name.

NOTE A – SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The audited financial statements of Kaspar Companies & Affiliates 401(k) Savings Plan (the Plan) are maintained on the accrual basis in accordance with U.S. generally accepted accounting principles.

Investment Valuation and Income Recognition: Investments in mutual funds and self-directed brokerage accounts are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Guaranteed interest contract is measured at contract value.

Participant' Notes Receivable: Participants' notes receivable are stated at their unpaid principal balance plus accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make a loan repayment and the Plan administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment to the participant is recorded.

Payment of Benefits: Benefits are recorded when paid.

Excess Contributions: Excess contributions represent an amount to be refunded to certain participants as a result of the annual discrimination testing required by ERISA. The balance is paid to the participant within two and a half months of the Plan year end.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report, which is the date the Financial Statements were available to be issued. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

NOTE B – PLAN DESCRIPTION

The following description of Kaspar Companies & Affiliates 401(k) Savings Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering virtually all employees who have 30 days of service with the Company. The Plan is for the exclusive benefit of participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants may enroll in the plan on the first day of the month following eligibility.

Plan Amendment: Effective November 1, 2024, the Plan name changed from Kaspar Wire Works, Inc. 401(k) Profit Sharing Plan to Kaspar Companies & Affiliates 401(k) Savings Plan. The trust also changed its name from Kaspar Wire Works, Inc. 401(k) Profit Sharing Trust to Kaspar Companies & Affiliates 401(k) Savings Trust, and Empower Trust Company, LLC will serve as the directed trustee. No other amendments were made to the Plan in 2024 or 2023.

Plan Sponsor: The Plan is sponsored by Kaspar Wire Works, Inc. for the benefit of its employees, and has been adopted by Kaspar Die and Tool, Inc.; Kaspar Electroplating Corporation; Kaspar Properties, Inc.; Sho-Rack Service Center, Inc.; Kaspar Texas Traditions, Kaspar Land Traditions, LP; Texas Precious Metals LLC; PM Web Assets LLC; Trailboss Equipment, LLC; Espresso LLC; Kaspar Companies, Inc; Truckfitters LLC; Ratliff Traditions, LLC; Texas Ammunition LLC; Kaspar Trucking LLC; and Welhausen Legacy LLC. Collectively, the Sponsor and adopting employers are referred to as the "Company" or "Employer".

Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants remain 100% vested in their accounts.

Contributions: Participants may contribute to the Plan as allowed by the Internal Revenue Code and the Plan. Participants may also contribute amounts representing distributions ("rollovers") from other qualified plans. The employer may contribute to the Plan each year a discretionary amount, which is allocated to all employees who participated in the Plan. There were no discretionary employer contributions in 2024 or 2023.

Participant Accounts: Each participant's account is credited with their contribution and allocations of a) the Plan Sponsor contributions, b) Plan earnings, and c) charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are one hundred percent (100%) vested at all times in both their contributions and the employer's voluntary contributions.

Investment Options: Upon enrollment in the Plan, a participant may change their investment option daily and direct employee contributions in 1% increments in several investment options.

Participants' Notes Receivable: Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from one to five years. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator. Principal and interest is repaid by payroll deduction.

Payment of Benefits: Payment of the vested account balance will begin no later than the sixtieth day after the end of the year during which the participant reaches normal retirement age, dies or terminates employment, whichever is later. If the total vested account balance is less than \$7,000, the participant will receive a single lump sum payment. If the vested account balance is equal to or greater than \$7,000, various payment options are available and are described more fully in the Plan agreement. Hardship withdrawals are available to the plan participants upon approval by the Plan Committee. At December 31, 2024 and 2023, there were no vested benefits allocated to participants who had withdrawn from participation.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor 29 CFR 2520.103-8, investments and participants' notes receivable at December 31, 2024 and 2023, the related investment earnings and interest on participants' notes receivable for the years then ended, were certified and held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Trustees, and were not audited by the independent auditor.

NOTE D – FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used during the year, nor were there any transfers among levels. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued based on quoted prices in an active market.

Self-Directed Accounts: Consists primarily of mutual funds valued at quoted prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – GUARANTEED INTEREST CONTRACT

The Key Guaranteed Portfolio Fund, with a balance of \$837,692 and \$1,189,245 at December 31, 2024 and 2023, respectively, represents a benefit-responsive interest contract entered into with the Trustee. The Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTE E – GUARANTEED INTEREST CONTRACT - continued

Because the guaranteed interest contract is fully benefit-responsive, it is stated at contract value, the amount the participant would receive if they were to initiate permitted transactions under the plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. For example, premature termination of the contracts by the Plan, Plan termination, bankruptcy, mergers, and failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any event which would limit the Plan's ability to transact at contract value with participants is probable of occurring.

NOTE F – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments.

NOTE G – INCOME TAX STATUS

The Plan is a pre-approved profit-sharing plan developed by Empower. The pre-approved profit-sharing plan has received a favorable opinion letter from the Internal Revenue Service. Although the plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the plan is qualified for tax exempt status. The Plan is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

NOTE H – SECURE 2.0 ACT

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2025 and later.
