Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of John C. Grimberg Co. Inc, 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the John C. Grimberg Co. Inc, 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Adoption Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of John C. Grimberg Co., Inc. (the "Company") not covered by a collective bargaining agreement. An eligible employee is defined as one who has completed one year of service, has worked at least 1,000 hours in a consecutive 12-month period, and is age 21 or older. Participants may enter the Plan January 1 or July 1 following eligibility. Employees who meet the aforementioned requirements are also eligible for employer discretionary matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Administration

The Plan is administered by the Company. The Company has executed a contract with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company to serve as the Plan's investment custodian and perform certain administrative duties on behalf of the Plan Administrator.

Contributions

Each year, participants may contribute up to the annual limit defined by the Internal Revenue Code ("IRC"). Participants may elect to make pre-tax deferrals or Roth 401(k) contributions to the Plan. Participants that have attained the age of 50 before year end are eligible to make additional pre-tax elective deferrals to the plan (catch-up contributions). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

For each Plan year, the Company may make matching contributions at its discretion. For the Plan year ended December 31, 2024, the Company made matching contributions in an amount equal to 50% of the participant's contribution, limited to a maximum of 4% of the participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, matching contributions from the Company, if any, and an allocation of the Plan's net earnings and charged with benefits paid and an allocation of administrative expenses, if any. Allocations of the Plan's earnings and administrative expenses are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in contributions made by the Company, plus actual earnings thereon, is based on years of service. A participant vests at a rate of 20% per year after two years of service and is 100% vested after six years of credited service. A participant is fully vested upon reaching normal retirement age, death, disability, or termination of the Plan.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. There were no amounts allocated to withdrawing participants that were requested by the participant prior to December 31, 2024, but not yet paid as of that date. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a IRA rollover. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

Forfeitures are retained in the Plan and used to pay administrative expenses and reduce future employer contributions. For the year ended December 31, 2024, forfeitures of \$3,090 were used to fund employer contributions. As of December 31, 2024 and 2023, the balance in the Plan's forfeiture account totaled \$0.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by any outstanding loan balance, or reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. Principal and interest are paid ratably through payroll deductions. Note terms are up to five years. Five notes per participant may be outstanding at a time. The notes are secured by the balance in the participant's account, and the interest rate will be based on the rates available for similar loans from commercial lending institutions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV") which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make their loan repayments and the administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2024 through October 13, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

Mutual Funds: Valued at their published net asset value ("NAV") per share. Funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Investments Measured at Net Asset Value: Consisting of pooled separate accounts ("PSA"), valued at the net asset value ("NAV") of units of the underlying investments. NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the PSA, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Insurance Company General Accounts: valued at fair value, based on contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates. GICs provide a guaranteed interest rate for a specified period of time as determined, or allowed, by the Plan sponsor's retirement plan. The rate credited is the rate in effect on the day when each deposit is directed to the account. To simplify reporting to Plan participants, all rates credited during the 12-month 'deposit year', which is often the same as the Plan year, are averaged into a single composite rate. The Plan sponsor chose the 12-month period for the deposit year.

Reports, expenses, and guarantee periods are based on deposit years. GICs promise contract value for a benefit event (termination, death, disability and retirement); however, there is a possible surrender charge when funds are withdrawn prior to their maturity. Thus, the contracts are considered not benefit responsive. For these contracts, most participants and Plan sponsor transactions that occur prior to maturity are realized at an adjusted contract value that takes into account the current rates of interest available in the marketplace for similar GICs. Therefore, for these GICs, the contract value adjusted by the early withdrawal charge is a proxy for fair value.

The interest rates for the guaranteed investment contract ranged from 0.14% to 4.40% at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by the custodian, and therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Additionally, the Plan issues loans to participants, which are secured by the participants' account balances and has a revenue sharing agreement (see Note 2). These transactions qualify as party-in-interest transactions.

5. Information Certified by Custodians

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company, the Custodians of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

The Plan adopted a prototype plan offered by Principal Life Insurance LLC. The prototype plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt. Accordingly, no provision for income taxes has been included in the financial statements.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognitions of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there have been no tax related interest or penalties for the periods presented in these financial statements.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, four investments represented a concentration of greater than 10% of the Plan's net assets available for benefits.
