The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). **Basic Financial Statement**

Plan expenses were \$60,763. These expenses included \$28,529 in administrative expenses and \$32,234 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 17 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$2,557,357 as of the end of the plan year, compared to \$1,558,291 as of the beginning of the plan year.
