Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of LocalTel Communications 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - GENERAL INFORMATION

A. General

The Plan is a defined contribution plan in accordance with Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees of Computer 5, Inc. dba LocalTel Communications (the Plan Sponsor) who are not excluded employees for purposes of the Plan. Excluded employees include union employees whose employment is governed by a collective bargaining agreement and nonresident aliens. Provided an employee is not an excluded employee, an employee will be immediately eligible to make salary deferrals and participate in the Plan Sponsor's matching contribution; and discretionary profit sharing contribution upon reaching 21 years of age and completed one year of service of at least 1,000 hours. This description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

B. Contributions

Participants may contribute up to the maximum percentage allowable by the applicable IRC of pretax annual compensation, up to a maximum of \$23,000 as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor matches 100 percent of the first 4 percent of base compensation that a participant contributes to the Plan. The matching contribution is invested as directed by the participant. Additional profit sharing amounts may be contributed at the option of the Plan Sponsor.

C. Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon as well as the Plan Sponsor's match. Participants become 100 percent vested in the Plan Sponsor's discretionary contribution after six years of service.

E. Notes receivable from participants

The Plan allows participants to borrow up to 50% of the vested balance of their account, up to a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

E. Notes receivable from participants (continued)

The term of the loan is generally five years, but can be longer if the loan is used for the purchase of a principal residence. In the event of termination of employment, loan balances and accrued interest shall be deducted from the amount of the distribution.

Based on the Plan administrator's assessment of the outstanding balance of notes receivable from participants in comparison to the secured balance of the vested participant account, an allowance for doubtful accounts is not considered necessary.

F. Payment of benefits

On termination of service due to disability, retirement or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in their account. Distribution as a result of death must be completed by the 5th anniversary of the date of death.

G. Forfeited accounts

Upon a participant's termination from the Plan, nonvested account balances are forfeited and used to reduce future employer contributions or to pay any administrative expenses. For the year ended December 31, 2024, the Plan incurred \$0 in forfeitures. The balance of unused forfeitures at December 31, 2024 was \$0.

H. Plan termination

The Plan was terminated on September 30, 2024 (see Note 6).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of accounting

The financial statements of the Plan are prepared utilizing the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

B. Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

C. Investment valuation and income recognition (continued)

Money market mutual funds held with brokers are considered to be investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

D. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

E. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

F. Payment of benefits

Benefits are recorded when paid.

G. Plan expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - INVESTMENTS

During 2024, the Plan's investments (including interest, dividends and gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$1,302,513.

NOTE 4 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by John Hancock Life Insurance Company, the custodian of the Plan's assets, therefore, these transactions qualify as party-in-interest transactions.

NOTE 5 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The guaranteed interest accounts are an investment option offered under the John Hancock group annuity contract. Contributions are held in the John Hancock general account, which guarantee the return of principal, plus compound interest earned over a defined period, 3, 5 or 10 years, less any contract or participant level expenses, provided all contributions remain in these accounts until the end of the guaranteed period. Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed account in that month. There is no minimum interest rate, and the account is not fully benefit responsive. At the end of each reporting year, a composite rate of interest is determined for each participant account, depending on the amount contributed and the rate in effect on the day it's allocated under the participant account. The composite rate is the effective annual rate earned by all contributions to the guaranteed account during the respective reporting year for that participant. Contributions continue to earn the calculated composited interest rate for the duration of the guaranteed term.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - PLAN TERMINATION

On September 30, 2024, the Plan's sponsor terminated employment of the participants as a result of a transaction. All employees became employees of the acquiring company, and the Plan was terminated. Employees electing distributions were allowed to do so, otherwise, their assets were rolled into the acquiring company's plan. In accordance with the plan document and ERISA requirements, all affected participants became 100% vested in their accrued benefits as of the plan's termination date. Plan assets were fully distributed to the affected participants before the end of the year.

NOTE 7 - INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined, and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021, which is the standard statute of limitations look-back period. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investments options, including mutual funds. The underlying investment securities in the mutual funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and investment contracts and the level of uncertainty related to changes in the value of the investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.


