Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Corporate Source, Inc. 401(a) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

1. DESCRIPTION OF PLAN

The following description of The Corporate Source, Inc. 401(a) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Internal Revenue Service (“IRS”) Code Section 401(a) that was established effective September 1, 2016. The Plan was most recently restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for oversight of the Plan.

The Plan covers all eligible employees of The Corporate Source, Inc. (the “Organization”) Employees are eligible to participate in prevailing wage contributions immediately upon hire. Temporary employees and employees covered by The Corporate Source, Inc. PR 401(k) Plan (the “PR Plan”) are excluded from the Plan's prevailing wage contributions. Employees who participate in the PR Plan have their prevailing wage contributions remitted to the PR Plan.

To participate in non-elective contributions, employees must complete one year of service, as defined. Employees eligible for nonelective contributions include all employees except union employees, leased employees, and employees who are non-resident aliens, and temporary employees.

Contributions

Participant contributions to the plan are not permitted. Rollover contributions are permitted in accordance with Plan provisions. Participants may be eligible for one or more of the various types of employer contributions as defined in the plan document. The following types of contributions were made into the plan during the year:

Non-Elective Contribution

In connection with the January 1, 2022 restatement, the previous discretionary profit sharing contribution was replaced with a non-elective contribution equal to 3% of compensation. Generally, the participant must work 1,000 hours during the year and be employed on the last day of the year to receive a contribution. An additional percentage of compensation may be declared and allocated for the plan year at the discretion of the Organization's Board of Trustees. These amounts are funded annually. For the year ended December 31, 2024, the Organization declared an additional 2% contribution and made a \$677,283 non-elective contribution to the Plan, net of forfeitures.

Prevailing Wage Contribution

The Organization may make a prevailing wage contribution to the Plan. The prevailing wage contribution shall be an amount equal to the fringe benefit payment amount as specified under the McNamara-O'Hara Service Contract Act (or similar contracts which utilize fringe rates) after appropriate deductions (i.e., health and welfare benefit-related amounts) and will reduce any other employer contributions made on behalf of a participant eligible for a prevailing wage contribution. These amounts must be funded at least quarterly. For the year ended December 31, 2024, the Organization made \$857,483 prevailing wage contribution to the Plan.

Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with an allocation of the Organization's contributions, as defined by the Plan document, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct their accounts into various investment options offered by the Plan. If no election is made by the participant, then the contributions are automatically invested in the Plan's Qualified Default Investment Alternative ("QDIA"). The Plan has elected the Vanguard Target Retirement Fund series as its QDIA.

Vesting

Participants are always 100% vested in their prevailing wage contribution account and rollover contribution accounts plus actual earnings thereon.

Participants' vesting in their non-elective contributions account is based on years of service as follows:

A participant will become 100% vested in their non-elective contributions account if their employment is terminated as a result of death or disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The interest rate on outstanding loans range from 4.25% to 9.50% per annum. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive to receive a lump sum equal to the value of the participant's vested interest in his or her account. Participants shall be entitled to receive in-service withdrawals upon attainment of age 59 ½.

The Plan also permits specified age and service in-service withdrawals. These withdrawals are allowed upon attainment of age 40 and 10 years of participation and have a total age plus years of participation equal to at least 60. These in-service withdrawals may only be transferred to an individual retirement account (IRA) in the Participant's name.

Plan Expense Account

At December 31, 2024 and 2023 the plan expense account totaled \$5,383 and \$6,491, respectively. The plan expense account includes revenue sharing paid back to the Plan's account and other allocations paid back to reduce plan expenses. During the year ended December 31, 2024, the Plan earned \$65,320 and paid \$60,145 in administrative expenses from the plan expense account to CapFinancial Partners, LLC, d/b/a CapTrust Financial Advisors ("CapTrust"). For the year ended December 31, 2024, the Plan used \$6,491 to allocate to participants.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$44,653 and \$50,215, respectively. The Organization uses forfeited amounts to reduce employer contributions or administrative expenses of the Plan. For the year ended December 31, 2024, \$50,215 in forfeitures were allocated to participants and \$0 were used to pay Plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from the Organization are based off compensation paid to Plan participants during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

3. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value, investments at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York ("Empower Life") and Empower Trust Company, LLC, the insurance company and custodian of the Plan, respectively.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth, by level within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

5. INVESTMENT CONTRACT WITH EMPOWER LIFE

In September 2016, the Organization entered into a fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company of New York (now called Empower Life). Empower Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$85,957 and \$101,037, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower Life. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the organization or other organization events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Either Empower Life or the Organization may terminate this Contract with advance written notice to the other party. The contract termination date shall be the seventy-fifth day after the date written notice is received.

6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Empower Life is the recordkeeper, insurance company and custodian of the Plan for the year ended December 31, 2024, therefore certain transactions qualify as exempt party-in-interest transactions. Administrative fees of approximately \$60,800, were paid to Empower Life during the year ended December 31, 2024.

The Organization has a retirement plan advisory service agreement with CapTrust, which provides investment advisory services to the Plan, therefore certain transactions qualify as exempt party-in-interest transactions. The service agreement calls for a fixed fee to be paid on a quarterly basis for advisory services provided to the Plan. Advisory fees of approximately \$65,700 were paid to CapTrust during the year ended December 31, 2024.

JM Pension Advisory, Inc. (“JM Pension”) is the third party administrator of the Plan for the year ended December 31, 2024 therefore, certain transactions qualify as exempt party-in-interest transactions. Administrative fees of approximately \$2,400 were paid to JM Pension during the year ended December 31, 2024.

Empower Advisory Group, LLC (“Empower Advisory”), a subsidiary of the recordkeeper, is an investment advisor of the Plan for the year ended December 31, 2024 therefore, certain transactions qualify as exempt party-in-interest transactions. Administrative fees of approximately \$1,400 were paid to Empower Advisory during the year ended December 31, 2024.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

8. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
