## Independent Auditor's Report

### Opinion

**1) Description of Plan**

The following description of the New Mexico Orthopaedic Associates, P.C. (the “Company”) Defined Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined benefit pension plan covering all employees of the Company who have completed one year (at least 1,000 hours) of service and have attained the age of 20.5. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Employee contributions are not permitted by the Plan. Required contributions to the Plan are made by the Company, as determined by an independent actuarial firm’s calculated required annual contributions.

Vesting

Participants are 100% vested upon initial enrollment in the Plan.

Pension Benefits

Participants are 100% vested and entitled to pension benefits beginning at the normal retirement age of 65. The amount payable to participants is equal to the amount of the participant’s accrued benefit, as defined by the Plan. Benefits are payable in six different options outlined in the Plan. A participant who terminates employment prior to normal retirement date is entitled to a benefit payable in an amount equal to his or her accrued benefit.

Death Benefits

If an active employee dies while still employed by the Company, a death benefit equal to the actuarial equivalent of the accrued benefit determined as of the anniversary date will be paid to the participant’s beneficiary subsequent to or coinciding with the date of death.

Benefit Payments

If the pension benefit is \$5,000 or less, the funds will be distributed in the form of a lump-sum distribution. For benefits over \$5,000, participants will receive an annuity equal to their vested accrued benefit, unless a lump-sum payment option is elected.

**2) Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Valuation of Investments

The Plan's investments are stated at fair value. Quoted market prices are used to value investments when available. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Annuity policies are stated at cash surrender value which approximates fair value. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results may differ from those estimates.

Benefit Payments

Benefits are recorded when paid.

Funding Policy

The Company's funding policy is to make contributions to the Plan in amounts such that all employee benefits will be fully provided for by the time the employee retires. During 2024 and 2023 the Company made contributions of \$2,928,000 and \$3,062,000, respectively. The Company's contributions for 2024 and 2023 exceeded the minimum funding requirements of ERISA.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided in the Plan document. In 2024 and 2023, some, but not all expenses were paid by the Plan.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died and (c) present employees or their beneficiaries. Benefits payable under all circumstances such as, retirement, death, disability, and termination of employment are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by the independent actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discussion for interest), and the probability of payment (by means of decrements such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuation as of December 31, 2024 and 2023 are as follows:

Date of Management's Review

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

3) **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (the "PBGC") if the Plan terminates. Generally, the PBGC guarantees most vested normal retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, PBGC does not guarantee all types of benefits under covered plans, and the amount of benefit protection is subject to certain limitations.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Company and the level of benefits guaranteed by PBGC.

4) **Tax Status**

The Plan obtained its latest determination letter on March 30, 2018, which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirement of the Internal Revenue Code.

Plan administration has evaluated its tax positions taken for all open tax years. Plan administration believes there are no uncertain tax positions related to Plan activities. The Plan is subject to routine audits by taxing jurisdictions for the last three years. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

The Plan's investments (including gains and losses on investments bought, sold, and held during the year) appreciated in value by approximately \$844,000 and \$2,596,000 for the years ended December 31, 2024 and 2023, respectively.

**6) Fair Value Measurement**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were applicable to the Plan.

**8) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change.

**9) Party-in-Interest Transactions**

Plan investments include shares of registered investment company and money market funds managed by Charles Schwab. Charles Schwab was the investment custodian for certain plan assets, and therefore, transactions with this entity may qualify as party-in-interest transactions.

The interest rates and mortality assumptions have been updated as required under the Pension Protection Act, all subsequent legislation, and associated IRS Regulations, including the changes presented by the American Rescue Plan Act of 2021. These changes resulted in an increase in the Funding Target and the Target Normal Cost.

Consistent with past practice, we have prepared ASC 960 results using the same methods and assumptions as the Funding Target. Typically these results would use a discount rate equal to the long term expected return on trust assets and a more current mortality table.

To better reflect anticipated plan experience, the administrative expense load added to the Target Normal Cost was changed from \$37,000 for 2023 to \$54,000 for 2024.
