Form 5500 – Manual Signing Procedure

A Guide for Your Reference

1. Complete Form 5500 and related schedule or Form 5500-SF as appropriate.
 - Be sure to check for errors and correct any the system finds.
2. Send the client a copy of the Form 5500 and an E-Signature Authorization form.
 - The client should sign as the plan administrator.
3. Once the client returns a signed copy of both forms, scan the forms separately and save them in the final reports folder in the applicable plan year end.
4. In Pension Reporter, open your plan and select Electronic Filing.
5. Select the Setup tab.
 - a. In the “From email list” section, highlight yourself.
 - You should only need to do this the first time you create and electronically file.
 - b. In the Transmission Type select E-Signature – TPA Signs and Transmits.
6. Select the Status tab, then click on the Create New Filing button
7. Click on the Add button to add the 5500 SF – E-Signature Alternative.
 - This attachment is the signed Form 5500/SF.
 - We do not have to upload a copy of the signed E-Signature Authorization form.
8. Select the Process tab then click on the Process button.
 - This will run the plan through edit checks and generate a Datair report regarding the status of the file creation.
 - If errors are detected, you will be given the option to stop and fix or proceed with the errors.
 - **Stop and fix the errors if possible.**
9. Select the Signers tab and TPA Signature tab, under TPA Signer complete as follows:
 - Signer ID: A1346727
 - PIN: 4918
 - Name: Matthew Slyter.
 - Under Manual Signers complete the name of signer and date the form was signed.
10. Select the Publish/Transmit tab and click on the Transmit button.
11. After transmission is complete, click on Get EFAST Status button.
 - My5500 Status should read “Filed-Accepted”
 - EFAST Status should read “FILING_RECEIVED”
 - **If anything different appears, seek help.**
12. Send the Form 5500 or Form 5500-SF Confirmation of Filing email (found on the TSCnet Forms page).
