### **Independent Auditor's Report**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Nationwide Children's Hospital Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in the notes to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

## Plan Description

The following description of the Nationwide Children's Hospital (Children's) Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions. Copies may be obtained from Children's Human Resources Department.

### General

The Plan, which became effective January 1, 1997, is a non-contributory, defined contribution plan available to substantially all employees of Children's who work at least 1,000 hours during the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

The Plan provides for Children's to contribute an amount up to 50% of the participant's contribution up to the first 3% of the participant's compensation. Participant contributions are maintained in a separate plan.

The Plan also provides for Children's to make a Basic Pension Contribution to all "pension eligible" employees. The amount of the contribution is determined based on the annual compensation and length of service of each employee as outlined in the Summary Plan Description.

Participants may not contribute to this Plan except for rollover or transfer contributions from other qualified defined benefit or defined contribution plans.

Contributions are subject to certain limitations.

### Participant Accounts

Each participant's account is credited with the participant's rollover contribution and Children's contributions as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Vesting in Children's contribution portion of participant accounts, plus actual earnings thereon, is based on continuous years of service according to the following vesting schedule as it relates to both the matching and basic contributions:

One year of service represents a minimum of 1,000 hours of service.

Participants become fully vested in their account balances upon (i) attainment of normal retirement age, if an employee at such time; (ii) death or (iii) termination of employment upon becoming disabled.

### Investment Options

Upon enrollment in the Plan and through April 2024, participants had the ability to direct all contributions in any of the various investment options that the Plan offered through Teachers Insurance and Annuity Association of American and College Retirement Equities Fund (TIAA and CREF).

In April 2024, the Plan's primary custodial and recordkeeping function switched from TIAA and CREF to Nationwide Trust Company, FSB for custodial services and Nationwide Retirement Plans Business Operations for recordkeeping services (collectively, Nationwide). Accordingly, subsequent to this date, a participant may direct contributions in any of the various mutual fund investment options that the Plan offers through Nationwide.

All account balances held with TIAA and CREF, with the exception of the TIAA and CREF proprietary assets, were transitioned to Nationwide. Certain assets will remain with TIAA and CREF indefinitely, unless the participant contacts Nationwide to initiate a transfer. The TIAA Traditional Retirement Choice 84 contracts will transfer to Nationwide in 60-monthly installment payments starting in April 2024.

Participants may change their investment options at any time.

### Payment of Benefits

Upon normal retirement (age 65) or termination of service, married participants receive their vested benefit in the form of a joint and 50% survivor annuity, and unmarried participants receive single life annuities. Participants may waive this annuity in writing and, subject to spousal consent, elect to receive a lump-sum, another annuity or certain term installments.

### Forfeited Accounts

Upon termination of employment, a participant's non-vested portion of Children's contributions and related earnings are forfeited. Forfeited contributions are used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$186,152 and \$280,895, respectively. During 2024 and 2023, approximately \$3,300,000 and \$2,591,000, respectively, were used to reduce current year employer contributions. Additionally, during 2024, forfeitures of \$1,000,000 were used to reduce the employer contribution receivable due to the Plan as of December 31, 2023.

### SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional elements to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. However, there were no material impact to the Plan's 2024 or 2023 financial statements.

## Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Contributions

Contributions from Children's are recorded in the year in which the underlying employee contributions are withheld from compensation.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Costs

Costs of plan administration are paid by Children's with the exception of certain plan servicing and withdrawal fees. Additionally, fees associated with investment management services are included as a reduction of the return earned on applicable funds.

## Fair Value Measurements

GAAP established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets and liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active, or inputs other than quoted prices that are observable for the asset or liability.
- Level 3 Inputs are significant unobservable inputs for the asset or liability.

The level of the fair value hierarchy within which a fair value measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Contracts:

Valued at the NAV provided by the administrator of the fund. Issues and redemptions of units are recorded upon receipt of unit holder's instructions based on the determined NAV per unit, which is determined daily. The NAV is used as a practical expedient to estimate fair value. The NAV is based primarily on market quotations or prices obtained from independent pricing sources who may employ various pricing methods including matrix pricing. For this fund, there are no unfunded commitments and participants can transact daily. The only redemption restriction is that participants are not permitted to make electronic transfers back into the same account through a purchase or exchange for 90 calendar days, if a purchase, sale or repurchase within that account is made within a sixty-day period.

Pooled Separate  
Account:

Valued at the NAV provided by the administrator of the fund. Issues and redemptions of units are recorded upon receipt of the unit holder's instructions based on the determined NAV per unit, which is determined daily. The NAV is used as a practical expedient to estimate fair value. The NAV is based principally on the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals. Any securities held in the account are valued using independent pricing sources. For this fund, there are no unfunded commitments and participants can transact daily; however, participant transfers out of this account are limited to one per calendar quarter per participant.

Annuity Contracts:

Valued at contract value, which approximates fair value, and equals the accumulated cash contributions, interest credited and transfers, if any, less any withdrawals and transfers, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Annuity Contracts with Insurance Company

The Plan has entered into a fixed rate annuity contract (TIAA Traditional Annuity) and a fixed rate group annuity contract (Stable Value Fund), both issued by TIAA and CREF. Both contracts provide a guarantee of principal and a guaranteed minimum rate of interest between 1% and 3% with the potential for additional interest, if declared by TIAA. The TIAA Traditional Annuity contract contains liquidity restrictions on the redemption of the accumulations, which could impact the value realized upon exiting the contract. Contracts contain liquidity restrictions on the redemption of the fixed rate annuity contract. The Stable Value Fund contains a restriction that direct transfers to competing funds in a plan's investment lineup are prohibited and transfers may be made to a competing fund following a 90-day waiting period after being transferred to a noncompeting fund. Additionally, transfers into the Stable Value Fund may not be made for 30 days following a transfer out. Plan sponsors choosing to terminate a plan's investment in the Stable Value Contract will receive contract value in, at most, two years.

## Plan Termination

Although it has not expressed any intent to do so, Children's has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. In the event of any termination of the Plan, participants will become 100% vested in their accounts.

## Party-in-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain plan investments are shares of a pooled separate account, variable annuity contracts, insurance company general accounts and registered investment companies managed by TIAA and CREF. TIAA and CREF is a custodian and recordkeeper of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Nationwide is also a recordkeeper and custodian of the Plan. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan also paid direct fees, net of plan servicing credits, of \$501,987 and \$179,407 in 2024 and 2023, respectively, for plan servicing and withdrawal fees to TIAA and CREF and Nationwide.

## Tax Status

On September 8, 2017, the Plan received a determination letter from the Internal Revenue Service (IRS) which covers the amended and restated plan document with an effective date of January 1, 2016. The determination letter stated that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is tax exempt. Subsequent to the issuance of the determination letter, the Plan was amended; however, the plan administrator believes the Plan, as amended, is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for benefits.

## **Plan Amendments**

Amendment ten was executed and approved on December 4, 2023 and contains provisions with varying effective dates. The purpose of this amendment was to amend the Plan in relation to the participation of new employee groups, including Grove City Pediatric and MH Sellers Athletic Training Department, to revise the default beneficiary designation provision, to revise the forfeiture usage provision and to revise the method of payment provisions of the Plan.
