Management, having determined it is permissible in the circumstances, has elected to have the audits of SVS Vision, Inc. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1. Description of the Plan

The following description of the SVS Vision, Inc. Union Employees' 401(k) Profit Sharing Plan and Trust (the "Plan") provides summary information for general purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- A. General – The Plan, a defined contribution plan, was established on November 1, 1989. On January 1, 2009, the Plan was restated and adopted a Prototype Non-Standardized Profit Sharing Plan with Cash or Deferred Arrangement ("CODA") document sponsored by Voya Financial ("Voya"). The Internal Revenue Service ("IRS") had determined and informed Voya by a letter dated March 31, 2008, that the Plan is acceptable under section 401 of the Internal Revenue Code ("IRC" or the "Code"). The Plan was amended on January 1, 2021. The IRS had determined and informed John Hancock Retirement Services in a letter dated March 31, 2014, that the Plan is acceptable under section 401 of the IRC. The Plan covers all employees covered under the Teamsters 243 bargaining agreement who completed 90 days of service, are age twenty-one or older, and who are employees of SVS Vision, Inc. (the "Plan's Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

During the current year there were plan to plan transfer between SVS Vision Inc. Union Employees' 401(k) Profit Sharing Plan & Trust and SVS Vision Inc. Non-Union Employees' 401(k) Profit Sharing Plan & Trust.

- B. Administration – The Plan is administered by SVS Vision, Inc.'s (the "Company") employees who have been appointed by the Board of Directors of the Company. Certain administrative expenses incurred by the Plan have been paid for by the Company.

Administrative expenses incurred in the operation of the Plan, including recordkeeping, trustee services, legal, and other administrative fees, are paid by the Plan Sponsor. However, certain expenses directly related to individual participant accounts, such as loan processing fees or fees for self-directed brokerage options, are charged directly to the participant's account balance. For the years ended December 31, 2024 and 2023, administrative expenses paid by the Plan Sponsor totaled \$16,859 and \$21,004, respectively.

- C. Contributions – In 2024, eligible employees may make elective pre-tax contributions to the Plan of up to 100% of their compensation, as defined in the Plan, not to exceed \$23,000. In addition, employees who have attained the age of 50 can make an additional "Catch up" contributions up to \$7,500. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers numerous mutual funds and a general account through the Plan's investment contract with an insurance company as investment options for Plan participants.

The Company is required to match participant contributions at a rate of \$0.75 per dollar of each participant's deferred election up to 3.0% of their compensation. The matching contribution is invested according to the participant's deferred election. The match is contingent upon the participant being actively employed by the Company on December 31 of the Plan year in which the deferral occurred. Additional discretionary profit sharing amounts may be contributed by the Company and are allocated to each participant based on the percentage of their compensation to the total compensation for all participants.

Participant contributions and the Company's matching contributions are directed by participants into investment funds made available through a contract with John Hancock Retirement Plan Services (the "Custodian").

- D. Participant Accounts – Each participant account is credited with the participant and employer contributions based on the allocation stated above. Investment earnings and losses are allocated based on the ratio of a participant's account balance to the total of all participants' account balances. John Hancock Retirement Plan Services administration expenses are charged as a percent of account assets. Other administrative expenses, as applicable, are charged based on the number of participant accounts, and are divided equally among each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of the Plan (continued)

E. Vesting – Participants are immediately 100% vested in their voluntary contributions and actual earnings thereon. Participants vest ratably in the Company's matching contribution. Participants are 100% vested after six years of credited services.

F. Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are collateralized by the balance of the participant's account and are supported by promissory notes, which are accounted for separately in the loan fund. Loans must be repaid within 57 months, unless the loan is to be used to acquire a principal residence and then it may exceed the period of five years, at the prevailing interest rate as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Loan transactions are treated as transfers between the applicable investment fund and loan fund. Interest earned on loan balances are treated as income to the loan fund and subsequent transfer into the employee's investment funds.

G. Payment of Benefits – The vested balance of a participant's individual account, adjusted for withdrawals, investment income, and gains or losses, may be distributed if a participant retires, makes a divorce settlement, becomes disabled, dies, or terminates employment with the Company. Balances related to terminated participants will be available to the participant upon the participant's severance from employment as defined by the Plan. The normal form of distribution is an annuity; however, a participant or beneficiary may elect to receive a lump sum or periodic cash installments (monthly, quarterly, semi-annually, or annually).

Participants may also withdraw, in whole or in part, the vested balances in their individual accounts for the following reasons if there are no alternative funds available:

- The participant is threatened with eviction from or foreclosure on his/her primary residence.
- The participant or participant's dependents incur uninsured medical expenses.
- For the purchase of the participant's primary residence.
- For payment of post-secondary school tuition for the participant or the participant's dependents.
- For payment of burial or funeral expenses for the participant's deceased parent, spouse, child or other dependent.
- For payment of expenses for the repair of damage to the participant's residence that would qualify for the casualty deduction under the IRC.

H. Forfeitures – During the years ended December 31, 2024 and 2023, \$0 were forfeited. These accounts are used to reduce employer contributions and pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

A. Basis of Presentation – The accompanying financial statements have been prepared based on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

B. Use of Estimates – The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

C. Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 8 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (continued)

- D. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- E. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.
- F. Payment of Benefits – Benefits are recorded when paid. Requests for distribution of Plan benefits by terminated participants are in various stages of processing. At December 31, 2024 and 2023, there were no outstanding requests for distribution of benefit claims payable.

Note 3. Investments

The Plan's administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The crediting interest rate on the fixed account investment fund is based on a formula agreed upon with the issuer, but may not be less than 3.0%. The crediting interest rate is reviewed on a quarterly basis for resetting. The average yield and crediting interest rate on the general account was 3.0% for the period ended December 31, 2024.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with John Hancock Retirement Plan Services. The Plan administrator does not believe that the occurrence of such event, which would limit the Plan's ability to transact at contract value with Plan, is probable.

The Plan's independent auditors did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4. Termination of the Plan

Although it has not expressed any intent to do so, the Plan's sponsor has the right to terminate the Plan at any time subject to the provisions of the ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

Note 5. Tax Status

The IRS has determined and informed the Plan by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan's Management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The Plan's administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7. Reconciliation of Financial Statements to Form 5500

Note 8. Fair Value Measurements

As of January 1, 2008, the Plan adopted Accounting Standards Codification ("ASC") Topic 820 Fair Value Measurements and Disclosures ("ASC Topic 820"). ASC Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described below:

- Level 1 includes observable inputs which reflect quoted prices for identical assets or liabilities in active markets at the measurement date.
- Level 2 includes observable inputs for assets or liabilities other than quoted prices included in Level 1 and it includes valuation techniques which use prices for similar assets and liabilities.
- Level 3 includes unobservable inputs which reflect the reporting entity's estimates of the assumptions that market participants would use in pricing the asset or liability, including assumptions about risk.

Note 8. Fair Value Measurements (continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024.

- *Mutual funds:* Fair Value

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 9. Stable Value Funds

The John Hancock Stable Value Fund (the "Fund") is a Common/Collective trust fund. The Fund may invest in fixed interest insurance investment contracts, money market funds, corporate and government bonds, mortgage-backed securities, bond funds and other fixed income securities. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment in the Fund at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses.

Note 10. Subsequent Events

The Company has evaluated subsequent events through October 3, 2025, the date on which the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.
