Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Diemolding Corporation Employees' 401(k) Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the **Auditor's Responsibilities for the Audits of the Financial Statements** section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

Note 1 - Description of plan

The following description of the Diemolding Corporation Employees' 401(k) Benefit Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution profit sharing plan under Section 401(a) of the Internal Revenue Code with a Section 401(k) salary deferral arrangement, which has been adopted by the Plan Sponsor, Diemolding Corporation (the "Company"). The Plan covers all union and full-time employees of the Company who are twenty-one years of age and have completed four months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan provisions - The Plan has implemented certain provisions of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act), a law which allows immediate changes to the Plan to, among others, allow certain eligible individuals to receive Coronavirus related relief through temporary suspension of loan repayments, temporary tax relief for Coronavirus related distributions up to \$100,000 and suspends required minimum distributions. The Plan implemented the required provisions and other optional provisions of Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (the SECURE 2.0 Act) and the Setting Every Community Up for Retirement Enhancement Act 2.0 of 2019 (the SECURE Act). Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service guidance.

Contributions - Participants are allowed to make pre-tax or Roth elective 401(k) salary deferrals up to the maximum amount allowed by the Internal Revenue Code. Participants who meet certain age requirements are allowed to make catch-up contributions. Rollover contributions from other qualified plans are permitted.

The Company makes a 3% Safe Harbor non-elective contribution for all eligible employees not covered by a collective bargaining agreement (non-union participant). Safe Harbor contributions amounted to \$65,984 and \$66,107 for the years ended December 31, 2024 and 2023, respectively. The Company may make additional discretionary contributions as determined by the Board of Directors. There were no discretionary contributions for the years ended December 31, 2024 and 2023.

Employees covered by a collective bargaining agreement (union participants) receive a non-elective employer contribution of 2% of compensation per pay period. In addition, each union participant is eligible to receive an employer matching contribution of 100% of the first 2% of the compensation contributed by such employee. Non-elective employer contributions amounted to \$53,825 and \$54,343 and employer matching contributions amounted to \$34,704 and \$38,578 for the years ended December 31, 2024 and 2023, respectively.

Investment options - Upon enrollment in the Plan, a participant may direct contributions to the Plan in various investment options. Participants may change their investment options daily online through Merrill Lynch's website.

Participant accounts - Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, and plan earnings and administrative expenses. Allocations of the Company's contributions, plan earnings and administrative expenses are based on participants' earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants can access their account information online through Merrill Lynch's website, where they can request benefit payments and loan disbursements.

Vesting - Participants are immediately vested in their elective salary deferral and rollover contributions, the Company's 3% Safe Harbor contributions for non-union participants, the 2% non-elective employer contributions and the 2% employer matching contributions for union participants. Vesting in the remainder of their account is based on years of continuous service. A participant vests at 20% each year and is 100% vested in any employer additional discretionary contributions after five years of credited service.

Forfeitures - Forfeitures of terminated participants' non-vested account balances may be used to (a) offset the administrative expenses of the Plan; (b) reduce employer contributions; and (c) provide additional allocations to participants in accordance with the applicable employer contribution formula. Unused forfeitures were \$11,256 and \$10,779 as of December 31, 2024 and 2023, respectively.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate equal to the prime lending rate determined at the time of note approval plus 1%. Interest rates on outstanding notes receivable from participants range from 4.25% to 9.50%. Principal and interest are paid ratably through weekly payroll deductions. According to requirements of the notes receivable from participants program, the plan administrator will treat a note in default if any scheduled payment remains unpaid beyond ninety days. Any notes that are in default, as defined by the plan document, are reported as either deemed distributions or benefit payments.

Deemed distributions - Deemed distributions represent the amount of unpaid principal on notes receivable from participants who are actively participating in the Plan and have not continued to make payments on the outstanding notes as required by the plan document. There were no deemed distributions for the years ended December 31, 2024 and 2023.

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either (a) a straight life annuity payable monthly; (b) a joint and survivor annuity; (c) a lump-sum payment; or (d) a series of annual, quarterly or monthly installments over a period selected by the participant, which may not exceed fifteen years. For termination of service due to other reasons, a participant may receive the vested value of his or her account as a lump-sum distribution.

Note 2 - Summary of accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market risk. Market risks include domestic and global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Valuation of investments and income recognition - Investments are stated at fair value (see Note 4), with the exception of common collective trusts, which are valued at net asset value as a practical expedient as reported by the sponsor of the trust (see below). All investment values have been determined and certified by Bank of America, N.A., the Trustee of the Plan, (see Note 3). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Common collective trusts are made up of various investment and security-backed contracts, which are mainly publicly traded securities. Common collective trusts are valued at net asset value (NAV), which serves as a practical expedient to estimate its fair value. The NAV of common collective trusts is not publicly quoted in the active markets and is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the trust, the investment adviser reserves the right to temporarily delay

withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no redemption restrictions or unfunded commitments as of December 31, 2024 or 2023. Investments measured at NAV are not required to be classified in the fair value hierarchy.

Administrative expenses - Costs of managing the investments, including maintaining participant accounts, as well as legal and accounting costs, are paid directly by the Company. Origination and disbursement fees are paid out of the Plan's assets (see Note 7).

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Management individually reviews notes receivable balances that exceed ninety days from the date of the most recent payment and based on the assessment of credit worthiness, estimates the portion, if any, of the balance that will not be collected. Currently, there is no valuation allowance recorded; however, management will record an allowance, if and when potentially uncollectible participant notes receivable become material. If a participant defaults on a note receivable and distribution from the participant's account has been made during the plan year because the participant has left the Plan, the defaulted note receivable will be reported as benefits paid to participants on the statements of changes in net assets available for benefits and deducted from the receivable balance.

Payment of benefits - Benefits are recorded when paid.

Economic dependency and concentration of credit risk - Approximately 14%, 13% and 12%, of the Plan's investments were held and administered by PIMCO, Putnam and Lord Abbett, respectively, as of December 31, 2024. Approximately 16%, 13% and 12%, of the Plan's investments were held and administered by Lord Abbett, PIMCO and Putnam, respectively, as of December 31, 2023. Accordingly, the Plan is dependent upon the financial condition of these investment companies.

Subsequent events - Management has evaluated subsequent events through October 8, 2025, the date that the financial statements were available for issue.

Note 3 - Information certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America, N.A., the Trustee of the Plan. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to the information except to compare such

information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4 - Fair value measurements

The Financial Accounting Standards Board's authoritative guidance on fair value measurements provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that a plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies (i.e., Mutual Funds) - Valued at the closing price reported on the active market on which the individual securities are traded (Level 1).

Self-Directed Brokerage Investments - Contains common stocks and registered investment companies, which are valued at the closing price reported on the active market on which the individual securities are traded (Level 1).

The preceding methodologies described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right, under the plan agreement, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

Note 6 - Tax status

The Plan has adopted the Merrill Lynch, Pierce, Fenner, & Smith Inc. Non-Standardized Defined Contribution Pre-Approved Plan. The Internal Revenue Service has determined that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the management of the Company and plan administrator are not aware of any matters that would disqualify the Plan. Accordingly, the Plan has been accounted for as a tax-exempt plan.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and interest for the years ended December 31, 2024 or 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed tax years before 2021.

Note 7 - Party-in-interest transactions

Plan investments are managed by Bank of America, N.A., the Trustee of the Plan. Fees paid for these services qualify as party-in-interest transactions and are included in the net appreciation in investments in the accompanying statements of changes in net assets available for benefits. Furthermore, the Plan contracts with Bank of America, N.A. to provide recordkeeping and third-party administrative services, which qualify as party-in-interest transactions and are paid by the Company. Origination and disbursement fees paid to Bank of America, N.A. by the Plan were \$1,550 and \$2,169 for the years ended December 31, 2024 and 2023, respectively.

Note 8 - Reconciliation of the financial statements to Form 5500

Form 5500 has certain investments balances, income and expense items that differ from amounts shown on the accompanying financial statements. These differences relate to classification and rounding only and have no effect on the net assets available for benefits as of December 31, 2024 and 2023, nor changes in net assets available for benefits for the years then ended.
