There are no significant transactions that have been recognized in the financial statements in a different period than when the transaction occurred. There are no instances where we consider a significant accounting practice that is acceptable under the applicable financial reporting framework not to be most appropriate to the particular circumstances of the Plan.

For purposes of this communication, professional standards require us to communicate to you significant unusual transactions identified during our audit. There were no significant unusual transactions identified as a result of our audit procedures that were brought to the attention of management.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates can be particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. There are no significant estimates affecting the financial statements.

The disclosures to the financial statements are neutral, consistent, and clear. Certain financial statement disclosures can be particularly sensitive because of their significance to the users of the financial statements. The most sensitive disclosures affecting the financial statements are:

The disclosure of financial information in Note 3 to the financial statements, which discloses the financial information certified by Fidelity Management Trust Company that was not subject to audit procedures.

The disclosure of fair value measurements in Note 4 to the financial statements, which discloses the fair value hierarchy for the Plan's investments.

The disclosure of tax status of the Plan in Note 6 to the financial statements, which states that the Plan Administrator believes the Plan is being operated in accordance with the Internal Revenue Code and is therefore tax exempt.

*Circumstances That Affect The Form And Content Of The Auditors' Report*

For purposes of this letter, professional standards require that we communicate any circumstances that affect the form and content of our auditors' report. There were no circumstances that caused us to modify our auditors' report.

*Matters Resulting In Consultation Outside The Engagement Team*

There were no significant matters which resulted in consultation outside of our engagement team.

*Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

*Difficulties Encountered In Performing The Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

*Corrected And Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. There were no uncorrected misstatements identified during the audit.

In addition, professional standards require us to communicate to you all material, corrected misstatements that were brought to the attention of management as a result of our audit procedures. As part of non-attest services provided related to cash to accrual conversion, journal entries were recorded and consisted of routine closing entries necessary to roll net assets forward from the prior year financial statements. Management concurred with all adjustments. There were no corrected misstatements that resulted from audit procedures.

*Disagreements With Management*

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

*Management Representations*

We have requested certain representations from management that are included in the attached management representation letter.

*Management Consultations With Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

*Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our profession judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention.

We had identified the following reportable finding during our audit:

During our testing, we noted that a participant received a discretionary, off-cycle bonus that did not have contributions properly withheld. Management has since performed a self-review to identify other instances of similar types of compensation that did not have contributions properly withheld. Management is also working with Fidelity to correct this operational error in accordance with the IRS Employee Plans Compliance Resolution System during 2025, and document such correction, in order to maintain the Plan's compliance with ERISA, and in order to maintain the Plan's tax exempt status.

### **Other Matters**

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether its form and content, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information related to assets held and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA 103(a)(3)(C).

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of the Netsmart Technologies, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

#### **General**

The Plan is a defined contribution profit sharing plan sponsored by Netsmart Technologies, Inc. (the Company) for the benefit of eligible employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

Under the terms of the Plan, all employees age 21 or older, except interns, temporary employees and those employees who are members of a collective bargaining unit, are eligible to participate in the Plan.

#### **Contributions**

Eligible employees may contribute up to 75% of their annual compensation, as defined by the Plan Agreement, subject to certain limitations as defined by the Internal Revenue Service (IRS). Participants age 50 and older may also contribute amounts representing catch-up contributions. The Plan allows participants to make after-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution and defined benefit plans (rollover).

All employees that become eligible for the Plan are subject to automatic enrollment in the Plan at a salary deferral rate of 6% of compensation, unless an employee completes a salary deferral agreement electing a different percentage or the employee affirmatively elects not to participate in the Plan. The automatic salary deferral will be invested in the Fidelity Freedom Index target date fund that most closely matches the anticipated retirement date of the participant, unless otherwise directed by the employee. The employee may modify the automatic election at any time to elect an alternative deferral amount or to elect not to defer into the Plan.

### Notes To Financial Statements (*Continued*)

The Company makes matching contributions equal to 50% of the first 6% of participant compensation contributed to the Plan. The Company, at its discretion, may make additional contributions to the Plan, subject to certain limitations. No discretionary contributions were made in 2024 or 2023.

Upon enrollment in the Plan, a participant may direct contributions in a self-directed brokerage account or various investment options offered by the Plan. Plan participants may change their investment options at any time.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of (i) Company contributions and (ii) Plan earnings (losses), and is charged with an allocation of Plan expenses. All allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions, plus earnings thereon, is based on years of service as follows:

1 year or more	25%
2 years	50%
3 years	75%
4 years	100%

Upon attainment of normal retirement age, death or disability of the participant, all amounts are fully vested.

### **Forfeitures**

Forfeitures of a participant's Company contribution will first be applied to restore previously forfeited account balances of returning participants who are so entitled. Remaining forfeitures shall be applied to reduce future Company contributions or be used to pay Plan expenses. During the years ended December 31, 2024 and 2023, \$439,927 and \$376,945, respectively, in forfeitures were used to reduce Company contributions. Forfeited nonvested balances totaled \$186,696 and \$148,180 as of December 31, 2024 and 2023, respectively.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance the participant had during the previous 12 month period or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's accounts and bear annual interest at the prime rate in effect in the month the loan is initiated plus 1%. Rates on outstanding loans at December 31, 2024 ranged from 4.25% to 9.50% per annum. Loans used to purchase a residence may be repaid over ten years. Loans for all other purposes must be repaid within five years. Principal and interest are paid ratably through periodic payroll deductions.

#### **Payment Of Benefits**

On termination of service, participants may elect to receive their vested benefits, either as a lump-sum amount or as a direct rollover to a qualified plan or individual retirement account. In addition, if the vested benefit exceeds \$5,000, a participant may elect to defer receiving payments until age 72.

In-service distributions may be made to a participant who has not separated from service provided the participant has attained the age of 59½.

#### **Hardship Withdrawals**

The Plan provides for hardship withdrawals, as set forth in accordance with applicable sections of the Internal Revenue Code (the Code), not to exceed a participant's actual contributions to the Plan, which must result from an immediate financial need of the participant as determined on a nondiscriminatory basis by the Plan Administrator.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Use Of Estimates In The Financial Statements**

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States. Those estimates and assumptions affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could vary from those estimates.

**Contribution Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions, and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net change in fair value of investments includes the Plan's gains and losses (realized and unrealized) on investments bought and sold as well as held during the year.

**Benefits Payments**

Benefits are recorded when paid.

**Notes Receivable From Plan Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan Agreement.

#### Subsequent Events

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

### 3. Certified Financial Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Fidelity Management Trust Company (Fidelity), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Fidelity that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

#### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Registered Investment Companies And Exchange Traded Funds**

Valued at the daily closing price as reported by the funds. Registered investment companies and exchange traded funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds are deemed to be actively traded.

#### **Individually Directed Brokerage Accounts**

Included within the individually directed brokerage accounts are registered investment companies, exchange traded funds, common stocks and interest-bearing cash. Common stocks are valued at the closing price reported on the active market on which the individual security is traded.

#### **Common/Collective Trust**

Valued at the NAV of units of the individual fund. The NAV, as provided by the trustee of the invested fund, is used as a practical expedient to estimate fair value and is calculated daily by the trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments and there is no required redemption period notice. The common/collective trust held by the Plan files an annual report on Form 5500 as a direct filing entity.

## 5. Party In Interest Transactions

Certain investments are shares of funds managed by an affiliate of Fidelity, and therefore, these transactions qualify as allowable party in interest transactions.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions and are allowable under ERISA.

## **6. Tax Status**

Effective March 31, 2021 the Plan was restated and adopted a pre-approved plan document sponsored by FMR, LLC. FMR, LLC received an opinion letter from the IRS dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS.

The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date. As such, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

## **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

## **8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
