Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the 2024 financial statements of Native American Youth and Family Center 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

1. Plan Description

The following description of the Native American Youth and Family Center 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan was established July 1, 2004, and restated effective January 1, 2022. The Plan is a defined contribution plan covering employees of Native American Youth and Family Center (the Organization) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Organization's board of directors.

The custodian of the Plan is Reliance Trust Company (Reliance) and the record-keeper is Standard Insurance Company (Standard). All participant account balances are held by Reliance. The participant directs the investment of all contributions and earnings thereon and may change their investment directive at any time.

Eligibility - The Plan is a defined contribution plan covering certain full and part-time employees of the Organization, as defined by the Plan. Employees are eligible to participate in the Plan and make salary deferral contributions and receive safe-harbor employer match contributions and discretionary employer contributions after three months of credited service and attained age eighteen. Entry dates are monthly. Eligible employees do not include union employees, nonresident aliens, and residents of Puerto Rico. Effective January 1, 2023, newly hired individuals are automatically enrolled in the plan upon meeting the eligibility criteria. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Each year, participants may elect to contribute up to 100 percent of their annual compensation on a pre-tax and/or after-tax Roth basis, subject to the limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions as defined in the IRC. The Plan also allows participants to contribute amounts representing rollover distributions from other qualified plans. Individuals automatically enrolled have an initial deferral rate of 1 percent that escalates 1 percent per year up to a maximum of 6 percent.

The Organization may contribute discretionary contributions as determined annually by the Plan Administrator. No discretionary contributions were made for the year ended December 31, 2024. The Organization will contribute safe-harbor matching contributions up to 6 percent of a participant's eligible compensation, not to exceed the participant's salary deferrals.

1. Plan Description - Continued

Participant Accounts - Each participant's account is credited with the participant's contributions, as well as allocations of the Organization's discretionary matching and safe-harbor matching contributions and Plan earnings. Deducted from each participant's account are any distributions made to the participant and an allocation of administrative expenses that are paid by the Plan. Allocations of administrative expenses are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions and the Organization's safe-harbor matching contributions, plus actual earnings on those contributions. Vesting in the Organization's discretionary matching contributions, plus earnings thereon, is based on years of continuous service. The vesting percentage is as follows:

Forfeitures - Forfeitures from non-vested accounts are used to either to pay plan expenses or reduce amounts otherwise required to be contributed to the Plan. The balances in the forfeiture account as of December 31, 2024 and 2023 was \$1,165, and \$1,458, respectively. During the year ended December 31, 2024, forfeitures were used to fund employer matching contributions of \$365.

Notes Receivable from Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear a reasonable interest rate as determined by the Plan Administrator. At December 31, 2024, the interest rates on existing loans ranged 3.25 percent to 8.50 percent, with maturities through July 2029. Principal and interest installments are paid ratably through monthly payroll deductions.

Payment of Benefits - Upon attaining normal retirement age of 59.5, termination of service, death, or disability, a participant may elect to receive a lump-sum distribution of the entire vested account balance. Terminated participants whose account balance is \$5,000 or less will automatically receive a lump-sum distribution. Hardship distributions are available only for the purpose of meeting immediate and heavy financial needs.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates - The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect reported amounts of net assets at the date of the financial statements, and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period, as well as disclosure of any contingent assets or liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. Additional information about fair value measurements can be found in *Note 4*.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investment in a fully benefit-responsive guaranteed investment contract is reported at contract value (*Note 5*). Contract value is the relevant measure for the fully benefit-responsive guaranteed investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value approximates fair value for the guaranteed investment contract.

Benefits Paid to Participants - Benefits are recorded when paid. At December 31, 2024, there were no benefits processed and approved for payment, but not paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in total investment income.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024.

3. Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including cash and investments held at December 31, 2024 and total investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance, whom management has determined to be a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used during the year ended December 31, 2024.

4. Fair Value Measurements - Continued

Following is a description of the valuation methodology used for assets measured at fair value on a recurring basis:

Shares of registered investment companies: The fair value of investments in mutual funds from registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges as determined by the custodian.

The preceding method may produce a fair value calculation that may be indicative of net realized value or reflective of future values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Guaranteed Income Investment Contract (Unaudited)

The Plan has a guaranteed investment contract account, the Standard Stable Asset Fund A (Stable Asset Fund). The Standard maintains contributions to this account in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Stable Asset Fund is carried at cost plus accrued interest.

The Standard has informed the Plan Administrator that they believe the Stable Asset Fund is comparable to a cash equivalent, as investments held in the contract are completely liquid, the value provided to the Plan is the redeemable value of the fund, and there are no deferred sales charges, load assessments, or interest rate adjustments that would affect the value as a result of the withdrawal request. The value of the Stable Asset Fund at December 31, 2024 and 2023 was \$25,220 and \$21,163, respectively. The Plan Administrator believes this investment is not subject to the fair value measurement requirements.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with The Standard. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; (4) a material amendment to the agreement without the consent of the issuer.

6. Transactions with Parties-In-Interest

The Organization is the Plan sponsor and administrator and pays certain administrative costs, including accounting, legal, and consulting fees, on behalf of the Plan.

Reliance, who serves as custodian of the Plan, manages certain Plan investments. These investments and investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

Participants in the Plan are permitted to borrow funds from their vested balances. These transactions qualify as party-in-interest transactions. Notes receivable from participants and the related interest earned are described in *Note 2*.

7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. Income Tax Status

The Plan is utilizing a non-standardized pre-approved plan with an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The letter states the Plan is designed in accordance with the applicable requirements of the IRC. Although the pre-approved plan document has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

10. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available for issue.

In May 2025, the Plan was amended to reduce the barriers of entering the Plan with a change in entry date.
