We have performed audits of the accompanying financial statements of SPI Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Note 1 – Description of Plan

The following description of the SPI Group (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution Plan covering all employees, except for union employees and non-resident aliens, of the Company who have one year of service and have also obtained the age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year participants may contribute up to 90% of pretax annual compensation, as defined in the Plan, subject to a dollar limit which is set by law. Participants may also elect to make Roth 401(k) contributions to the Plan. The Company may match participants' contributions based on a percentage it deems advisable. Additional amounts may be contributed at the option of the Company's board of directors. All contributions are invested in various money market and mutual funds as directed by each participant. Contributions are subject to certain limitations.

Participants' Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after 6 years of credited service.

Investment Options: Upon enrollment in the Plan, a participant may direct employee and employer contributions in numerous investment options. The John Hancock Life Insurance Company sponsors and manages a wide array of fixed income and equity options.

Participants may change their investment options at their discretion.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts: At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$3,249 and \$19,502, respectively. Forfeited accounts may be used to pay administrative expenses and to reduce employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of funds are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Use of Estimates in the Preparation of Financial Statements: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Administration Costs: All expenses of administration may be paid out of the Plan unless paid by the Company. The Company may reimburse the Plan for any administrative expense incurred.

Note 8 – Tax Status

The Plan uses a prototype Plan document sponsored by Nova 401(k) Associates, Inc. Nova 401(k) Associates, Inc., received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Department of the Treasury information returns are subject to examination, generally for 3 years after the final date.
