We have performed audits of the accompanying financial statements of the Christiana Care Health Services, Inc. Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Christiana Care Health Services, Inc. **1. Description of Plan**

The following brief description of the Christiana Care Health Services, Inc. Defined Contribution Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan was established on January 1, 2007, and covers substantially all employees of Christiana Care Health Services, Inc. (the “Organization”), who have one year of service (minimum of 1,000 hours) and attained age twenty-one. The Plan excludes non-resident aliens who have no earned income from sources within the United States, leased employees, and members of collective bargaining units for which Plan participation was not part of the bargaining agreement. Employees of the Organization hired prior to August 14, 2006 who have elected to continue active participation in the Christiana Care Health Services, Inc. Retirement Plan are not eligible to participate in the Plan. Employees of Christiana Care Home Health & Community Services, Inc. hired prior to August 25, 2007 who have elected to continue active participation in the Christiana Care Visiting Nurse Association Retirement Plan are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Lincoln Financial Group Trust Company, Inc. (“Lincoln”) is the trustee of the Plan.

**Contributions**

The Plan is non-contributory. Employer contributions are made quarterly and are allocated according to vesting years of service earned on December 31 prior to the year in which the allocation is contributed. The Organization may elect a discretionary nonelective contribution as a percentage of participants’ eligible compensation, as defined in the Plan document. For the year ended December 31, 2024, the Organization elected to make nonelective contributions in amounts equal to the applicable percentage of each participant’s eligible compensation based on the following schedule:

<u>Group</u>	<u>Years of Credited Service</u>	<u>Percentage of Compensation</u>
Group A	1 but less than 5 years of credited service	3.0%
Group B	5 but less than 10 years of credited service	3.5%
Group C	10 but less than 15 years of credited service	4.0%

Effective July 1, 2024, the Plan was amended to provide additional employer contributions for certain eligible physicians, as defined in the Plan, in the amount of an additional 2.0% of compensation funded in substantially equal quarterly installments.

Participants direct the investment of their employer contributions into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with allocations of the Organization’s contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the amount that can be provided from the participant’s vested account.

**Vesting**

Vesting in the Organization's contribution plus actual earnings thereon is based on years of continuous service. A participant is one hundred percent vested after three years of credited service. A participant is also one hundred percent vested upon attainment of normal retirement age, death while an employee, or death while absent from employment in qualified military service.

**Forfeitures**

When certain terminations of participants in the Plan occur, the nonvested portion of the participant's account, as defined, represents a forfeiture. Forfeitures may be used to reduce employer contributions, reinstate previously forfeited accounts, or to pay Plan expenses. Total unallocated forfeiture account balances were \$140,927 and \$85,731 as of December 31, 2024 and 2023, respectively. During 2024, the amount of forfeitures used to reduce the Organization's contributions totaled \$620,140.

**Payment of Benefits**

Upon termination, both voluntarily and involuntarily, for any reason including death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In certain instances, a terminated participant may elect to remain in the Plan. Installment payments are also permitted by the Plan.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. In addition, minimum payments must begin subject to Internal Revenue Service ("IRS") guidelines.

**Notes Receivable from Participants**

As part of a previous plan merger, participant loans from a predecessor plan were merged into the Plan. New participant loans are not allowed. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through direct repayments by the participant to Lincoln. Interest rates on these participant loans are at 4.25% and mature on various dates through 2025.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and their related activity on a contract value basis (see Note 5).

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan income and expenses during the reporting period. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The administrative committee of the Plan determines the Plan's valuation policies utilizing information provided by the trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gain and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Administrative Expenses**

All reasonable administrative expenses, including custodial and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses of maintaining the Plan that are paid directly by the Organization are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-responsive investment contract, at contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds, fully benefit-responsive investment contract, self-directed brokerage accounts, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Self-directed brokerage accounts generally are limited to certain mutual funds, interest-bearing cash, publicly traded common stock and exchange-traded funds. Common stock and exchange-traded funds are valued at the closing prices reported on the active market on which the individual securities are traded. Mutual funds are valued at the daily closing price NAV as noted above.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future returns. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fully Benefit-Responsive Investment Contract**

During 2023, the Plan entered into a traditional investment contract with Transamerica Life Insurance Company (“TLIC”). This group annuity contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. As of December 31, 2024 and 2023, the contract value amount of the fully-benefit responsive investment contract was \$24,371,621 and \$21,286,376, respectively. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings less participant withdrawals, and administrative expenses.

Under the contract, TLIC has established a separate account to which deposits under the contract are allocated. TLIC is the sole owner of the assets of the separate account. Any income, gains, losses realized or unrealized, attributable to assets allocated to the separate account will be credited to the separate account without regard to other income, gains or losses of TLIC. The contract is also backed by the general account of TLIC. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the group annuity contract. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the TLIC contract at contract value on a daily basis. Direct transfers to competing investment options are not permitted. Any transfers out of the TLIC contract must first go through a non-competing investment option and reside there for a minimum of ninety days before transfer to a competing investment option. Certain events (including but not limited to bankruptcy of the Plan sponsor, disqualification of the Plan, and mergers) might limit the ability of the Plan to transact at contract value with the contract issuer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

The Plan or TLIC can terminate the contract by providing written notice to the other party. There may be a market value adjustment upon the termination of the TLIC contract, which may result in a distribution that is less than or in excess of contract value. Upon termination of the contract, the maturity date of the contract may also be extended.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the TLIC contract value for credit risk of the contract issuer or otherwise.

## **6. Tax Status**

The IRS has determined and informed the Organization by a letter dated August 10, 2015, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan continues to be operated in compliance with the applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **7. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

## **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **9. Related-Party and Party-In-Interest Transactions**

Lincoln serves as the trustee and the Plan pays fees to Lincoln. An affiliate of Lincoln provides recordkeeping services. The Plan also has a traditional investment contract with TLIC. Transactions with these parties qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

Lincoln or its affiliates generate income to the Plan through revenue sharing agreements. More specifically, Lincoln or its affiliates may receive revenue from investments held by the Plan for services Lincoln or its affiliates provide to those investments. This revenue may be used to offset certain amounts owed to Lincoln or its affiliates for administrative services to the Plan. If the revenue received by Lincoln or its affiliates from investments exceeds the amount owed as agreed to by Lincoln and the Plan for administrative services, Lincoln or its affiliates is to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the year ended December 31, 2024, the related amounts deposited into the Plan were \$39,193 and are included in net appreciation in fair value of investments. During the year ended December 31, 2024, \$57,294 of the related amounts were used to pay administrative expenses. As of December

31, 2024 and 2023, the balance in this account totaled \$1,021 and \$10,427, respectively. The Plan or the Organization may make payments to Lincoln or its affiliates for administrative expenses not covered by revenue sharing.

**10. Plan Amendments**

During 2024, the Plan was amended to provide for enhanced employer contributions for certain eligible physicians, to clarify usage of the Plan's forfeiture account and to make other administrative changes to the Plan.

Effective January 1, 2024, the Plan was amended and restated to incorporate all prior amendments, to update the eligibility provisions of the Plan, to modify the discretionary employer contribution provisions of the Plan, and to make other administrative changes to the Plan.

**11. Subsequent Events**

Management has reviewed and evaluated all subsequent events through October 9, 2025, the date the financial statements were available to be issued, and has determined there were no other matters that require adjustment to or disclosure in the financial statements.
