## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

**NOTE 1 - Description of the Plan**

---

The following description of Lake Company of Wisconsin, 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined-contribution plan covering all full-time employees of Lake Company of Wisconsin, Inc. (the Plan Sponsor) not subject to a collective bargaining agreement who have completed one year of service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Administrative Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Each year, participants may contribute to the Plan a percentage of their annual compensation on a pretax or after tax basis, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Matching or profit sharing amounts may also be contributed at the discretion of the Plan Sponsor. There were no discretionary matching or profit sharing contributions in 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or make an alternate deferral election. Automatically enrolled participants will have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral rate will increase annually by 1% up to a maximum of 10% of eligible compensation until changed by the participant.

**Investment Options**

Participants may direct their balances among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Plan Sponsor matching contributions, and allocations of (a) the Plan Sponsor's profit sharing contribution, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. A participant is 100% vested in employer contributions upon reaching normal retirement age, or upon death or disability. Vesting in the Plan Sponsor's match contribution portion and the profit sharing portion of their accounts is based on the following table:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one note outstanding at any given point in time. Note terms range from one to five years, except for notes used for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 10.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement a participant may receive a lump sum or other form of payment equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½, even if still employed.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Distribution fees are charged directly to the participant's account and are included in administrative expenses. The Plan also pays certain investment advisory and plan administration expenses from plan assets. Certain investment-related expenses are allocated proportionately to participants based on their respective account balances and are included in net appreciation (depreciation) of fair value of investments.

**Forfeited Accounts**

Forfeiture accounts may be first used to pay administrative expenses of the Plan and then reduce future Plan Sponsor contributions in accordance with the plan document. Remaining forfeitures will be allocated to active participants. At December 31, 2024 and 2023, there were no forfeited nonvested balances. During the year ended December 31, 2024, no forfeited nonvested account balances were used to pay the Plan's administrative expense.

**NOTE 2 - Summary of Significant Accounting Policies**

---

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("USGAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of financial statements is in conformity with USGAAP and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments Valuation and income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the Plan's trustee.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest less amounts defaulted (if any). Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefits paid to participants or beneficiaries are recorded when paid.

**Subsequent Events**

Subsequent events are events or transactions that occur after year end but before financial statement are issued or available to be issued. These events and transactions either provide additional evidence about conditions that existed at year end including the estimates inherent in the process of preparing financial statements (that is, recognized subsequent events), or provide evidence about conditions that did not exist at year end but arose after that (that is, nonrecognized subsequent events.)

The Plan has evaluated subsequent events through October 10, 2025, which was the date that these financial statements were available for issuance, and determined that there were no significant nonrecognized subsequent events through that date.

**NOTE 3 - Fair Value Measurements**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets in active markets that the plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- > quoted prices for similar assets or liabilities in active markets;
- > quoted prices for identical or similar assets or liabilities in inactive markets;
- > inputs other than quoted prices that are observable for the asset or liability;
- > inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The plan sponsor is responsible for the determination of fair value and accordingly performs periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds held in pooled separate accounts:* Valued based on the quoted net asset values ("NAVs") of the underlying investments held by the pooled separate accounts. The underlying mutual funds held in pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. These funds must publish their daily NAV and transact at that price.

*Common collective trust:* The fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Underlying investments of the synthetic investment contracts are generally valued as follows: domestic and foreign fixed income securities are valued at the fair value based on market values obtained from independent pricing services, quotes by dealer who are market makers in these securities, or by a methodology approved by the investment contract's trustee. Investments in regulated investment companies, collective investment trusts and separate accounts are valued at the NAV per share/unit. The funds can be redeemed daily with no redemption restrictions. There were no unfunded commitments as of December 31, 2024 or 2023.

**NOTE 6 - Plan Termination**

---

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Plan Sponsor contributions.

---

**NOTE 7 - Tax Status**

---

The IRS has determined and informed the Company by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - Party-In-Interest Transactions**

The Standard Insurance Company is the custodian as defined by the Plan document and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the plan for administrative expenses during the plan year ended December 31, 2024, amount to \$4,032.

**NOTE 9 - Risks and Uncertainties**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of both December 31, 2024 and 2023, there were three investments which individually represented greater than 10% of investment assets held.
