Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Schlage Lock Company LLC Employee Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of Schlage Lock Company LLC Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

History

The Plan is sponsored by Schlage Lock Company LLC (the Company), a U.S. subsidiary of Allegion plc (Allegion). The Company established the Plan effective December 1, 2013.

The ninth amendment to this Plan was executed on July 15, 2024. Effective March 1, 2023, any Stanley participant who was a member of Local Union 1333 prior to March 1, 2023 shall be allocated employer nonmatching contributions equal to \$5.94 divided by the participant's hourly rate of pay on a quarterly basis. Effective September 1, 2023, any Stanley participant who is a member of Local Union 134 on or after the effective date shall be allocated employer nonmatching contributions equal to 1% of compensation per pay period.

The tenth amendment to this Plan was executed on December 6, 2024. The amendment reflected the Company's acquisition of Metal-Tite Products, Inc., DBA Krieger Specialty Products (Krieger), and Unicel Architectural, Inc. (Unicel) by granting acquired employees of Krieger and Unicel who became participants in the Plan credit for service earned with Krieger and Unicel prior to the acquisition. Further, this amendment added Krieger and Unicel as participating subsidiaries and provided for ongoing Company contributions and set forth vesting provisions as further described below.

Additionally, as part of the tenth amendment, effective September 1, 2024, the nonmatching contributions allocated to members of Local union No. 26 (formerly Local Union No. 1333) was updated to 9% of the employee's compensation.

General

The Plan is a defined contribution plan covering eligible employees of the Company, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Fidelity Management Trust Company (Fidelity) is the trustee and recordkeeper of the Plan and the Plan's assets are part of the Schlage Lock Company LLC Savings Plan Master Trust (Savings Plan Master Trust) maintained by Fidelity.

The Schlage Lock Company LLC Benefits Administration Committee (the Committee) administers the Plan and is responsible for carrying out the provisions thereof on behalf of the Company. The Schlage Lock Company LLC Benefits Design Committee approves recommended design changes to the Plan. The Schlage Lock Company LLC Benefits Investment Committee selects and approves the Plan's investment options.

General (Continued)

Participants direct investments among the approved investment options. The Plan is operated with the intent to satisfy the requirements of ERISA Section 404(c).

Eligibility

All individuals employed by the Company and all employees of Stanley Access Technologies LLC are eligible to participate upon completion of any waiting period, as defined in the Plan. The Plan excludes leased employees, nonresident aliens, temporary and seasonal employees (until completing six months of service), and employees whose terms of employment are governed by a collective bargaining agreement, except for bargaining units specifically approved by the Committee.

Contributions

For those employees who are eligible to participate in the Plan, the Plan includes an automatic enrollment provision whereby a new employee is automatically enrolled in the Plan approximately 30 days after date of hire with a 2% pre-tax contribution that is invested in a default investment fund defined by the Plan. For employees hired or rehired on or after October 1, 2024, this was increased to 3%. The current default investment is the age-appropriate target retirement date fund for that employee. The employee may elect to not participate in the Plan or to change his or her contribution percentage and investment elections at any time. Payroll deductions, consequently, begin as soon as administratively feasible. Each year, participants may contribute up to 50% (in whole percentages) of their compensation, as defined in the Plan and subject to limits under section 401(a) of the Internal Revenue Code (IRC) of 1986, as amended. Participants may use before or after-tax dollars for part or all of their elective contributions.

Participants also may rollover amounts representing distributions from other eligible retirement plans to the Plan, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to various limitations to ensure compliance with the requirements of the IRC. Participants may change their contribution amounts in accordance with the administrative procedures established by the Committee.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan's assets are held in the Savings Plan Master Trust, together with assets from other participating defined contribution plans sponsored by the Company or its affiliates and intended to qualify under IRC Section 401(a). Within the Savings Plan Master Trust, the Plan offers an interest-bearing cash option, self-directed brokerage accounts, and various commingled or mutual funds including target date retirement funds.

Contributions (Continued)

The Company contributes to the Plan via matching and nonmatching contributions. The Plan provides Company-matching contributions of 100% of participants' contributions up to 6% of eligible compensation. The Company's matching contribution is contributed in cash to be invested in the same manner as the participant contributions. The Company also provides a nonmatching core contribution equal to 2% of eligible compensation to participants employed as of June 30, 2012, who made a onetime irrevocable election to waive participation in the Ingersoll-Rand Pension Plan Number One and participants who were hired or rehired by the Company on or after July 1, 2012, and prior to December 1, 2013.

Participants employed by Ingersoll Rand on June 30, 2012, who did not elect to waive participation in the Ingersoll-Rand Company Pension Plan Number One became eligible for the nonmatching contribution beginning on January 1, 2023, provided the participant is continuously employed with the Company.

As a result of the Stanley acquisition, the Company contributes matching and nonmatching contributions to the Plan on behalf of Stanley participants. The Plan provides Company matching contributions of 100% of participants' contributions up to 6% of eligible compensation and nonmatching contributions based upon the Stanley participant's age as of the end of the Plan year as follows:

Matching and nonmatching Company contributions are made in cash and invested in the same manner as the participant contributions. In the event a participant does not have an investment election on file, Company contributions are invested in the Plan's default investment fund, which is the age-appropriate target date retirement fund for the participant.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution, (b) the Company's matching and nonmatching contributions, and (c) Plan earnings (losses), net of investment management fees. Each participant's account is charged with an allocation of applicable administrative expenses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Company's matching contribution portion of participants' accounts is also immediately vested. Company nonmatching contributions for participants are vested after three years of service or upon attainment of age 65, death, or disability while employed. Acquired Stanley participants are immediately vested in Company nonmatching contributions if the participant was credited with one hour of service on or after January 1, 2010 or upon attainment of age 55, death, or disability while employed.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by their highest outstanding loan balance during the preceding 12-month period, or 50% of their eligible account balance. Participants are permitted to have one outstanding loan at any given time. Loan terms range from six months to five years; however, a loan to acquire a principal residence may be for a term of up to 15 years. Loan terms for participants merged into the Plan remain at their original loan terms. The loans are secured by the balance in the participant's account and bear a fixed interest rate of prime plus 1.0% at the time of the loan. At December 31, 2024 and 2023, outstanding loans bore interest rates ranging from 4.00% to 10.50%. Principal and interest are paid through payroll deductions.

Benefit Payments

Upon termination of service, a participant with a vested account balance greater than \$5,000 (\$7,000 effective January 1, 2024) may leave their balance in the Plan, or has three distribution options: (1) receive a lump sum amount equal to the value of the participant's vested interest in his or her account; (2) receive installments or partial distributions in the form of various types, as defined by the Plan; or (3) roll over the balance in his or her account to another qualified plan or Individual Retirement Account (IRA). A participant with a vested account balance of \$5,000 (\$7,000 effective January 1, 2024) or less may only choose options (1) or (3). If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

If the balance of the terminated participant's account is between \$1,000 and \$5,000 (\$7,000 effective January 1, 2024), the Plan Sponsor may authorize that the benefit payment be rolled into an IRA in the participant's name. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. The Plan also allows for certain military and disability distribution options to eligible Plan participants.

Forfeited and Unallocated Plan Accounts

Company nonmatching contributions forfeited are used to reduce future Company contributions. Unallocated assets are used to pay administrative expenses. Forfeited nonvested accounts and unallocated assets at December 31, 2024 and 2023 totaled \$143,701 and \$96,136, respectively. For the year ended December 31, 2024, \$92,842 of forfeitures were used to reduce Company contributions and no unallocated assets were used to pay administrative expenses. For the year ended December 31, 2023, \$19,993 of forfeitures were used to reduce Company contributions and no unallocated assets were used to pay administrative expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Committee to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the dates of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are part of the Savings Plan Master Trust, which provides unified investment management. Fidelity invests Plan assets in various trust investment options at the direction of Plan participants and as required by the Plan. Separate participant accounts are maintained by investment option. These accounts record contributions, withdrawals, transfers, earnings, and changes in market value.

Investments in the Savings Plan Master Trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Schlage Lock Company LLC Benefits Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Notes 4 and 5 for discussion of fair value measurements of the investments.

Realized gains or losses on security transactions are recorded on the trade date. Realized gains or losses are the difference between the proceeds received and the security's unit cost. Dividend income is recorded on the ex-dividend date and interest income is recorded when earned.

Investment Valuation and Income Recognition (Continued)

Certain management fees and expenses charged to the Plan for the investment in the Savings Plan Master Trust are deducted from income earned on a daily basis and are not separately reflected. Consequently, certain management fees and operating expenses are reflected as a reduction of investment returns for such investments.

The statements of changes in net assets available for benefits include unrealized appreciation or depreciation in accordance with the policy of stating investments at fair value. Net appreciation or depreciation of investments reflects both realized gains and losses and the change in unrealized appreciation and depreciation of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Such reclassifications were not material for the years ended December 31, 2024 and 2023.

Benefit Payments

Benefit payments are recorded in the Plan's financial statements when paid. There were no approved and unpaid amounts at December 31, 2024 and 2023.

Administrative Expenses

Recordkeeping administrative expenses are paid for by the participants. Expenses of the funds related to the investment and reinvestment of assets are included in the cost of the related investments. Other expenses such as loan fees, withdrawal fees, and fees related to investments in the brokerage accounts are paid for by the participant and are included in these financial statements.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Fidelity Management Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

Fair value is defined as the exchange price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Fair value measurements are based on a framework that utilizes the inputs market participants use to determine the fair value of an asset or liability and establishes a fair value hierarchy to prioritize those inputs. The fair value hierarchy is comprised of three levels that are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The fair value hierarchy requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Observable inputs are obtained from independent sources and can be validated by a third party, whereas unobservable inputs reflect assumptions regarding what a third party would use in pricing an asset or liability based on the best information available under the circumstances. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds – The shares of registered investment companies are valued at the daily net asset value (NAV) of the funds in which the Savings Plan Master Trust participates at year-end. Such assets are classified as Level 1.

Mutual Funds – The shares of registered investment companies are valued at quoted market prices in an exchange or active market, which represents the daily NAV of shares held by the Savings Plan Master Trust at year-end and are classified as Level 1. Investments in registered investment companies generally may be redeemed daily.

Common Collective Trusts – These assets are valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. NAVs are calculated by the investment manager or sponsor of the fund. The Plan's investment in common collective trusts are classified as Level 2.

Self-Directed Brokerage Accounts – Investments in the self-directed brokerage accounts consist mainly of common stock, government and corporate bonds, certificates of deposit, and various other investment funds. These investments, with the exception of government and corporate bonds and certificates of deposit, are valued at current value based on published market quotations from individual investments composing the brokerage accounts. Such assets are classified as Level 1. Investments in government and corporate bonds and certificates of deposit are valued based on fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer and are classified as Level 2.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

See Note 5 for further disclosures of the fair value of the assets held within the Savings Plan Master Trust.

NOTE 5 INVESTMENT IN SAVINGS PLAN MASTER TRUST

The Plan's investments are in the Savings Plan Master Trust, which was established for the investment of assets of the Plan and another participating defined contribution plan sponsored by the Company. The assets of the Savings Plan Master Trust are held by Fidelity. Each participating plan has a specific, divided interest in the Savings Plan Master Trust; as investment options for participants may vary by plan. Fidelity maintains separate accounting of all contributions, benefit payments, and expenses and allocates income earned and received by the Savings Plan Master Trust on the basis of the adjusted value of each plan at each measurement date.

NOTE 6 RISKS AND UNCERTAINTIES

Through the Savings Plan Master Trust, the Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Plan, ERISA, and the IRC. In the event of Plan termination, all affected participants would become 100% vested in Company contributions.

NOTE 8 PLAN TAX STATUS

The U.S. Internal Revenue Service (IRS) has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the IRC to be exempt from U.S. federal income tax. The Plan has been amended since receiving the determination letter. However, Plan management and the Plan's counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan and the related trust is tax-exempt. As a result, no provision for income tax is required.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments held in the Savings Plan Master Trust are shares or units of money market portfolio, commingled pool, and mutual funds managed by Fidelity Management Trust Company, the Plan's trustee and recordkeeper. These transactions qualify as permitted party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation or depreciation of investments, as they are paid through revenue sharing, rather than a direct payment.

The Company is in the process of correcting the prohibited transaction by depositing the lost earnings, filing the required Form 5330 with the IRS, and paying the appropriate excise tax.
