Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AMCON Distributing Company Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Description of Plan

The following description of AMCON Distributing Company Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a qualified defined contribution profit sharing plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is intended to qualify under the applicable sections of the Internal Revenue Code (IRC) of 1986, as amended, and the applicable current IRC provisions. The Plan is sponsored by AMCON Distributing Company (the Company). The assets are maintained under an agreement between Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company or the custodian) and the Plan.

Eligibility: Employees become eligible to participate in the Plan upon completion of 90 consecutive days of employment and having also obtained 21 years of age. Employees become eligible for employer matching contributions upon completion of nine months of service as well as meeting the preceding requirements to join the Plan.

Contributions and investment options: Participating employees may contribute up to 100% of their eligible compensation on a pretax basis, not to exceed the maximum allowed by the IRC. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation into the applicable Principal Trust Target Date Fund based on current age and normal retirement date. Employer contributions consist of a matching contribution equal to 100% of participant contributions up to 2% of employee compensation and a matching contribution equal to 50% of participant contributions on the next 4% of employee compensation. The amounts contributed by the participants and the Company are deposited into one or more investment options at the participants' discretion. Participants may change their investment options daily.

Participant accounts: Each participant's account is credited with the participant's elective contributions, the employer's matching contributions and investment income (loss) and charged with withdrawals and an allocation of administrative expenses if not paid by forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination of service, a participant may elect to have his or her account balance paid in a lump sum or in various annuity options.

Vesting: Employee contributions and earnings (losses) thereon vest immediately. A participant's interest in matching contributions made by the Company and earnings (losses) thereon is subject to the following vesting percentages:

In the event that the participant dies, the participant is disabled or retirement conditions are satisfied, the participant's entire interest is fully vested.

Forfeitures: Forfeitures from nonvested accounts are used to reduce employer contributions or pay the administrative expenses of the Plan. During the years ended December 31, 2024 and 2023, forfeitures from nonvested account balances reduced employer contributions by \$116,577 and \$79,169, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$363 and \$455, respectively.

Notes receivable from participants: Participants may borrow from their vested account balance. A participant may borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Loans are secured by the balances in participants' accounts. The interest rate is determined at the time the participant applies for a loan. Loans outstanding at December 31, 2024, mature through 2029 and bear interest ranging from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions. Loans have a maximum term of five years unless the loan is for the purchase of a participant's primary residence.

Note 2. Significant Accounting Policies

Basis of accounting: The accompanying financial statements have been prepared using the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties: The Plan utilizes various investment instruments. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition: Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

Administrative expenses: Certain administrative expenses, primarily audit fees, are paid by the Company for the Plan and are not reflected in the Plan's financial statements. Other administrative expenses, primarily contract administration and record-keeping fees, are paid by the Plan's forfeitures or participants and are reflected in the Plan's financial statements.

Payment of benefits: Benefit payments to participants are recorded when paid.

Note 2. Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 or 2023. Delinquent loans are treated as distributions based upon the terms of the plan document.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

Subsequent events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 3. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts (other than the Principal U.S. Property Separate Account—Z) invest primarily in domestic and international stocks, commercial paper or single mutual funds. The Principal U.S. Property Separate Account—Z invests primarily in commercial real estate and includes mortgage loans that are backed by the associated properties. The net asset value (NAV) is used as a practical expedient to determine fair value for these accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Each pooled separate account provides for redemptions by the Plan at reported net asset values per share, with little to no advance notice requirement.

Common/collective trust funds: Common/collective trust funds invest primarily in domestic and international stocks, commercial paper or single mutual funds. The NAV is used as a practical expedient to determine fair value for these accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Mutual funds: Mutual funds are reported at fair value based on the quoted market price of each fund and are classified within Level 1 of the valuation hierarchy.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management has evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Investments measured using the NAV per share practical expedient: The following tables summarize investments for which fair value is measured using the NAV practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are pooled separate accounts and common/collective trusts managed by Principal Financial Group, a related company of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. Principal Trust Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. The Plan paid approximately \$148,000 of record-keeping and other fees paid to related parties and party-in-interest during the year ended December 31, 2024. The Company also provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
