NOTE 1 - DESCRIPTION OF PLAN

Ardent Health and Rehabilitation, Co., d/b/a SanStone Health and Rehabilitation (the “Company”) established the SanStone Management Company 401(k) Plan (the “Plan”) on January 1, 2007. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, and in accordance with applicable sections of the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, referred to as Rollover Contributions in the attached financial statements. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and a common and collective trust as investments for participants. Effective January 2021, the Company changed the discretionary match to a safe-harbor contribution, matching 100% of the first 3% of eligible compensation, and 50% of the next 2% of eligible compensation. The Company made safe harbor and/or matching contributions of \$638,525 and \$538,906 during 2024 and 2023, respectively. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, an allocation of the Company’s contributions and Plan earnings. Each participant’s account is also charged with an allocation of administrative expenses (if paid by the Plan’s trust). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their own contributions and the Company’s safe harbor match, plus actual earnings thereon. Vesting in the Company’s match contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100 percent vested in their account after six years of credited service and automatically becomes vested upon reaching normal retirement age (65 years old), or in the event of disability or death.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

Forfeitures may be used to pay administrative expenses of the Plan or to offset employer contributions. Unallocated forfeitures were \$19,308 and \$30,999 as of December 31, 2024 and 2023, respectively. During 2024 and 2023, \$24,637 and \$13,778 were used to pay administrative expenses of the Plan.

Payment of Benefits

Upon termination of service, due to termination, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account balance or annual installments from the Plan, excluding terminations. Participants may also delay distributions of their vested balance until the age of 72. Participants with a vested account balance of \$5,000 or less may not postpone their distribution until a later date. The Company may distribute the vested balance as a lump-sum to the participant without the participant's consent. There were no benefits payable to participants as of December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued and determined there are no items to disclose.

NOTE 3 - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Mutual Funds: Valued based on quoted net asset value of the shares held by the Plan at year-end and is readily determinable.

Common and Collective Trust: Valued based upon the net asset values of such fund, after adjustments, to reflect all fund investments at fair value, including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the fund. The fund provides for daily redemptions by the Plan at the reported net asset value per share, with no advance notice requirement.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

NOTE 4 - RELATED-PARTY TRANSACTIONS

Fees paid by the Plan for the investment management and recordkeeping services amounted to \$35,186 and \$29,420 for the years ended December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

NOTE 6 - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 8 - CERTIFYING ENTITY'S CERTIFICATION

The following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedules that were prepared or derived from information prepared by Alerus Financial, N.A., the certifying entity of the Plan, and furnished to the plan administrator. The Plan Administrator has obtained a certification from the certifying entity that such information is complete and accurate.

Statements of Net Assets Available for Benefits – all items and amounts, except for receivables.

Statements of Changes in Net Assets Available for Benefits – all items and amounts except for contributions, benefits paid to participants and administrative expenses.

Supplemental Schedules – all items and amounts, except for delinquent participant contributions.

NOTE 9 - DUE TO BROKER

Amounts recorded as due to broker on the Statements of Net Assets Available for Benefits represent liabilities for securities purchased through a broker, with an offset to non-interest-bearing cash.

NOTE 10 - SETTING EVERY COMMUNITY UP FOR RETIREMENT ENHANCEMENT ACT (SECURE 2.0)

In December 2022 SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective in 2025 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
