Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of We Florida Financial Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1. DESCRIPTION OF THE PLAN

The following description of We Florida Financial Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan that was established April 26, 2022 as a result of a transfer of assets from the Credit Union Retirement Association 401(k) Plan in which We Florida Financial and City Service Group, LLC, its wholly-owned Credit Union Service Organization (the Credit Union or Plan Sponsor), were a participating employer. The Plan covers substantially all employees of the Credit Union who are 18 years of age or older and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Credit Union management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Credit Union has entered into an agreement whereby Empower Trust Company, LLC (the Custodian) has been appointed the Custodian of the Plan's assets. Under the terms of the agreement, the Custodian holds and invests the funds of the Plan. The Plan also retained Empower Annuity Insurance Company of America to provide participant recordkeeping and administration services.

Eligibility

The Plan is a defined contribution plan covering substantially all employees of the Credit Union who have completed at least one month of service and are age eighteen or older.

Contributions

Each year, participants may contribute elective deferrals up to 100% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts received from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has a Safe-Harbor arrangement that requires the Credit Union to match 100% on the first 3% of compensation of a participant's elective deferrals for each payroll period, and 50% of a participant's elective deferrals between 3% and 5% of a participant's compensation. The Credit Union may make discretionary matching and profit sharing contributions at the option of the Credit Union's board of directors equal to 2% of an eligible employees' compensation regardless of whether the employee makes a discretionary contribution under the Safe-Harbor arrangement. For the year ended December 31, 2024 the Credit Union's safe-harbor matching and profit sharing contributions were \$524,744. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of any Credit Union contributions, and Plan earnings. Participant accounts are charged with benefit payments and an allocation of any administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in all contributions plus actual earnings thereon. Participants are also 100% vested in their accounts upon death or disability or attainment of normal retirement age, as defined in the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set based on market rates, as defined in the Plan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, participants with vested account balances of \$5,000 or less are subject to involuntary cash-outs, in which automatic distribution of their account balance will occur without direct consent unless they elect a rollover. Participants whose vested account balances exceed \$5,000 may elect a lump sum distribution, periodic equal installment payments, a partial withdrawal, or a rollover of their account balance to another qualified account. Additionally, they may also elect to defer the distribution of their plan balance. Participants who elect to have their benefit payments deferred continue to share in allocations of investment income and losses, but do not share in subsequent allocations of employer contributions. Special rules apply to distributions due to death, disability, and retirement. Participants should refer to the full Plan document for details.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$514 and \$372, respectively. These accounts, if any, will be used to pay administrative expenses or reduce future Credit Union contributions. Also in 2024, no Credit Union contributions or administrative expenses were reduced from forfeited nonvested accounts.

Termination of the Plan

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in all contributions and earnings.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan to make estimates and assumptions that affect the reported amounts of net assets available for benefit and disclosure of contingent net assets available for benefit as of the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies, which are in accordance with U.S. GAAP. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, as the notes are collateralized by the participant's vested account balance.

As of December 31, 2024 and 2023, the interest rates on notes receivable from participants ranged from 4.25% to 9.50%. Notes receivable from participants were \$220,102 and \$267,620 as of December 31, 2024 and 2023, respectively, and mature at various dates through May 2029.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan allows for administrative expenses to be paid by the Credit Union or the Plan. Expenses that are paid by the Credit Union are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3. UNAUDITED INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Custodian held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023, net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and investment information included in the footnotes and supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except comparing such information to the related information included in the financial statements and supplemental schedule.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,372,855. This was reported as net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

U.S. GAAP provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are described as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There has been no change in methodology used as of December 31, 2024.

Mutual funds - Mutual funds are valued at the daily closing price as reported by the fund and quoted in the active market. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price.

NOTE 5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has a fully benefit-responsive investment contract with the Custodian. The Custodian maintains the assets in a general account in the form of a guaranteed fixed account. The guaranteed fixed fund is credited with a fixed rate of interest and charged for participant withdrawals and fees.

As described in the summary of significant accounting policies, because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contracts.

Contract value, as reported to the Plan, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the Issuer. Such events include but may not be limited to the following: (1) removal of a group of participants from Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan; (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the Credit Union; (3) cessation of an employment relationship resulting from a reorganization, merger, layoff, or the sale or discontinuance of all or any part of the Plan sponsor's business; (4) removal from the Plan of one or more groups or classifications of participants; (5) partial or complete Plan termination; or (6) Plan disqualification. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. As of December 31, 2024 and 2023, the value of the fully benefit-responsive investment contract was \$2,100,237 and \$2,358,259, respectively.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments and related transactions were in investment funds managed by the Plan's Custodian and, therefore, these investments and transactions qualify as party-in-interest transactions. The Plan paid direct compensation of \$14,102 to the Plan's Custodian for services rendered. Indirect compensation (that is netted against investment income on the statement of changes in net assets available for benefits) is paid to the Custodian from total annual operating expenses charged on the balance of fund investments, depending on the particular fund. Transactions involving these investments are considered party-in-interest transactions. The notes receivable from participants are also considered to be party-in-interest transactions. All of these transactions are not considered prohibited by statutory exemptions under ERISA.

NOTE 7. TAX STATUS

The Plan obtained its latest determination letter dated June 30, 2020, in which the IRS stated that the prototype plan document of the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken by the Plan. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.
