## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Riverwood Healthcare Center 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended, December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year then ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Plan Description

The following description of the Riverwood Healthcare Center 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Aitkin Community Hospital, Inc. d/b/a Riverwood Healthcare Center (the Center) who have three months of service and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Center has overall responsibility for the operation and administration of the Plan. The Center has delegated responsibility to the Plan's Pension Committee to determine the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Center's Board of Directors.

Effective August 25, 2023, the Plan was amended, changing its name to the Riverwood Healthcare Center 401(k) Plan.

Effective January 1, 2025, then Plan was amended, changing the Plan's trustee and the employer match computation period to each payroll period.

**Contributions:** Each year, participants may contribute a percentage of annual eligible compensation, as defined in the Plan. The Plan includes an automatic enrollment provision whereby all eligible employees who are not currently contributing at least 3% of eligible compensation are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target retirement fund until changed by the participant. The withholding rate under the automatic enrollment provision of the Plan will increase 1% annually until statutory limits are met, unless affirmatively changed by the participant. The Plan allows participants to allocate contributions between pretax and after-tax (Roth 401(k)) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Plan allows participants age 50 and over to make catch-up contributions. The Center contributes 3% of participants' annual eligible compensation in the form of safe harbor contributions. In addition, the Center may make discretionary matching contributions up to 1% of a participant's annual eligible compensation that is contributed to the Plan. Participants who have attained one year of service are eligible to receive discretionary matching contributions. The Center made discretionary matching contributions of 1% during 2024. Contributions are subject to certain limitations. Participants direct the investment of Plan contributions into various investment options offered by the Plan.

**Participant accounts:** Each participant's account is credited with the participant's contributions, Center safe harbor contributions and Center matching contributions, if any, as well as an allocation of investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and investment losses. Allocations are based on account balances, earnings or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions and Center safe harbor contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service, as defined. A participant vests 25% for each year of credited service and is 100% vested after four years of credited service, upon death, disability or attainment of early retirement age, as defined, during the term of employment, or upon termination of the Plan.

#### Note 1. Plan Description (Continued)

**Notes receivable from participants:** Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note terms range up to five years, or longer if the note proceeds are used by the participant for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear a fixed rate of interest, set at 2% above the prime rate, as defined. Principal and interest are paid ratably through regular payroll deductions or remitted directly by participants.

**Payment of benefits:** Upon termination of service due to death, permanent disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or an annuity purchased with the proceeds from the participant's vested account. For termination of service due to other reasons, a participant may receive the value for the vested interest in his or her account as a lump-sum distribution.

The Plan also allows for in-service distributions, including hardship distributions, subject to certain limitations.

**Forfeitures:** Forfeited nonvested accounts totaled \$1 and \$0 at December 31, 2024 and 2023, respectively. These accounts will be used to fund future Center contributions. During 2024, the Plan used \$6,406 of forfeitures to partially fund Center contributions.

#### Note 2. Summary of Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Pension Committee determines the Plan's valuation policies utilizing information provided by the Plan's custodian and investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default in accordance with Plan provisions, the participant note balance is reduced and a benefit payment is recorded.

Notes receivable from participants are classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Benefit payments:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Center. Expenses that are paid by the Center are excluded from these financial statements. Certain other investment advisory and management fees are paid directly by the Plan and included in administrative expenses. Other investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

**Collective trust fund:** The collective trust fund is a stable value fund that is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value (NAV) of the shares of the fund held by the Plan at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust fund, the fund advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Center has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

#### Note 6. Tax Status

The Plan has adopted a non-standardized form of a preapproved plan. The preapproved plan provider, Nova 401(k) Associates, has received an opinion letter from the Internal Revenue Service as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. Although the Plan has been amended from the version that received the letter, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

#### Note 6. Tax Status (Continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Related-Party Transactions and Party-in-Interest Transactions

T. Rowe Price is the custodian of the Plan and provides asset management, administrative and record-keeping services; therefore, these transactions qualify as party-in-interest transactions. Certain expenses paid by the Plan to the custodian as well as other service providers are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

#### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
