Independent Auditor's Report

To the Participants and Administrator of
Covey Equity Holdings LLC 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of financial statements of Covey Equity Holdings LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and related notes to the financial statements.

Notes to Financial Statements December 31, 2024 and 2022

Note 1: Description of the Plan

The following description of the Covey Equity Holdings LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a voluntary defined contribution profit sharing plan covering substantially all employees, except union or non-resident aliens, of Supreme Cores Holdings LLC, Supreme Cores Alabama, Inc., Vytron LLC, Coosa Holdings LLC, Prime Technological Services LLC, and PLI Fabrication LLC (collectively, the Participating Companies), who have completed at least six months of service and are at least 21 years old. The Plan Sponsor is Covey Equity Holdings LLC (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Prior to January 1, 2022, the Plan operated under the name Prime Technological Services, LLC 401(k) Profit Sharing Plan and Trust, the Plan was amended on January 1, 2022 to change the Plan name to Covey Equity Holdings, LLC 401(k) Plan and amend the Plan Sponsor to Covey Equity Holdings LLC. The balances in the Supreme Core Holdings, LLC 401(k) Plan and Vytron LLC 401(k) Profit Sharing Plan were merged into the Plan effective January 1, 2022.

The plan was amended on March 1, 2024 to allow the employees of PLI Fabrication LLC to participate in the plan.

Contributions

Participants may make pre-tax or post-tax (Roth) contributions to the Plan through payroll deductions up to 100% of their annual compensation, subject to the statutory limit set by the Internal Revenue Code (IRC), which was \$23,000 for 2024. Participants who have attained at least age fifty are eligible to defer additional amounts (catch-up contributions). The maximum catch-up contribution in 2024 was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

During 2024, the Plan Sponsor elected to match 100% of the participant's elective deferral, up to 3% of eligible compensation, plus 50% of the participant's elective deferral, between 3-5% of eligible compensation. The Plan Sponsor's matching contributions totaled \$706,714 during 2024. The Plan Sponsor may also make discretionary profit-sharing contributions for eligible employees. The Plan requires an employee to be an active participant in the Plan on the last day of the Plan year or have attained more than 1,000 hours of service during the year to participate in the profit-sharing contribution. There were no discretionary profit-sharing contributions made during 2024. Contributions are subject to certain other Plan and statutory limitations.

Administration

The Plan Sponsor serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, among other things, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions, which may affect eligibility for benefits. The Plan Sponsor has engaged Principal Trust Company (Principal) to serve as the trustee and custodian of the Plan. As the custodian, Principal receives all contributions made under the Plan, holds Plan assets, pays benefits as directed by the Plan Administrator, and assists

in the administration of the Plan. Principal serves as the intermediary for all asset purchases and redemptions. Additionally, Principal manages certain investment options of the Plan (Notes 3 and 7).

Administrative Expenses

Administrative expenses of the Plan are primarily paid by the Plan Sponsor. These expenses include, but are not limited to, legal, accounting, and recordkeeping fees; however, investment expenses are paid by the Plan. A proportionate share of fees and expenses paid by the Plan is charged to each participant's account.

Participant Accounts

Each participant's account is credited with pretax and Roth contributions made by the participant and the participant's portion of the Plan Sponsor's matching contributions, additional discretionary contributions, and plan earnings or losses. Earnings (losses), expenses, and gains and losses on investments are allocated to the participants' accounts daily based on participant account balances, as defined in the Plan Document.

Vesting

Participants are immediately vested in their elective contributions and matching contributions plus actual earnings thereon. Participants become vested in Plan Sponsor discretionary contributions in accordance with Plan provisions based upon years of service and become fully vested after five years of service. The vesting percentages are as follows:

Participants also become 100% vested upon termination of the Plan or upon reaching normal retirement age of sixty-five or upon disability or death while still an employee of the Plan Sponsor.

Investment Options

Participants are required to make participant-directed allocations of their accounts in increments totaling 100% among various investment options, including certain options for which the custodian or its affiliates serve as investment advisors (Note 7), selected by the Plan Administrator.

Notes Receivable from Participants

Prior to January 1, 2022, the Plan allowed participants to borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. Loan balances are secured by the balance in the Participant's account and are considered collectible at the time of separation. The minimum loan is \$1,000. A limit of one loan may be outstanding at one time. Loans bear interest at an agreed-upon percentage based on prevailing market rates. Principal and interest are credited to the participant's account as the loan is repaid. Upon the amendment on January 1, 2022, the Plan no longer allows participants to borrow from their account balances. The notes receivable balance represents loans outstanding prior to the amendment.

Withdrawals

At the time of retirement, death, disability, or termination of employment, a participant or their beneficiary may receive the payment of the vested interest in their account in a lump sum distribution. Participants with a vested account balance exceeding \$5,000 at time of termination of service may receive partial withdrawals or installments, but only in respect to minimum required distributions, over a period of not more than participant's assumed life expectancy. If the account balance is \$1,000 or less, the Plan may, upon termination of service, pay the benefits owed in a lump sum. In-service withdrawals are also permitted for participants who have attained age 59½. Participants' account balances between \$1,000 and \$5,000 will be automatically rolled over to an individual retirement account. Participants are eligible to receive hardship withdrawals when certain conditions are met.

Forfeitures

Non-vested account balances of terminated employees are forfeited upon the complete distribution of the vested portion of their account. Forfeitures of terminated employees' non-vested accounts may be used to reduce Plan Sponsor contributions or pay reasonable plan expenses. Forfeitures totaled \$0 in 2024. There were no forfeitures available for future at December 31, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates in Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Payments of Benefits

Benefit payments are recorded when paid by the Plan.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowable under the IRC are recorded as a liability with corresponding reduction to employee contributions.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

Risks and Uncertainties

The Plan's invested assets ultimately consist of stocks, bonds, fixed income securities, and other investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and the statement of changes in net assets available for benefit.

Note 3: Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information to information included in the Plan's financial statements and supplemental information:

Note 4: Fair Value Measurements

The accounting standard for fair value measurement provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Common Collective Trusts (“CCTs”): The CCTs are valued at the NAV, which is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments owned by the fund, minus any liabilities, and then divided by the number of shares outstanding. The practical expedient would not be used if it is determined to be probable the fund would sell the investment for an amount different from the NAV.

Pooled separate accounts (PSAs): PSAs are privately managed through investment companies and are not publicly quoted. PSAs are valued by the Custodian at net asset value (NAV) which is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The Plan has concluded that the NAVs reported by the investment companies are used as a practical expedient to approximate the fair value of the investments and are not classified in the fair value hierarchy. This practical expedient would not be used if it is determined to be probable that the investments will sell for an amount different from the reported NAV. There are currently no redemption restrictions or unfunded commitments on these investments.

The fair values assigned to the Plan’s investments are based upon available information and do not necessarily represent amounts which might ultimately be realized. Due to the absence of readily determinable fair values and the inherent uncertainty of valuations, the estimated fair values may differ significantly from values that would have been used had a ready market for the securities existed. The Plan Sponsor believes the valuation methods are appropriate and consistent with other market participants.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Fully Benefit-Responsive Investment Contract

The Plan has entered into a traditional investment contract through a group annuity contract with the Custodian. The traditional investment contract held by the Plan is a guaranteed investment contract which meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus interest, less participant withdrawals, and administrative expenses. The Custodian maintains the contributions in a general account secured by the general assets of the Custodian. Guaranteed interest rates and maturity dates are revised semiannually by the Custodian subject to contractual limitation in the contract. Certain events such as plan termination or a plan merger initiated by the Plan Sponsor may limit the ability of the Plan to transact at contract value. The Plan Sponsor does not believe that any events that may limit the ability of the Plan to transact at contract value are probable of occurring.

Note 6: Income Tax Status

The Plan Sponsor has adopted a prototype plan sponsored by Principal. The prototype plan has received a favorable determination letter from the Internal Revenue Service (IRS) dated June 30, 2020 which stated that the prototype plan and related trust met the requirements of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the requirements of the IRC and that the Plan was qualified and tax-exempt as of December 31, 2024.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7: Party-in-Interest Transactions

Principal, its affiliates, and certain service providers perform services for, sell products to, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. In addition, the Plan incurs expenses for services provided by parties-in-interest related to investment consulting, accounting, legal and plan administration. While the Plan Sponsor pays most of the fees, an insignificant portion is paid by the Plan.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 9: Prohibited Transactions

The Plan Sponsor deducted \$32,444 during 2024 from participants' gross wages that was not remitted in a timely manner to the Plan in accordance with DOL Rules and Regulations. The Plan Sponsor intends to file Form 5330 with the IRS, pay the required excise tax and make restoration contributions to the Plan to restore earnings.

Note 10: Subsequent Events

The Plan Sponsor has evaluated for subsequent events between the date of the statement of net assets available for benefits as of December 31, 2024 and the report date, which is the date these financial statements were available for issuance. Management has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
