Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Shaw Media Employee 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Shaw Media Employee 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE 1. DESCRIPTION OF PLAN

The following description of the Shaw Media (the “Company”) Employee 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees other than leased employees, those employees whose employment is governed by the terms of a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, unless such agreement expressly provides for coverage in this Plan, and certain nonresident aliens who have no earned income from sources within the United States. Interns and temporary or seasonal employees are also excluded from the Plan. Employees who have completed one month of employment consisting of 80 hours of service and are age twenty-one or older are eligible to participate in the Plan. The Plan is subject to the provisions of ERISA. The Company’s Board of Directors is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions

Participants may elect to contribute a minimum of 1% and up to the amount allowed by Internal Revenue Service (IRS) limits, of pretax annual compensation as defined by the Plan. Participants may elect to make pretax elective deferral contributions or after tax Roth deferral contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. As of July 1, 2015 the automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contribution is invested in a designated fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover into the Plan amounts representing distributions from other qualified plans or individual retirement accounts containing only amounts received from other plans.

The Plan currently allows for discretionary profit sharing and matching contributions. For 2024 and 2023, the Company made employer matching contributions to the Plan equal to 25% of the first 6% of compensation of each participant’s eligible deferral contribution.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contribution and allocations of the employer’s matching and profit sharing contribution and earnings thereon. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their elective salary deferral contributions and rollovers plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Generally, participants vest per the respective vesting schedules shown below.

Participants are automatically vested regardless of years of service upon attaining normal retirement age (65), death, retirement due to permanent disability, or termination of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear an interest rate of 1% above the prime rate as of the date of issuance. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits

Benefits are payable in the form of a lump-sum payment in cash, partial withdrawals, or installment payments to the participant upon:

- (a) death or retirement on or after normal retirement date (age 65) or due to disability; or
- (b) resignation or dismissal prior to normal retirement date.

If the benefits are payable in the event of (a) above, the amount of the benefits would be equal to the entire balance in the participant's accounts. However, if (b) is applicable, the benefits payable would be limited to the total of the participant's own contributions and earnings thereon, and the amount of the participant's vested interest in the Company matching and discretionary contributions.

Each participant or former participant may, in writing, designate a beneficiary or beneficiaries to whom distributions of participant's vested account balance shall be made in the event of the participant's death.

Forfeited Accounts

Forfeitures of the nonvested portion of the Company's discretionary profit sharing and matching contributions are first used to reinstate previously forfeited account balances of former participants since reemployed, and then may be used to pay any administrative expenses of the Plan or fund matching contributions. For the plan years ending December 31, 2024 and 2023, administrative expenses were reduced by approximately \$8,400 and \$10,000, respectively, from forfeited nonvested accounts.

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$13,473 and \$8,600, respectively.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by investment advisers and the trustee. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Excess Contributions Payable

There were no such excess contributions payable as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid. Undistributed vested benefits for participants who had elected to withdraw from the plan but had not been paid were \$3,607 and \$0 as of December 31, 2024 and 2023, respectively.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

In December 2022 Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions become effective in 2024 and forward. The amendment for this Act is pending as of December 31, 2024.

NOTE 3. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company (the custodian of the Plan).

NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective trust fund: The fair value of participation units in the stable value collective trust is based on net asset values (NAV) of the fund, after adjustments to reflect all fund investments at fair value, including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the fund (level 2 inputs). Participants transact at contract value, therefore it is considered to approximate fair value.

The fund invests in conventional and synthetic investment contracts issued by life insurance companies, banks, and other financial institutions, with the objective of providing a consistent level of return while providing stability of investment return, preservation of capital and liquidity to pay plan benefits of its retirement plan investors. Redemption is generally permitted daily. Individual participant redemptions for benefit payments and redemptions by participants to reinvest in options that do not compete with the stable value fund are generally permitted without restriction. Were the Plan to initiate a full redemption of the stable value fund, a 12 month written notice is required.

Guaranteed investment contract: The fair value is equal to the book value plus or minus any market value adjustment.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5. GUARANTEED INVESTMENT CONTRACT WITH NATIONWIDE INSURANCE COMPANY

In 2004, the Plan entered into a guaranteed investment contract with Nationwide which is a fixed return product with annual interest rate guarantees. Deposits are guaranteed in both principal and interest by Nationwide. Amounts are held in Nationwide's general account and are credited on a net daily basis at annual effective rates. The contract is not fully benefit responsive and is therefore reported at fair value. The guaranteed interest rate was 1.93% for 2024.

NOTE 6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Nationwide. Nationwide is the asset custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan directly and indirectly to Nationwide for recordkeeping, information management, and custodial services were approximately \$36,000 for the year ended December 31, 2024. As described in note 2, the Plan paid certain expenses related to operations and investment activity to various service providers. Indirect compensation was also paid to Mesriow Financial, investment advisor, and Howard Simon and Associates, Inc., third party administrator, during 2024.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8. TAX STATUS

The Plan's document sponsor, FIS Business Systems, LLC, obtained its latest opinion letter as to the volume submitter plan document on June 30, 2020, in which the IRS stated its opinion that the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. While the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan was designed and has been operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
