Note 1 - Plan Description

The following description of GT Technologies Hourly 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on April 1, 1991. In 2013, in connection with GT Technologies, Inc.'s (the "Company" or GT Technologies) separation from GenTek, Inc., the Plan was amended to transfer sponsorship to GT Technologies and change the name from GenTek, Inc. Hourly Savings Plan to GT Technologies Hourly Savings Plan. Effective April 19, 2016, the Plan was amended to change its name from GT Technologies Hourly Savings Plan to GT Technologies Hourly 401(k) Savings Plan.

The Plan is a defined contribution plan covering certain hourly employees of GT Technologies. All employees become eligible to participate in the Plan as soon as administratively possible following their employment date except as otherwise provided in the plan document or collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Non-highly compensated employees may elect to contribute from 1 percent to 90 percent of compensation on a pretax or Roth basis. Highly compensated employees may elect to contribute up to 8 percent of compensation on a pretax or Roth basis. The Plan includes automatic enrollment into the Plan at 2 percent with annual increases of 1 percent up to a maximum of 8 percent unless the participant elects otherwise in accordance with the plan document. All employee contributions are subject to maximum tax deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching that is specific to each union group's collective bargaining agreement. The Plan provides for additional employer contributions at the discretion of the Company, as defined in the plan agreement. There were no additional employer discretionary contributions made in 2024.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 20 percent after one year of service and 20 percent each successive year thereafter until they become fully vested after five years of service. Participants who are in the employment of the plan sponsor at their normal retirement age of 60 become 100 percent vested in all contribution types.

Benefit Payments

Distributions are payable upon retirement, death, disability, hardship, termination of employment, or reaching age 59½ in the form of a lump-sum amount equal to the vested balance of a participant's account.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions, pay administrative expenses, or restore previously forfeited balances.

Note 1 - Plan Description (Continued)

Party-in-interest Transactions

Certain plan assets are in investment funds managed by John Hancock Trust Company LLC (John Hancock). John Hancock is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. The Company also pays certain administrative expenses on behalf of the Plan.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 10, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

John Hancock (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Pooled Separate Account

The pooled separate account is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's net underlying assets. There are no redemption restrictions or unfunded commitments on these investments.
