To the Plan Administrator and Participants
DFCU Financial 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the DFCU Financial 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management is responsible for the preparation and fair presentation of the 2024 financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

Note 1 – Description of the Plan

General

DFCU Financial 401(k) Plan (the Plan) was established by DFCU Financial (the Credit Union). The Plan qualifies as a tax-exempt plan under the provisions of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the DFCU Financial 401(k) Plan is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Administration

The Plan Sponsor and named Plan Administrator is DFCU Financial (the Credit Union). The Plan's Trustee is Fidelity Management Trust Company. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator has formed a committee made up of Credit Union officers and members of the human resource department. The committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees. The Plan's Investment Custodian is Fidelity Management Trust Company. The Investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. Fidelity Management Trust Company performs participant recordkeeping services.

Eligibility

The Plan covers all employees employed by the Credit Union who are age 21 and older. Enrollment for eligible employees begins immediately coinciding with the satisfaction of eligibility requirements. Substantially all employees of the Credit Union, who are age 21 or older, and have completed one year of service with 1,000 hours worked in the previous year are enrolled in non-elective, non-contributory, discretionary contribution sponsored by the Credit Union. Enrollment for eligible employees begins the first day of the month following the satisfaction of eligibility requirements

Contributions to the Plan

Each year, participants may elect to contribute up to 60% of their eligible compensation, as defined in the plan document. Participants may also elect to make Roth contributions, or after-tax contributions, up to 100% of their eligible compensation, as defined in the plan document, in addition pre-tax employee contributions. Participants are automatically enrolled to defer 6% of their pre-tax eligible compensation, unless the participant specifically declines enrollment or alters the contribution amount. The auto enrollment includes enrollment in the annual automatic increase program which increases a participant's contribution by 1% each year until they reach a contribution level of 10%. Employees may opt out of the auto increase program. Participants who have attained age 50 before the end of the plan year are eligible to make 'catch-up' contributions. Participants may also contribute amounts representing distributions from other defined benefit or defined contribution plans (rollovers).

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

The Plan also provides for employer contributions as noted below:

- Discretionary employer matching contributions, which for the year ended December 31, 2024, equaled 100% of deferrals up to a maximum of 4% of eligible employee compensation.
- Discretionary employer non-elective contributions, which for the year ended December 31, 2024, equaled 5% of eligible compensation for qualifying employees.

Participants direct the investment of both their individual contributions plus their share of employer matching contributions into the various investment options offered by the Plan. The Credit Union's contributions are allocated in the same manner as that of the participant's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and applicable employer contributions. Funds contributed by participants are invested at percentages as directed by participants in any one or more of several investment alternatives. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions. The investment fund income, gains or losses are allocated daily to the applicable participants' accounts in that fund based on the previously reported account balances, adjusted for current period contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive payment in the form of a lump-sum amount or a partial withdrawal. The distributable amount is equal to the value of the participant's vested interest in his or her account, provided the minimum withdrawal is \$5,000. Employees who elect to have their benefit payments deferred continue to share in allocations of investment income and losses but do not share in subsequent allocations of discretionary contributions. All remaining terminated participants may allow their balances to remain in the Plan for up to one year. The Plan also allows for in-service distributions due to financial hardship, as defined in the plan document.

Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount is \$1,000 and participants may only have one loan outstanding at any given time. Loan transactions are treated as participant directed investments. Loan terms range from one to five years or up to fifteen years only in the event the loan proceeds are used to purchase or construct the participant's principal residence. Loans are secured by the balance in the participant's account and bear the prime rate of interest at the time the loan is processed. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings thereon. Employer matching and discretionary non-elective contributions are subject to a three year vesting schedule based on years of service. Participants are 100% vested after the completion of three years of service or upon death. Employer matching and discretionary non-elective contributions will be vested in accordance with the following schedule:

Forfeitures

Forfeitures attributable to terminated participants' nonvested accounts are allocated to a forfeiture account and are used to either pay for certain plan expenses or reduce employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

In previous years, the Plan prepared its financial statements on a modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. GAAP. In 2024, the financial statements have been prepared on the accrual basis of accounting, in conformity with generally accepted accounting principles. The effect of this change was immaterial to the financial statements. The financial statements for 2023 have been retroactively restated to account for the change and the resulting impact to the financial statements was immaterial.

Employer contributions and income from investments are recorded when they are earned. Employee contributions are recorded when withheld from pay. Income from investments is recorded when earned. Expenses are recorded in the accounting period in which they are incurred.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation policies utilizing information provided by the Investment Custodian and investment advisers. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Fees and Expenses

Certain of the Plan's administrative expenses, including salaries, accounting, and legal, are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of loans and benefit payments are charged directly to the participant's accounts and are included in administration expenses. Direct fees for custodian and recordkeeping services are paid by the Plan and are also included in administration expenses. Investment related expenses are included in the net appreciation or depreciation in fair value of investments.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 7, 2025, which is the date the financial statements were available to be issued.

Note 3 – Unaudited Investment Information Certified by the Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Fidelity Management Trust Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
2. All investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
3. All investment related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024; and
4. Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participants for the year ended December 31, 2024.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fair Value of Investments in Entities that use NAV

Common investment trusts: Valued at the NAV of units held by the Plan at year end. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no redemption restrictions or unfunded commitments relative to the CITs.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all their employer contributions.

Note 6 – Tax Status

The Plan is utilizing a non-standardized prototype plan, which has been filed with the IRS and has received a favorable opinion dated June 30, 2020 from the IRS. The Plan Sponsor has not elected to apply for an individual IRS Determination Letter upon adoption of the Plan nor on any subsequent amendments. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, that the Plan is qualified under Section 401(a) and that the related Trust is tax-exempt as of December 31, 2024.

The Plan was most recently amended effective February 15, 2023.

The Plan permitted provisions of SECURE Act 2.0 during the years ended December 31, 2024 and 2023. Written amendments to the plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan Administrator believes that the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is currently not being examined. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2020.

Note 7 – Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company, who is the Custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. For the year ended December 31, 2024, the Plan paid fees to the Custodian in the amount of \$25,654.

Certain professional fees related to the administration of the Plan were paid by the Employer on behalf of the Plan to Gregory J. Schwartz and Co.

Certain investment related expenses are included in the net appreciation or depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Certain accounting and administrative functions are performed by officers or employees of the Credit Union. No such officer or employee received compensation from the Plan.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
