INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Thompson Tractor Co., Inc. Employees' Health Care Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Thompson Tractor Co., Inc. Employees' Health Care Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits and statements of plan's benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and statement of changes in plan's benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. DESCRIPTION OF THE PLAN

The following description of Thompson Tractor Co., Inc. Employees' Health Care Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan provides health, vision, dental and other benefits covering all eligible employees and covered dependents of Thompson Tractor Co., Inc. (the Company) who elect to participate. Participants are eligible to participate in the Plan upon the first day of employment. Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Retired employees over the age of 60 and their covered dependents are entitled to medical benefits until the retiree reaches age 65.

Benefits

The Plan provides health benefits (medical, vision, dental, behavioral and prescription drugs), life insurance, short- and long-term disability benefits, and accidental death and dismemberment benefits. Retired employees are entitled to similar benefits until they reach age 65. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the life insurance benefits (basic and voluntary), accidental death and dismemberment benefits (basic and voluntary), disability benefits and certain other health benefits. The Plan purchases annual insurance contracts for these insured benefits. These premiums are paid to the insurance company from the general assets of the VEBA trust.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for certain self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-Insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan and Company.

The Plan utilizes a pharmacy benefit manager who periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Contributions

In addition to deductibles, copayments and coinsurance, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of COBRA, voluntary life insurance, and accidental death and dismemberment insurance programs based on the current group rate premium cost. Participants and the Company contribute specified amounts to the Plan based on premiums determined by the Company's consultants for all other benefit programs. Retired employees contribute a monthly premium to the Plan in an amount determined by the Company. COBRA premiums in the amount of \$91,080 were contributed to the Plan in 2024. The Company can make additional contributions at the discretion of the Plan administrator. Any deficiency of the Plan's assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by the Company or the VEBA trust are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits. Health claims are recorded when paid.

Stop-Loss Insurance

The Company has stop-loss insurance which provides coverage on any individual participant when eligible claims exceed \$250,000 in a Plan year. Premiums for stop-loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop-loss reimbursements totaling \$279,327 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Refunds

Refunds and adjustments due from the Plan's prescription drug provider are recorded when earned. Prescription rebates and adjustments totaling \$2,183,457 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Investment Valuation and Income Recognition

The Plan's investments in money market funds are stated at fair value, which approximates cost. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis.

Subsequent Events

Management has evaluated subsequent events for the Plan through October 6, 2025, the date the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan based on claims data provided by the Plan's third-party claims processors. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. INVESTMENT INFORMATION CERTIFIED BY TRUSTEES (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at December 31, 2024 and 2023, interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by First Horizon Bank (the trustee).

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data, by correlation, or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

The method above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, consultants and the trustees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. Certain administrative expenses are paid by the Company on behalf of the Plan.

7. TAX STATUS

The VEBA trust, funding certain benefits of the Plan, received an exemption letter from the Internal Revenue Service (IRS) dated July 14, 1988, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC).

However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes resulting from unrelated business taxable income. There was no such income in 2024. In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is designed to be in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits, however, there are currently no audits for any tax periods in progress.

8. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants; to discontinue its contributions at any time; and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants.

Claims and premiums that have been processed and approved for payment at year end but not paid, and claims incurred but not reported, are not considered liabilities under GAAP and, therefore, are not presented as liabilities or claims and premiums paid in the accompanying financial statements but are recorded on Form 5500 as a liability.

10. RELATED PARTY TRANSACTIONS

Certain Plan assets were invested in shares of money market accounts managed by First Horizon Bank. In addition, the Plan has several arrangements with First Horizon Bank. These transactions are party-in-interest transactions under ERISA.

11. RISKS AND UNCERTAINTIES

The Plan invests in investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The total value of the Plan's benefit obligation is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.



